INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of the
Lansdown Resort & Spa 401(K) Plan

We have performed audits of the accompanying financial statements of Lansdown Resort & Spa 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lansdown Resort & Spa 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Lansdown Resort & Spa 401(K) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of Internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Lansdown Resort & Spa 401(K) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE 1 - PLAN DESCRIPTION

General - LANSDOWN RESORT & SPA 401(K) PLAN was established for the employees of Lansdowne Resort and Spa(Company). The Plan is a defined contribution plan covering substantially all full time employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan year begins on January 1 and ends on December 31 of the same calendar year. The Plan's initial effective date was January 1, 2021. The Plan has a 401(k) salary deferral provision with an employer match, as well as discretionary profit sharing contributions. The Plan's assets are held by Reliance Trust Company, the Plan Trustee.

Eligibility Requirements - All employees who have satisfied eligibility requirements of the Plan shall be eligible. All employees may participate in the Plan with the exception of Interns who are excluded from participation in the Plan. Employees are eligible to participate in the match or discretionary profit sharing contributions after completing two (2) months of service with the Company by the next plan entry date. The minimum age requirement for participation in the Plan is the employee's attainment of age 21.

Effective Date of Participation - An eligible Employee who has satisfied the eligibility requirements will become a Participant for all purposes of the Plan on the first day of the month coinciding with the date on which such requirements are satisfied.

Service - For the purpose of service crediting, the Elapsed Time Method shall be used for all purposes instead of year of service. An employee's statutory entitlement with respect to eligibility to participate is determined with reference to the total period of time which elapses while the employee is employed with the employer, irrespective of the actual hours of service. No service with other employers is recognized except as otherwise required by law.

Compensation - Compensation with respect to any Participant in the Plan means wages, tips and other compensation on Form W-2. Compensation shall be based on a determination period that is the Plan year. Bonuses are excluded from compensation with regard to the Plan.

Vesting/Retirement Age - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution of their accounts plus actual earnings thereon is based on the number of years of continuous service. A participant is 100% vested in all Plan contributions when contributions are made. The Plan considers retirement age to be when a participant attains the age of 65.

NOTE 1 - PLAN DESCRIPTION (continued)

Participant Accounts - Each Participant's account is credited with the Participant's contribution and allocations of the Company's contribution and Plan Earnings and charged with an allocation of administrative expenses. Allocations are based on Participant earnings, participant contributions or account balances, as defined. The benefit to which a Participant is entitled is the benefit that can be provided by the Participant's vested account.

Contributions - Employee Elective Deferrals - A salary reduction arrangement exists within the plan. Plan Participants may make an elective deferral of compensation; tax free, up to the maximum amount allowed by the Internal Revenue Service. Participants may make the same salary deferral as other compensation with respect to bonuses paid by the Employer. Participants may initially commence salary deferrals on the first day of the month coincident with or next following their entry date.

Contributions - Employer Matching Contributions and Employer Fixed (Profit Sharing) Contributions - The Employer may make a matching contribution to the Plan equal to a discretionary percentage, to be determined by the Company, of the Participants Elective Deferral. This discretionary percentage of the Participants Compensation is determined by the Employer on a uniform basis to all Participants. This percentage varies year to year. Matching contributions will be made on behalf of all participants. The Company may also make a discretionary fixed (profit sharing) contribution to the Plan to be determined by the Company, not limited to current or accumulated net profits.

Forfeitures - Forfeitures of Employer Matching Contributions and Employer Fixed (Profit Sharing) contributions are applied first to reduce expenses related to the administration of the Plan and then to reduce any Employer Contributions. The non-vested portion of a participant's account balance will be forfeited if the participant incurs a one year break in service. During the Plan year ending December 31, 2023 there were no forfeitures.

Loans - Loans are permitted in the Plan. All loans are treated as participant directed investments. Loans are permitted from all accounts within the Plan. The minimum amount of a loan from the Plan is \$500. The maximum amount of a loan is equal to the lesser of \$50,000 or fifty percent of the participant's account balance. The repayment period for loans from the Plan is up to five years. Loans from the Plan to purchase a principal residence can exceed five years. Loans are secured by the balance in the participant's account and bear a fixed interest rate equal to the prime rate in effect on the date the loan is approved. Principal and interest are paid ratably through payroll deductions. At December 31, 2023 and 2022, outstanding participant loans were \$108,537 and \$42,185, respectively.

NOTE 1 - PLAN DESCRIPTION (continued)

Investment Options - Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of available investment options through Reliance Trust Company. Participants may change their investment options at any time.

Expenses - Plan expenses are paid by the Company, except loan processing fees and investment fees, as provided by the Plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared using the accrual basis of accounting.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. If available, quoted market prices are used to value investments. The amounts for investments that have no quoted market price represent estimated fair value. Participant loans are stated at cost which approximates fair value. Purchase and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payments of Benefits - Benefits are recorded when paid. On termination of service, a participant may elect to receive an amount equal to the vested value of his/her account balance as a lump sum payment, in installment payments, or through the purchase of any annuity contract.

Date of Management's Review - Subsequent events were evaluated through October 8, 2023, which is the date the financial statements were available to be issued.

NOTE 3 - INVESTMENTS

The December 31, 2023 Statements of Net Assets Available for Benefits, the investments activities included on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2023, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the Trustee in accordance with the 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Prototype Non-Standard Profit Sharing Plan, as amended, upon which the Plan is based, obtained its determination letter on July 16, 2014, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; However, that are currently no audits for any tax periods in progress.

NOTE 6 FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The method used to measure fair value may produce an amount that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value.

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants will become 100% vested in the accounts at the date of termination.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
