Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Convoy 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits in liquidation as of May 2, 2024 and December 31, 2023 and the related statement of changes in net assets available for benefits in liquidation for the period ended May 2, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Convoy 401(k) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 2, 2024 and 2023 and for the period ended May 2, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Convoy 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Basis of Accounting

As discussed in Note A to the financial statements, the governing body of Convoy 401(k) Plan approved a plan of liquidation on October 25, 2023, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going concern basis to the liquidation basis in 2023. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A.--DESCRIPTION OF PLAN

The following description of Greypoint, Inc. DBA Convoy (Company or Sponsor) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan was a defined contribution 401(k) profit sharing plan originally effective January 1, 2017. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An eligible employee was any person employed by the Company excluding employees covered by a collective bargaining agreement, union employees, leased employees, and non-resident aliens. There was no age or service requirement, and employees were immediately eligible to enter the Plan. Effective January 1, 2022, the plan was restated as part of a Cycle 3 restatement period. Effective May 1, 2023, the Plan was amended to change the definition of eligible compensation for all contributions types.

Plan Termination: Effective October 25, 2023, the Plan was amended to freeze and terminate. No further contributions were permitted or made under the Plan with respect to Plan Compensation earned on or after the effective date. As of the Plan termination date, all participants became 100% vested in their accounts. In accordance with accounting principles generally accepted in the United States of America ("GAAP"), the Plan changed its basis of accounting used to value Plan assets and liabilities from the ongoing basis to the liquidation basis. See Note G for further details regarding the Plan termination.

Contributions: The Plan was funded by eligible participant elective deferrals which may have been up to 100% of pre-tax annual compensation. Eligible participants were automatically enrolled in the Plan with a deferral amount of 6% of their eligible compensation. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could contribute amounts representing distributions from other qualified retirement plans. Also, all participants who were eligible to make elective deferral contributions may have designated all or any portion of their deferrals as Roth elective deferral contributions. Contributions were subject to certain limitations. Contributions were not permitted after the Plan terminated on October 25, 2023.

Participant Accounts: Each participant's account is credited with the participant's contribution, an allocation of the Company's contributions, an allocation of plan earnings (losses), and charged with an allocation of certain administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as applicable, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting: Participants were immediately vested in their rollover contributions and elective deferrals plus actual earnings thereon. See also above Plan Termination.

NOTE A.--DESCRIPTION OF PLAN (Continued)

Retirement: The normal retirement date was the first day of the month on or after the date the participant turns 65. There was no early retirement.

Payment of Benefits: On termination of service due to death, disability, or retirement or other reasons, a participant may have elected to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For terminated participants they were automatically rolled over into an IRA established by the Company. Hardship distributions were allowed in accordance with the provisions of the Plan. In-Service distributions were allowed at age 59½. Qualified reservist and qualified severance distributions were also allowed. Upon termination of the Plan, the participant was entitled to a distribution of their entire vested benefit. The distributions could be made directly to the participant or may be transferred to another qualified retirement plan or IRA. If the participant does not consent to a distribution, the plan administrator transferred the entire vested benefit directly to an IRA.

Notes Receivable from Participants: Participants were allowed to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were issued by the Plan and secured by the balance in the participant's account. Loan transactions were treated as a transfer to (from) the investment fund from (to) the loan fund. A participant may have up to two loans outstanding at a time. All loans must be repaid within a period of five years. Under the terms of the Plan agreement, plan loans bear a reasonable rate of interest comparable to the current interest rate charged by financial institutions for similar loans, further defined as prime plus 1%. Principal and interest were paid through payroll deductions.

Investment Options: Participants directed their contributions and account balances in a variety of investment options which include mutual funds. The Plan Sponsor periodically reviewed the investment fund options available to participants and changed them as warranted. Participants could change their investments at any time.

Plan Expenses: Expenses of maintaining the Plan were to be paid by the Company or the Plan. Certain expenses of maintaining the Plan were paid directly by the Company and are not included in these financial statements. Fees relating to administration of notes receivable from participants and for certain withdrawals were charged directly to the participant's account and are included in administrative expenses. Investment related expenses, including 12b-1 fees and revenue sharing fees, as applicable, were deducted from each funds' earnings and included in net appreciation (depreciation) in fair value of investments.

NOTE B.--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the liquidation basis of accounting, consistent with terminated plans, as of May 2, 2024 and December 31, 2023, and for the period ended May 2, 2024, in accordance with GAAP.

Accrued expenses reported in the accompanying statement of net assets available for benefits, as of December 31, 2023, reflect management's best estimate of the costs to be incurred and paid from assets of the Plan in connection the Plan termination.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determined the Plan's valuation utilizing information provided by investment advisors and custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and expensed when they are incurred. Delinquent notes receivable from participants were recorded as benefit payments based upon the terms of the Plan document. No allowance for credit losses was recorded as of May 2, 2024 or December 31, 2023.

Payment of Benefits: Benefits were recorded when paid.

NOTE C.--CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at May 2, 2024 and December 31, 2023, and net appreciation (depreciation) in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the period ended May 2, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, the record keeper of the Plan as agent for Ascensus Trust Company, the custodian of the Plan.

NOTE D.--FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE D.--FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 2, 2024 and December 31, 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E.--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were in funds managed by the custodian, Ascensus Trust Company; therefore, these transactions qualified as party-in-interest transactions. Certain administrative functions of the Plan were performed by officers or employees of the Company. Certain employees and/or owners of the Company served as trustees of the Plan. No such officer or employee received compensation from the Plan.

NOTE F.--TAX STATUS

The Plan was amended and restated effective January 1, 2022 and adopted a non-standard pre-approved profit sharing plan with CODA, which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

The Plan has been amended since receiving the determination letter. Additionally, the Plan has not applied for a determination letter associated with the termination of the Plan (See Note G) as permitted by the IRC. However, the Plan administrator believes that the Plan is designed, and was being operated, in compliance with the applicable requirements of the IRC and, that the termination of the Plan does not affect its qualification for federal tax purposes. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of May 2, 2024 (in liquidation) and December 31, 2023 (in liquidation), there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G.--PLAN TERMINATION

As described in Note A, the Company elected to terminate the Plan effective October 25, 2023. Accordingly, the net assets of the Plan were allocated for payment of plan benefits to the participants, as prescribed by ERISA, applicable regulations thereunder, and the plan document.

As of December 31, 2023, approximately \$19,409,434 had been distributed out of the Plan related to the termination. As of May 2, 2024, all Plan assets have been distributed out of the Plan related to the termination.

NOTE H.--RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market and credit risks prior to full liquidation. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would have occurred in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
