There were no sensitive disclosures affecting the financial statements in the current year.

The financial statement disclosures are neutral, consistent, and clear.

### **B.    Form 5500 Procedures**

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audits.

### **C.    Difficulties Encountered in Performing the Audits**

We encountered no significant difficulties in performing and completing our audits.

**D. Corrected and Uncorrected Misstatements**

**Note 1 Description of Plan**

The following description of the Mercer Bucks Cardiology 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established by Mercer Bucks Cardiology, P. A. (the "Company" or "Sponsor") under the provision of Section 401(a) of the Internal Revenue Code ("IRC"), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. Effective January 1, 2014, a new prototype plan document was adopted and became effective to comply with the Pension Protection Act of 2006 and other legislative and regulatory changes. For the Plan year ended December 31, 2018, the Plan instituted safe harbor employer matching contributions. Therefore, the Plan was in compliance with the safe harbor provisions, and as such, was not subject to annual average deferral percentage (ADP) testing. All employees of the Company who have completed one year of service, as defined, are eligible to participate, provided they are at least twenty-one years of age. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended ("ERISA"). The Plan's Trustees and Administrator are responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance.

**Contributions**

Each year, participants may contribute up to 70 percent of eligible pretax annual compensation, as defined in the Plan and subject to certain limitations under the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, a money market fund and a guaranteed investment contract as investment options for participants.

The Company contributes 3 percent of eligible compensation to the Plan as a safe harbor contribution. In addition, each year the Company can elect to make a discretionary profit sharing contribution to the Plan. A participant will also receive a discretionary profit sharing contribution if the participant retired, became disabled or died during the year. For the four and one-half months ended May 16, 2023, there were no safe harbor contributions. (See Note 8)

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions, employer safe harbor contributions and the earnings thereon. Vesting in employer discretionary contributions and the earnings thereon is based on years of continuous service. A participant vests according to the following schedule:

Less than 3	0%
3 years or more	100%

**Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The maximum loan term is five years unless the loan is taken to purchase a principal residence. Loans are secured by the balance in the participant's account and bear interest at a rate of prime, plus one percent, determined as of the date of the loan distribution. Loans are repaid through payroll deductions. Loan fees are charged to the participant's account. As of May 16, 2023 and December 31, 2022 there were no outstanding loans.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or partial withdrawals. The Plan also allows for in-service distributions if a participant reaches age 59½.

**Hardship Benefits**

The Plan allows for "hardship withdrawals" of employee benefits from participant's pre-tax elective deferral and ROTH elective deferral accounts based the provisions of the Plan document.

**Forfeited Assets**

Forfeitures are used to reduce future employer contributions or to offset administrative expenses of the Plan. At May 16, 2023, \$0 of forfeited non-vested accounts were available, and \$7,209 was used during 2023 to offset the 2022 employer contributions.

**Note 2      Summary of Significant Accounting Policies**

**Basis of Presentation**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investments are reported at fair value and contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 5.

**Participants Notes Receivable**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of May 16, 2023 and December 31, 2022. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Note 2 Summary of Significant Accounting Policies (Continued)**

**Payment of Benefits**

Benefit payments to participants are recorded when paid. Payments representing refunds of excess contributions are accrued and reflected as a reduction of participant contributions in the accompanying financial statements.

**Expenses**

Expenses related to the administration of the Plan are primarily paid by the Company. Investment related expenses, other than those paid directly by the Plan, are integrated with investment performance.

**Note 3 Fair Value Measurements**

Generally accepted accounting principles ("GAAP") establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

Balances were zero as of May 16, 2023. At December 31, 2022, the Plan only held Level 1 investments, as described below:

**Level 1**

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used for assets measured at fair value at May 16, 2023 and December 31, 2022.

**Mutual Funds and Money Market Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 4 Certified Investments**

The information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the supplemental schedule(s) required by ERISA, including investments and notes receivable from participants held at May 16, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends for the four and one-half months ended May 16, 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

**Note 5 Investment Contract with Insurance Company**

In 2011, the Plan entered into a fully benefit-responsive investment contract with VOYA. VOYA maintains the contributions in a separate fixed account. The account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by VOYA. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract restricts transfers that constitute frequent trading. Frequent trading restricts more than one purchase and sale of the same underlying fund within a 30 day period.

**Note 5 Investment Contract with Insurance Company (Continued)**

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than zero percent. Such interest rates are typically reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VOYA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example; divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 6 Party-in-Interest and Related Party Transactions**

Certain Plan investments as well as a guaranteed investment contract are managed by VOYA. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to VOYA for the administrative services amounted to \$17,400 for the four and one-half months ended May 16, 2023.

**Note 7 Tax Status**

The Plan adopted a prototype plan document effective January 1, 2014. The prototype plan received its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designated, was in compliance with applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan was designed, and was operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan will be open for examination for three years.

**Note 8 Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. During the year ended December 31, 2021, the Plan Sponsor became associated with Capital Health Medical Center ("Capital Health"). As part of the association, a significant number of employees became Capital Health employees during 2021, and the remainder during 2022. Employees that became employed under Capital Health were given immediate eligibility into Capital Health's employee benefit plan.

During the year ended December 31, 2022, the Plan Sponsor discontinued its contributions and terminated the Plan subject to the provisions of ERISA as of May 16, 2023. Due to the Plan termination, all participants became fully vested, and net assets were distributed to participants and beneficiaries in proportion to their respective account balances.
