NOTE A – DESCRIPTION OF PLAN

The following description of the Wright Brothers, Inc. (“Company”) Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company and the employees of related participating employers Wright of Pennsylvania, LLC, Wright of Ohio, LLC, Wright of South Carolina, LLC, Wright of Florida, LLC, Wright of Kentucky, Wright of Maryland, LLC, Wright of Indiana, LLC, Wright of Delaware, LLC, Wright of Virginia, LLC, and Wright of North Carolina, LLC who have completed three consecutive months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan’s Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Trustees.

Contributions

Each year, participants may contribute up to an amount not to exceed limits imposed by Code sections 401(k), 402(g), 404 and 415. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. Contributions are automatically invested in a designated balanced fund until changed by the participant. The Company can choose to make a discretionary matching contribution for eligible employees. For years ending January 16, 2024 and December 31, 2023 the Company made no contributions. The Company can also choose to make a discretionary Profit-Sharing contribution for eligible employees who have completed the service requirement of seven months. No profit-sharing contributions were made in 2024 and 2023.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earning or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants

Participants are not permitted to borrow from their fund accounts.

Payments of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten-year period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

At January 16, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$33 respectively. These accounts have been used to reduce employer contributions and fees.

In 2024 and 2023 fees of \$0 and \$3,142 were paid from forfeited nonvested accounts.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and Employer contributions are recorded in the year in which the employee contributions are withheld from compensation.

Excess Contributions Payable

There were no excess contributions for years ending January 16, 2024 and December 31, 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Fees for the administration of participant accounts and benefit distributions are included in administrative expenses and charged directly to the participant's account.

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through November 13, 2024, which is the date the financial statements were available to be issued.

NOTE C – SHORT YEAR REPORTING PERIOD

The Plan's fiscal year for the period ending January 16, 2024, is a short year, covering the period from January 1, 2024 to January 16, 2024. This was due to a plan merger. The Wright Brothers, Inc. Retirement Plan was merged into the W.D. Wright Contracting, Inc. Profit Sharing / 401(k) Plan, resulting in termination of the Wright Brothers, Inc. Retirement Plan. All Plan assets transferred to the new Plan on January 16, 2024 and the Plan was terminated.

NOTE D – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate

valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 2 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at January 16, 2024 and December 31, 2023.

Level 1 Fair Value measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended January 16, 2024 and December 31, 2023, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3.

NOTE E – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Bryan Wright is a shareholder in the Company, limited trustee of the Plan, Plan administrator, and employee of the Company participates in the Plan. The only activity between the related party and the Plan is as an employee participant. Contributions to the Plan are exempt from the prohibited transaction rules of ERISA. No contributions were made in 2024 or 2023.

NOTE F – BENEFIT PAYMENTS

Benefits of \$692 and \$53,533 were paid to participants from the Plan for the years ended January 16, 2024 and December 31, 2023.

NOTE G – TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate the tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
