Dear IRS,

I am writing to provide a written response to the final notice I received regarding an overdue filing of form 5500 or 5500-SF. Please see my explanation below as well as the included signed plan termination acknowledgment that was emailed to Paychex.

Apparently, the 401K plan was opened in early 2020 when I signed up with Paychex for their payroll services. At the time, I did have one employee, Orlando Rivera, but neither he nor I ever contributed any amount of money to the plan. It looks like approximately \$100 was used to start the plan back in 2020 but no funds were ever added.

In May of 2022, I terminated the plan in part because I had moved to ADP for payroll services in 2021 and because it was a loose end that needed to be taken care of. It was my understanding that Paychex was going to handle the plan termination once they received my signed termination acknowledgment. Please see the included email which I used to send Paychex the signed plan termination acknowledgment.

Please let me know if you need any additional information or what I may need to do to resolve this matter.
