Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PrairieCare, LLC 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Plan Description

The following brief description of the PrairieCare, LLC 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Employers (Companies) participating in the Plan under common control and ownership include the following:

- PrairieCare, LLC
- St. Croix Psychiatric, LLC
- PrairieCare Shared Services, LLC
- Paragon Residential Treatment for Youth, LLC dba PrairieCare Residential Services
- Stephen R. Setterberg, M.D., LTD

The Companies were purchased by Monroe Operations, LLC on November 1, 2022.

General

The Plan is a defined contribution plan. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The administrative committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees are eligible to make salary reduction contributions and receive the Companies' contributions after attaining age 21. Eligible employees become participants on the first day of the month coinciding with or following the date on which entry requirements were fulfilled.

Contributions

Participants may contribute up to the amount allowed under the current Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants can make Roth contributions to the Plan, and participants aged 50 or older, who are making contributions to the Plan, are allowed catch-up contributions as defined in the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The Company has elected to make a matching contribution which is a 50% match of an employee's contribution up to 6% of an employee's compensation as defined. Additional discretionary amounts may be contributed at the option of the Companies' board of directors. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of the Companies' contributions and Plan earnings or losses. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Participant accounts are charged with an allocation of administrative expenses based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Plan Description

Investment Options

Participants direct the investment of contributions into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Companies' contributions plus actual earnings thereon is based on credited years of service, as defined. Participants are 100% vested in the Companies' matching and profit-sharing contributions after four years and in the event of death, disability, or satisfying the conditions for early retirement.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Generally, the repayment period cannot exceed 5 years. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.25%-10.5%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum distribution or installment payments equal to the value of the participant's vested account balance.

In-service Withdrawals

Participants can receive all or a portion of their vested account balance upon reaching age 59½. Participants can also withdraw funds from their rollover accounts at any time. Hardship withdrawals from the participant's elective deferral account are permitted only in the case of financial hardship, as determined by the Plan administrator in a uniform and nondiscretionary manner.

Forfeited Accounts

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of their Companies' contributions not then vested shall be forfeited. The forfeited portion of any participant's account will be used to reduce the Companies' contributions. At February 8, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$10,890 and \$1,498, respectively. The forfeited nonvested accounts were transferred in the plan transfers described in Note 6.

Note 2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the modified cash basis of accounting which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (US GAAP). This basis of presentation differs from US GAAP in that participant and Company contributions are recognized when received rather than when due.

Note 2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of February 8, 2024 and December 31, 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Note 3. Certification

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements was obtained by the Plan administrator and agreed to or derived from information certified as complete and accurate by Ascensus, LLC as agent for Ascensus Trust Company and Newport Trust Company, LLC, the trustees of the Plan.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and that the Plan has the ability to access.

Level 2 inputs are based on observable inputs corroborated by market data but not quoted on active markets.

Level 3 inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets or liabilities and have the lowest priority.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Registered Investment Companies Funds (Mutual Funds): Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at the NAV of units of a collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Pursuant to Financial Accounting Standards Board Accounting Standards Update 2015-07, *Fair Value Measurements*, the collective trust funds measured at NAV have not been classified in the fair value hierarchy. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Interest bearing cash: Valued at \$1.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at February 8, 2024 and December 31, 2023.

The Plan holds a collective trust fund that is not a direct filing entity. The stable value fund seeks to preserve capital and provide stability of principal while earning income that exceeds money market rates over the long term.

Note 5. Related Party and Party-in-interest Transactions

Certain Plan investments are shares of mutual funds managed by The Vanguard Group, Inc. (Vanguard). Vanguard serves as recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for investment management services are included in investment income, as they are indirect fees paid through revenue sharing, rather than a direct payment. The Plan pays certain fees related to the Plan's operations, which are included as administrative expenses. Notes receivable from participants also qualify as party-in-interest transactions.

Note 6. Plan Transfers

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Companies' contributions.

Effective January 22, 2024, the Plan merged account balances in the amount of \$28,432,313 from the Companies, other than St. Croix Psychiatric, LLC, to the Newport Healthcare 401(k) Plan. The account balances of the St. Croix Psychiatric, LLC participants were spun off into the St. Croix Psychiatric, LLC d/b/a PrairieCare Medical Group in the amount of \$12,452,841 on February 8, 2024.

Note 7. Tax Status

The Plan adopted a non-standardized pre-approved plan document sponsored by Ascensus, LLC. The non-standardized sponsor has received an opinion letter dated June 30, 2020, from the IRS as to the non-standardized plan's qualified status. The non-standardized plan opinion letter has been relied upon by this Plan. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC. The Plan has not applied for a separate determination letter.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of February 8, 2024, no uncertain positions have been taken or are expected to be taken that would require recognition of a liability (or an asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to income tax examinations for years prior to 2021.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits - modified cash basis.
