Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Connemara Converting 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO THE FINANCIAL STATEMENTS

For the Years Ended December 31, 2023 and 2022

NOTE 1 - PLAN DESCRIPTION:

The following brief description of the Connemara Converting 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a single employer defined contribution plan covering employees of Connemara Converting, LLC, Connemara Converting Kansas, LLC, and Connemara Converting West, LLC (the “Company”) that have completed six months of eligible service and have attained an age of 21, excluding certain union employees, unless an agreement requires that such union employees participate in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In November 2022, Connemara Converting West, LLC was sold to an unrelated party resulting in withdrawal of all participant balances prior to December 31, 2022. On September 30, 2023 Connemara Converting LLC was sold to Midland Paper Company. As a result of this sale, Midland Paper Company effectively owns 100% of Connemara Converting Kansas, LLC in addition to Connemara Converting LLC. On December 13, 2023, the Board of Directors of Midland Paper Holdings, Inc, a controlling party of Connemara Converting LLC, approved the merger of this Plan into the Midland Paper Holdings Inc 401(k) Savings Plan (“Savings Plan”), effective December 31, 2023. As a result, all investments were transferred from the Plan into the Savings Plan.

Contributions

Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan, subject to annual IRS limitations. Participants may also contribute amounts representing distributions from other qualified plans. The Company provides a safe harbor contribution of 100% of the elective employee contributions to the Plan not to exceed 3% of the employee compensation, plus 50% of each employee’s elective contribution that exceeds 3% of the employee’s compensation but does not exceed 5% of the employee’s compensation. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants aged 50 and over are also allowed to make “catch up” contributions. Additional profit-sharing amounts may be contributed by the Company at the option of the Company’s Board of Directors; none were contributed as of December 31, 2023 and 2022.

Participants’ Accounts

Each participant’s account is credited with the participant’s contribution, an allocation of the Company’s contribution, plan earnings, and an allocation of any administrative expenses. The Company’s contribution, exclusive of the 401(k) match, and forfeitures are allocated based upon each participant’s compensation, as defined. Plan earnings are allocated in proportion to each participant’s account balance.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service, unless separation due to death, disability, or retirement occurs, in which case participants are immediately vested.

NOTE 1 - PLAN DESCRIPTION (CONT'D):

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Interest is payable at rates available for similar loans from commercial lending institutions. Principal and interest is repaid ratably through regular payroll deductions.

Payment of Benefits

Upon termination of service, a participant may elect to receive their vested account balance as a lump sum distribution or a rollover into another qualified plan.

Forfeitures

Forfeitures of terminating participants will first be used to pay Plan expenses. Any remaining forfeitures will be used to reduce the Company's subsequent contributions to the Plan. In 2023, \$0 of employer contributions were paid from forfeited non-vested accounts. At December 31, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0 and \$109, respectively.

Secure Act 2.0 Information

In December 2022 Securing a Strong Retirement Act (Secure 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 Secure Act. Most of the provisions will become effective in 2024 and forward, therefore there is no current impact to the Plan. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting. The Plan's investments are stated at fair value.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONT'D):

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2023 and 2022, no allowance for credit losses has been recorded. If a participant does not make loan payments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's recordkeeping expenses are paid by the Plan. The Company pays all other administrative expenses in excess of amounts paid through forfeitures (see Note 1) and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS:

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its

investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value:

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market funds held by the Plan are considered to be actively traded.

Investment Measured at Net Asset Value

The investment measured at the net asset value (NAV) represents units in the Putman Stable Value Fund and Putman Stable Value Fund GM (referred to collectively as PSVF), which are stable value collective trust funds that invest in investment contracts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily and there are no unfunded commitments.

NOTE 4 - INVESTMENTS:

The December 31, 2023 and December 31, 2022 Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2023, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the trustees in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total assets of \$0 at December 31, 2023 and \$4,059,337 at December 31, 2022, and related gain of \$686,219 for the year ended December 31, 2023.

NOTE 5 - PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would have become 100% vested in their employer contributions. See Note 1 regarding merger of plan.

NOTE 6 - INCOME TAX STATUS:

The Internal Revenue Service (IRS) has determined and informed the Company by letter that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has obtained a favorable tax determination letter from the IRS dated June 30, 2020. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

The Plan conducts transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. These parties include investment advisory, custodian, recordkeeping, and accounting services. The Plan issues loans to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transactions rules of ERISA.

NOTE 8 - RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statement of net assets available for benefits.

NOTE 9 - FIDELITY BOND:

The Company failed to obtain a fidelity bond prior to July 15, 2023. The Plan administrator has since acquired a fidelity bond.

NOTE 10 - SUBSEQUENT EVENTS:

Subsequent events were evaluated through October 15, 2024, which is the date the financial statements were available to be issued.
