Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ida County, Iowa Community Hospital, Inc. dba Horn Memorial Hospital Tax Deferred Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 6, 2024 (in liquidation) and December 31, 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the period ended February 6, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of February 6, 2024 and December 31, 2023 and for the period ended February 6, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Notes 1 and 11 to the financial statements, the Board of Directors of Ida County, Iowa Community Hospital, Inc. dba Horn Memorial Hospital approved a plan of liquidation, and management determined liquidation is imminent. The Plan termination was effective December 31, 2023. As a result, the Plan presented the 2024 and 2023 financial statements using the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Note 1 - Description of Plan

The following brief description of the Ida County, Iowa Community Hospital, Inc. dba Horn Memorial Hospital Tax Deferred Annuity Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering qualified employees of Ida County, Iowa Community Hospital, Inc. dba Horn Memorial Hospital (the Employer), as defined by the Plan, who have elected to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Directors of the Employer (the Board of Directors) is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

On September 23, 2024, the Board of Directors adopted a resolution to ratify and formally amend and terminate the Plan effective December 31, 2023. Notices of intent to terminate the Plan were distributed to participants beginning November 6, 2023. As a result, management determined that liquidation was imminent as of December 31, 2023. No additional participants may enter the Plan and contributions ceased as of December 31, 2023.

Eligibility

Effective December 31, 2023, the Plan was frozen to new participants. Prior to this, employees became eligible on their first day of employment with the Employer.

Entry Date

Effective December 31, 2023, the Plan was frozen to new participants. Prior to this, entrance dates were the first day of employment.

Contributions

Effective December 31, 2023, employee contributions were no longer allowed into the Plan. Previously, participants could elect to make contributions of their pre-tax or post-tax (Roth) annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Previously, the Employer contributed 100% on up to 5% of the eligible participants' pre-tax or Roth contributions to the Plan into the Ida County, Iowa Community Hospital, Inc. dba Horn Memorial Hospital Employees' Pension Plan (a separate plan).

Participants could also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions were subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions (including rollovers) and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment to the Plan, a participant may direct deferrals and rollover contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

Vesting

Participants are vested immediately in their contributions (including rollovers), plus actual earnings thereon.

Notes Receivable from Participants

Participant's may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. The Plan administrator will establish a reasonable rate of interest which will provide a return similar to rates being charged by lending institutions in the same geographic location as the Employer. Principal and interest is paid ratably through bi-weekly payroll deductions over a period not to exceed five years, unless the proceeds of the note were used to acquire the participant's residence, in which case the note terms can range up to thirty years. A participant may have no more than one outstanding note at any one time.

Payment of Benefits

Distributions pursuant to the Plan termination were paid at the participant's election by (a) cash distribution of the value of the participant's account (b) rollover distribution to an eligible retirement plan or (c) rollover distribution to an Individual Retirement Account (IRA). For any participant who did not make an election, their accrued plan benefits were rolled over to the Horn Memorial Hospital 401(k) Plan in 2024 (See Note 11). The assets of the Plan were fully distributed as of February 6, 2024.

Plan Termination

The Board of Directors has the right under the Plan to terminate the Plan subject to the provisions of ERISA. As further discussed in Note 11, the Board of Directors elected to terminate the Plan effective December 31, 2023. The Plan made all final distribution payments in 2024.

Note 2 - Significant Accounting Policies

Basis of Accounting

Due to the decision to terminate the Plan during 2023, management determined that liquidation of the Plan is imminent and the financial statements for 2024 and 2023 have been prepared using the liquidation basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

There are no investments remaining at February 6, 2024. All investments in the 2023 statements of net assets available for benefits are reported at liquidation value. For all investments, except the fully benefit-responsive investment contracts, fair value approximates the amount the Plan expects to collect at liquidation. For the fully benefit-responsive investment contracts, contract value approximates the amount the Plan expects to collect at liquidation.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income and dividends are recorded on the liquidation basis, including amounts expected to be earned through the final distribution of Plan assets. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

The fair value of pooled separate accounts is determined by the net asset value (NAV) of the funds' underlying investments held at year end adjusted for any dividends or distribution received by American United Life Insurance Company (AUL) and the daily equivalent of any fee charged by AUL pursuant to the contract. The NAV, as provided by AUL, is used as a practical expedient to estimate fair value. There have been no changes in the methodology used at February 6, 2024 and December 31, 2023.

The classification of investment earnings (losses) reported in the statement of changes in net assets available for benefits may differ from the classification of earnings (losses) on Form 5500 due to different reporting requirements on Form 5500.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

The Plan's expenses are paid by either the Plan or the Employer, as provided by the Plan document. Expenses that are paid directly by the Employer are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits. In addition, certain investment related expenses are included in net depreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan.

Subsequent Events

The Plan has evaluated subsequent events through December 4, 2024, the date which the financial statements were available to be issued.

Note 3 - Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2023, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period ended February 6, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by AUL (the custodian of the Plan).

Note 5 - Investment Contracts with Insurance Company

The Plan has entered into multiple traditional fully benefit-responsive investment contracts with AUL. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value, as reported to the Plan by AUL, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. The contract value of the investment contracts at February 6, 2024 and December 31, 2023 was \$0 and \$490,160, respectively.

AUL maintains the contributions from all contracts in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The guaranteed interest rate is based on a formula agreed upon with the issuer but may not be less than 1% for the AUL Fixed Account or 3.75% for the Alternate Fixed Account. In accordance with the contract, the interest rate for the AUL Stable Value Account was subject to market rates for 2024. Such interest rates are reviewed on a quarterly basis for resetting.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract at contract value. Participants may transfer funds every 90 days. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents; (2) changes to the Plan's prohibition on competing investment options; or (3) significant withdrawals from the Plan. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 6 - Party-in-Interest Transactions

Certain Plan investments are shares of pooled separate accounts managed by AUL and fully benefit-responsive investment contracts managed by AUL. AUL is the custodian as defined by the Plan. Investment management service fees are paid by the Plan participants as part of investment purchase price pursuant to the AUL contracts. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Note 7 - Tax Status

The Plan uses a pre-approved Plan document sponsored by OneAmerica Financial Partners Inc., which received an advisory letter from the Internal Revenue Service (IRS), dated November 22, 2017, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 - Plan Amendments

Effective January 1, 2023, the Plan was amended to comply with provisions of the SECURE 2.0 Act. In addition, effective December 28, 2023 the Plan was amended to no longer allow annuities as a permitted form of distribution and the joint and survivor annuity distribution requirements will no longer apply. Effective January 1, 2024, the Plan was amended to comply with provisions of the CARES Act.

On September 23, 2024, the Board of Directors ratified and adopted a resolution to freeze the Plan effective December 31, 2023. No new participants could enter the Plan after that date and no further contributions could be made to the Plan, but active participants continue to accrue benefits.

Note 10 - Delinquent Participant Contributions

During Plan year ended December 31, 2021, the Plan sponsor inadvertently failed to deposit approximately \$1,414 of participant contributions within the required timeframe as stated by the United States Department of Labor regulations. The contributions were remitted during 2023. The Plan sponsor is in the process of determining lost earnings to correct this failure. The correction will be made from the Plan sponsor's assets and not from assets of the Plan.

Note 11 - Plan Termination

On September 23, 2024, the Board of Directors ratified and approved a plan of liquidation for the Plan. The Plan termination was effective December 31, 2023 and the Plan Sponsor announced the termination of the Plan and a formal plan to liquidate. Individuals could elect to take a distribution paid direct to them or in a direct rollover. All of the Plan assets were either distributed or transferred, as elected by each participant, as of February 6, 2024. There were no liquidation costs and the adoption of the liquidation basis of accounting did not have a material effect on values of the Plan's assets.

The Board of Directors adopted a resolution to convert the existing Ida County, Iowa Community Hospital, Inc. dba Horn Memorial Hospital Employees' Pension Plan (a separate plan) to the Horn Memorial Hospital 401(k) Plan effective January 1, 2024. Pursuant to the Plan termination discussed above, participants could elect a direct rollover of their plan balance to an eligible retirement plan, individual retirement account, or to the Horn Memorial Hospital 401(k) Plan, or to take a lump sum payment as a direct distribution. If they otherwise did not make a distribution election, the balance would be rolled into the Horn Memorial Hospital 401(k) Plan. As a result, during the period from January 1, 2024 to February 6, 2024 assets of approximately \$6,775,000 were transferred from the Plan to the Horn Memorial Hospital 401(k) Plan.
