Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ***Williams Distributing Company Retirement Savings Plan*** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits in liquidation as of March 4, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits in liquidation for the period ended March 4, 2024, and the related notes to the financial statements (the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of March 4, 2024 and December 31, 2023, and for the period ending March 4, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.



Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Independent Auditors' Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Independent Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, Williams Distributing Company, the Plan Sponsor, approved a plan of liquidation in October 2023. In accordance with accounting principles generally accepted in the United States of America, the Plan has used the liquidation basis of accounting to present the financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Independent Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an independent auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

1. PLAN TERMINATION

In January 2023, the Company was acquired by Daikin Comfort Technologies North America ("Daikin"). In October of 2023, the Plan Sponsor approved a plan termination with an effective date of December 31, 2023 and to merge all Plan assets into the Daikin 401(k) Plan. Upon the effective date of Plan termination, the participants became 100% vested in their employer contributions. On March 4, 2024, participant accounts aggregating \$23,554,281, which included \$245,539 in outstanding loans, were transferred from the Plan to the Daikin 401(k) Plan. The Company remitted delinquent participant deferrals and lost earnings to the Daikin 401(k) Plan on October 18, 2024.

2. DESCRIPTION OF THE PLAN

The following description of *Williams Distributing Company Retirement Savings Plan* (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering all employees of *Williams Distributing Company* (the "Company" or "Plan Sponsor") who had worked at least 60 days of service in the Plan year and were age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Transamerica Life Insurance Company (the "Trustee" or "Transamerica") was the trustee and recordkeeper of the Plan. The Company was the administrator of the Plan (the "Plan Administrator"). The Trustee held all assets of the Plan in accordance with the service provider contract with the Company. Management of the Company was responsible for oversight of the Plan, determined the appropriateness of the Plan's investment offerings, monitored investment performance and reported to the Plan's Trustees.

Notes to Financial Statements

Contributions

Each year participants could contribute up to 100% of annual compensation as defined in the Plan subject to certain IRS limitations. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to contribute to the Plan. Automatically enrolled participants had their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan included an auto-escalation feature, whereby automatically enrolled participant's contributions increased by 2% of eligible compensation annually up to 4% of eligible compensation. Eligible participants received a discretionary matching contribution after working at least 1,000 hours in their first twelve months of employment. Additional amounts could have been contributed at the discretion of the Company's management. During the period ending March 4, 2024, the Company made matching contributions of 50% for each eligible participant's contributions up to 2% of eligible compensation throughout the period. The Company, at its discretion, could have made an additional profit sharing contribution to the Plan at an amount equal to a percentage of each participant's eligible compensation. The Company did not make a discretionary contribution during 2024. Participants directed the investment of contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account was credited with the participant's contributions and the Company's matching contributions (when made) and an allocation of (a) the Company's discretionary contribution (when made), and (b) Plan earnings and charged with an allocation of administrative expenses, if any. Participants who initiated a loan or benefit payment were charged a fee for that transaction. Allocations were based on participant compensation, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their 401(k) voluntary contributions plus actual earnings thereon. On December 31, 2023, the Plan was terminated and participants became immediately vested in all Company matching and discretionary contributions. Prior to December 31, 2023, vesting in the Company matching and discretionary contributions was based on years of continuous service. A participant became 100% vested after six years of credited service.

Notes Receivable from Participants

Participants could borrow from their accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The resulting notes receivable were secured by the balances in the participants' accounts and bore interest at rates ranging from 5.25% to 10.50%, which were commensurate with local prevailing rates at the time the notes were issued, as determined quarterly by the Plan Administrator. Principal and interest was collected ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, financial hardship, retirement or any other distributive event, as defined in the Plan agreement, participants or their beneficiaries could receive an amount equal to the value of the participant's vested interest in their account in a lump-sum payment or in various installment annuities. The Plan also allowed distributions on attainment of 59 1/2 years of age equal to the value of the participant's vested interest in their account.

Forfeited Accounts

If a participant was not fully vested on their termination date, the nonvested amount of the account was forfeited. Forfeitures were used to reduce future employer cash contributions or to pay Plan expenses as determined by Plan management. Employer cash contributions and plan expenses were reduced by \$27,409 and \$8,363, respectively, from forfeited nonvested accounts during the period ended March 4, 2024. At December 31, 2023, forfeited nonvested accounts totaled \$8,920. There were no forfeited nonvested accounts transferred to the Daikin 401(k) Plan in 2024.

3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

As the Company terminated the Plan, the Plan's statements of net assets available for benefits and statement of changes in net assets available for benefits are prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). The adoption of the liquidation basis of accounting had no impact on the Plan's financial statements as its assets available for benefits were already reported at fair value.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value, except for the fully benefit-responsive investment contract, which was reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determined the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's aggregate gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees were recorded as administrative expenses and were expensed when they were incurred. If a participant ceased to make loan repayments and the Plan Administrator deemed the note receivable to be in default, the participant note receivable was reduced and a benefit payment was recorded.

Contributions

Participant contributions were recorded when withheld from compensation. Employer contributions were recorded in the period in which they become obligations of the Company.

Excess Contributions Payable

Contributions withheld in excess of amounts allowed by the IRS are recorded as excess contributions payable with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 4, 2024.

Benefits Paid to Participants

Benefit payments to participants were recorded when paid.

Administrative Expenses

The Plan's administrative expenses were paid either by the Plan or the Company, as provided by the Plan agreement. Certain administrative expenses, including an allocation of salaries related to Plan administration were paid by the Company and qualify as party-in-interest transactions which are exempt from prohibited transaction rules. Expenses that were paid directly by the Company are excluded from these financial statements. Fees for custodial, investment management, record keeping services, and audit fees were paid by the Plan. Participants were charged directly for notes receivable fees and fees related to certain distribution types.

Subsequent Events

In preparing these financial statements, Plan management has evaluated, for potential recognition or disclosure, significant events or transactions that occurred during the period subsequent to March 4, 2024, the most recent statement of net assets available for benefits presented herein, through the date of the accompanying Independent Auditors' Report, the date these financial statements were available to be issued. No such significant events or transactions were identified.

4. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at March 4, 2024 and December 31, 2023, and net change in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period ended March 4, 2024, was obtained by management and agreed to and derived from information certified as complete and accurate by Reliance Trust Company ("Reliance") as custodian of the mutual funds, Transamerica, as custodian of the fully benefit-responsive investment contract, and Great Gray Trust Company ("Great Gray") formerly known as Wilmington Trust Company as custodian of the collective investment trusts.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. For financial assets recorded at fair value, the description includes an indication of the level of the fair value hierarchy in which assets are classified. There have been no changes in the methodologies used at March 4, 2024 or December 31, 2023.

Mutual funds: Shares held in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trusts ("CIT"): Valued at the NAV of units of a collective trust fund, classified as "other" and not assigned a level in the fair value hierarchy. The NAV as provided by the trustee of the CIT, is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. There were no transfers of assets into or out of Level 3 during the period ended March 4, 2024.

6. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan had entered into a traditional fully benefit-responsive guaranteed investment contract with Transamerica, the guaranteed investment contract issuer ("issuer") with a balance of \$131,160 at December 31, 2023. The fully benefit-responsive guaranteed investment contract was transferred with other Plan assets at March 4, 2024. Transamerica maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but could not be less than 0%. The crediting rate was reviewed on a semi-annual basis for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could have been affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include:

- 1) Amendments to the Plan documents (including complete or partial Plan termination or merger with another plan),
- 2) Changes to the Plan's prohibition on competing investment options,
- 3) Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan,
- 4) The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or
- 5) Premature termination of the contract.

Plan management did not believe there were any events probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events included:

- 1) Changes to the Plan that significantly affect contract obligations,
- 2) The contract can no longer be treated as a pension plan contract as defined under the Internal Revenue Code (the "Code")
- 3) The Plan is terminated,
- 4) Failure to comply with contract requirements,
- 5) Failure to provide needed information except by unintentional omission,
- 6) Failure to furnish a copy of any amendments or annual reports within 30 days except by unintentional omission, or
- 7) The contract account's value is less than \$20,000.

Upon termination of the Plan at March 4, 2024, the investment contract with Transamerica was liquidated and transferred into the Daikin 401(k) Plan at contract value.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were in funds and accounts that were managed by Transamerica and Great Gray or their subsidiaries and affiliates. Participant loan and distribution processing fees were paid to Transamerica by participants. The Plan paid for third party administrator fees, investment advisory, and plan audit fees which qualify as party-in-interest transactions. The Plan also issued loans to participants which were secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option were paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

8. TAX STATUS

The Plan used a prototype plan document sponsored by Transamerica. The prototype plan document has received an opinion letter from the IRS dated June 30, 2020, which states that the written form of the underlying prototype plan document is qualified under Section 401(a) of the Code and that any employer adopting this form of the plan will be considered to have a plan qualified under Section 401(a) of the Code. The Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Administrator believes the Plan was operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified and the related trust was tax-exempt.

US GAAP requires Plan management to evaluate and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. While the Plan may be subject to routine audits by taxing jurisdictions, there are currently no audits for any tax periods in progress.

9. DELINQUENT PARTICIPANT CONTRIBUTIONS

During the Plan period ended March 4, 2024 and year ended December 31, 2023, participant contributions totaling \$25,561 were not remitted to the Plan within the period prescribed by Department of Labor regulations. The contributions and related lost earnings were remitted to the Daikin 401(k) Plan during 2024.
