### **Opinion**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Los Angeles Sheriff's Professional Association Benefit Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**A. General**

The Plan is a payroll reimbursement and prepaid legal services plan that provides benefits in the event an eligible member is suspended by the Los Angeles County Sheriff's Department (the "Department"). The Plan was established on June 1, 1999 by the Los Angeles Sheriff's Professional Association (the "Association"). Substantially all active, dues paying members of the Association are eligible to participate. The Association's officers serve as the Board of Directors/Committee to manage the operation and administration of the Plan. The plan administrator believes the Plan is designed and operated in compliance with the applicable requirements of the Internal Revenue Code (the "Code") and is taking action to bring the Plan into compliance with provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**B. Contributions**

Contributions to the Plan are paid by members through payroll deductions at a rate determined by the Board of Directors/Committee. The required contribution rate is subject to change as may be deemed necessary by the Board of Directors/Committee.

**C. Eligibility**

All Association members are eligible to participate in the Plan. Members are not eligible for reimbursement if the alleged conduct resulting in suspension involves matters outside the course and scope of employment, malicious disregard for public policies, repetitive policy violations, reckless behavior, or if the investigation leading to discipline began before the member joined the Association. Representation must utilize Association counsel for each phase of any Department investigation, the initial interview through the final grievance stage.

**D. Payment of Benefits**

Benefits consist of payments equal to an officer's gross or hourly pay rate, excluding overtime, as determined by the Board of Directors/Committee for up to 30 days, depending on his or her level of membership in the Association (see Note 7). Benefits are received in the form of legal services and payroll reimbursements, if appropriate, and are recorded when paid.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements are prepared on the modified cash basis of accounting. Member contributions are recognized when received and expenses are recognized when paid.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**B. Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 3 - INCOME TAX STATUS**

The Plan received its tax exemption from the Internal Revenue Service under Section 501(c)(9) of the Internal Revenue Code on May 5, 2021 and believes its exempt under the state of California Revenue and Taxation Code Section 23071(i). The Board of Directors/Committee believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Code and related state statutes and is exempt from federal income and state franchise taxes.

Accounting principles require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Board of Directors/Committee has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, after paying expenses, any and all monies may be used to continue paying benefits until such monies have been exhausted or transferred to another trust or non-profit entity which provides similar benefits, or used as directed by the Board of Directors/Committee.

**NOTE 5 - BENEFIT OBLIGATIONS**

The Plan's benefit obligations include estimated payroll reimbursements for incidents which occurred prior to the Plan year end and have been approved for benefit coverage by the Board of Directors/Committee and the provision of prepaid legal services. Benefits incurred but not paid through the Plan year end and estimated future benefits through the closure of the cases are included in the benefit obligations. As of May 31, 2024 and 2023, there were no benefit obligations.

**NOTE 6 - RELATED PARTY TRANSACTIONS**

The Association collects member dues and contributions and pays expenses on behalf of the Plan. Contributions and plan expenses are allocated to the Plan based upon flat dollar amounts or formulas approved by the Board of Directors/Committee.

**NOTE 7 - SUBSEQUENT EVENTS**

In October 2024, the Board of Directors/Committee changed the method of calculating the officer's payroll reimbursements to his or her daily current earnings times the number of approved reimbursed days.

Management has evaluated subsequent events through October 24, 2024, the date on which the financial statements were available to be issued. Except as discussed above, there were no material subsequent events that required recognition or additional disclosures in these financial statements.


