## **Basis for Opinion**

As discussed in Note 1 to the financial statements, the Board of Managers of NJOY, LLC, the Plan Sponsor, directed the Plan Trustee on April 17, 2024, to merge the Plan into the Altria Deferred Profit-Sharing Plan for Salaried Employees effective April 30, 2024. All Plan assets were transferred to the control of the Altria Deferred Profit-Sharing Plan for Salaried Employees. Our opinion has not been modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

#### **Note 1. Description of the Plan**

The following description of the NJOY 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering all eligible employees of NJOY, LLC (the "Company") who are at least 21 years of age. The inception date of the Plan was July 1, 2019. Employees hired prior to the date of plan inception became immediately eligible to participate on July 1, 2019. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee of the Plan is Fidelity Management Trust Company (the "Trustee"). Effective June 1, 2023, the Plan Sponsor was sold to a third party.

##### Plan amendments

Effective January 1, 2024, the Plan was amended to freeze active participation, and participants became 100% vested in their Company's discretionary nonelective contributions.

##### Plan Merger and Transfer of Plan Assets

As a result of the sale of the Plan Sponsor, the Board of Managers of NJOY, LLC directed the Plan Trustee on April 17, 2024, to merge the Plan into the Altria Deferred Profit-Sharing Plan for Salaried Employees (an existing plan controlled by the acquiring company) effective April 30, 2024.

##### Contributions

Each year, participants may contribute any portion of eligible compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes safe harbor matching contributions equal to 100 percent of the first 3 percent of eligible compensation that a participant contributes to the Plan, and 50 percent of the next 2 percent of participant contributions. The Company may elect to make additional discretionary nonelective contributions. During the four month period ended April 30, 2024, no discretionary nonelective contributions were made. Contributions are subject to certain Internal Revenue Service (IRS) limitations. No contributions were made during the period from January 1, 2024 and April 30, 2024.

##### Participant accounts

Each participant's account is credited with the participant's contributions, Company contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Note 1. Description of the Plan, Continued**

##### *Vesting*

Participants are vested immediately in their voluntary contributions, Company safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary nonelective contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after 6 years of credited service.

##### *Payment of benefits*

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or other installment options as provided by the Plan. Hardship distributions are permitted upon demonstration of a financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59<sup>1/2</sup>.

##### *Forfeited accounts*

At April 30, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$114, respectively. These accounts may be used to reduce future Company contributions. During the period from January 1, 2024 to April 30, 2024, Company contributions were reduced by \$114 from forfeited nonvested accounts.

#### **Note 2. Summary of Significant Accounting Policies**

##### *Basis of accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### *Contributions*

Contributions from Plan participants and the contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation.

##### *Use of estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Note 2. Summary of Significant Accounting Policies, Continued**

##### *Investment valuation and income recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Payment of benefits*

Benefits are recorded when paid.

##### *Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### *Subsequent events*

The Plan has evaluated subsequent events through November 20, 2024, the date that the financial statements were available to be issued.

##### *Recently issued accounting pronouncements*

Accounting standards that have been issued or proposed by the Financial Accounting Standards Board or other standards-setting bodies are not expected to have a material impact on the Plan's financial statements.

#### **Note 3. Trustee Certifications**

The following is a summary of the Plan's asset information as of April 30, 2024 and December 31, 2023, and for the period from January 1, 2024 to April 30, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the Trustee and furnished to the plan administrator. The plan administrator has obtained certifications from the Trustee that the information provided to the plan administrator by the Trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets:

**Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2: Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
  - Quoted prices for similar assets or liabilities in active markets.
  - Quoted prices for identical or similar assets or liabilities in inactive markets.
  - Inputs other than quoted prices that are observable for the asset or liability.
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2024 and December 31, 2023. There were no investments measured at fair value as of April 30, 2024.

**Note 5. Related-Party and Party in Interest Transactions**

Certain Plan investments are managed by the Trustee, as defined by the Plan. Therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the Trustee totaling \$12,798 which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan’s operations.

**Note 6. Tax Status**

Effective November 23, 2020, the Plan adopted a non-standardized pre-approved profit-sharing plan sponsored by FMR LLC, the plan provider. The plan provider has received an opinion letter from the IRS, as to the pre-approved plan's qualified status. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the April 30, 2024 statement of net assets available for benefits.
