As discussed in Note I to the financial statements, the 401(k) Plan Committee, the Plan's Sponsor, voted on May 23, 2023, to merge the Plan into the Trillion Group Retirement Savings Plan effective January 1, 2024. All plan assets were transferred to the Trillion Group Retirement Savings Plan on January 22, 2024, and employer contribution receivables on March 12, 2024. Our opinion has not been modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Fehr-Graham & Associates 401(k) Profit Sharing Plan (the Plan) provides only general information. Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

1. General

The Plan was a defined contribution profit sharing and 401(k) plan covering eligible employees of Fehr-Graham & Associates (the Company). Employees were eligible to participate and earn discretionary Company matching contributions upon attaining age 18 and may not be covered by a collectively bargained agreement or be non-resident aliens. The Plan excluded employees classified as interns and part-time employees who were scheduled to work less than one thousand hours. Participants were eligible to receive discretionary Company profit sharing contributions after completing one thousand hours of service, provided they were employed on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2023, the Plan Sponsor was acquired by the Trilon Group, LLC. Effective January 1, 2024, the Plan was merged into the Trilon Group Retirement Savings Plan, (the "Surviving Plan"). The participants' vested account balances in the Surviving Plan equaled the vested account balances in the Plan upon the transfer. The merger does not impact participant benefits as the benefit provisions were incorporated into the Surviving Plan. Interested parties should refer to the Surviving Plan's Plan adoption agreement and plan document for a complete description of the plan.

2. Contributions

The Plan was funded by voluntary contributions of participants and discretionary matching and profit sharing contributions of the Company. Participants were able to contribute to the Plan, through regular payroll deductions, and participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants were also able to roll over amounts representing distributions from other qualified employee benefit plans. The Company funded \$855,094 on March 12, 2024 directly to the surviving plan for employer contributions related to the plan year ending December 31, 2023. This included \$966,346 for employer discretionary profit sharing reduced by forfeitures used of \$119,930, and \$8,678 for true-up of discretionary employer match contributions. No discretionary employer matching contributions or discretionary employer profit sharing contributions were made to Plan for the period ended March 12, 2024. Contributions were subject to certain IRS limitations.

3. Investment Options

Participants were permitted to direct their salary deferral contributions and the Company's contributions into a variety of investment funds made available and determined by the Plan Administrator. Participants were also permitted to change their investment options at any time.

4. Participant Accounts

Each participant's account was credited with the participant's contribution, an allocation of the Company's discretionary matching and profit sharing contribution and an allocation of plan earnings. The Company's discretionary profit sharing contributions were calculated based on a percentage determined by the Company's net income for the year. The Company's matching contribution was calculated based on a percentage determined by the Company. Plan earnings were allocated to participants' accounts in direct proportion to their respective account balances, based on the performance of participants' investment selections. The benefit to which a participant was entitled to was the benefit that can be provided from the participant's vested account balance.

5. Vesting

Participants were immediately fully vested in participant contributions and rollover contributions plus the actual earnings thereon. The portion of the participants' accounts attributable to the Company's discretionary matching and profit sharing contributions became 20% vested after two years of service and continued to vest at the rate of 20% for each successive year until 100% vested after six years of service. In the event of death, disability, or retirement at normal retirement age as defined in the Plan document, participants became fully vested.

6. Payment of Benefits

On termination of service, a participant could elect to receive a single, lump sum payment equal to the value of his or her vested account balance, or a direct rollover distribution. In-service withdrawals for participants over the age of 59 1/2 were also permitted by the Plan. Vested account balances which do not exceed \$5,000 upon termination of employment were paid in a lump sum as soon as administratively practicable following termination. Under certain conditions participants were eligible to receive a hardship distribution.

7. Administrative Expenses

Certain expenses incurred maintaining the Plan were paid directly by the Company and are excluded from these financial statements. Certain investment-related expenses were included in net depreciation in fair value of investments.

8. Forfeitures

At March 12, 2024 and December 31, 2023, unallocated plan assets resulting from forfeited nonvested accounts totaled \$0 and \$119,930, respectively. These accounts were used to reduce future Company contributions or pay the Plan's administrative expenses. In 2024, \$119,930 forfeitures were used to reduce the 2023 employer contribution made in 2024. The employer contribution receivable balances at March 12, 2024 and December 31, 2023 are stated net of forfeitures.

9. SECURE 2.0 Act

The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2023 and later. No optional provisions have been adopted through the report date.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting. The Plan recognizes employee contributions and the related employer matching contributions in the period in which the related employee contribution is withheld.

2. Fair Value Measurements

Current accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include the following:

- \* Quoted prices for similar assets or liabilities in active markets;
- \* Quoted prices for identical or similar assets or liabilities in inactive markets;
- \* Inputs other than quoted prices that are observable for the asset or liability;
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for the Plan's investments measured at fair value. There have been no changes in the methodologies used at March 12, 2024 and December 31, 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Interest-bearing cash:* Valued at amortized cost, which approximates fair value. Interest-bearing cash is considered to have readily available access to its valuation techniques.

3. Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determined the Plan's valuation policies utilizing information provided by the investment advisers and trustees. See Note B-2 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

4. Use of Estimates

In preparing the Plan's financial statements, management was required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

5. Payment of Benefits

Benefits are recorded when paid.

NOTE C - INFORMATION CERTIFIED BY AMERICAN TRUST CUSTODY

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at March 12, 2024 and December 31, 2023, net appreciation in fair value of investments and interest and dividend income for the period January 1, 2024 through March 12, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by American Trust Custody (the trustee of the Plan).

NOTE D - TAX STATUS

Effective October 1, 2021, the Plan adopted a standardized form of a prototype plan sponsored by Dubuque Bank & Trust Co. The prototype plan has received an opinion letter from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E - PLAN TERMINATION

Although it has not expressed any formal intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become fully vested in their respective account balances.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G - RELATED PARTY-IN-INTEREST TRANSACTIONS

Plan investments were managed by American Trust Custody. American Trust Custody was the trustee, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment. July Business Services provided recordkeeping services to the Plan and fees paid for these services also qualify as party-in-interest transactions.

The Plan had previously utilized Heartland Retirement Plan Services as its recordkeeper and Dubuque Bank & Trust Company as the custodian and trustee. In May 2023, July Business Services acquired Heartland Retirement Plan Services. Although the name of the recordkeeper and custodian changed, there was no transfer of assets.

NOTE H - PLAN AMENDMENTS

Effective January 1, 2023, the Plan was amended to update the fees associated with the Plan. Significant provisions of the amended plan document are consistent with those of the current plan document. Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

NOTE I - PLAN MERGER AND TRANSFER ACTIVITY

In May 2023, the Plan Sponsor was acquired by The Trilon Group, LLC. Effective January 1, 2024, the Plan was merged into the Trilon Group Retirement Savings Plan, (the "Surviving Plan"). Total investment assets of \$23,710,976 were merged into the Surviving Plan and transferred to the Surviving Plan on January 22, 2024. Employee elective contributions and employer discretionary match contributions related to the plan year ending December 31, 2023, totaling \$47,514 and \$16,275, respectively, were funded into the Plan during 2024 prior to transfer. Employer contributions of \$855,094, also related to the December 31, 2023 plan year, were funded directly to the Surviving Plan on March 12, 2024. The participants' vested account balances in the Surviving Plan equaled the vested account balances in this Plan upon the transfer. The merger did not impact participant benefits as the benefit provisions were incorporated into the Surviving Plan. Interested parties should refer to the Surviving Plan's Plan adoption agreement and plan document for a complete description of the plan.

NOTE J - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through November 12, 2024, the date that these financial statements were available to be issued. Plan management has determined that no events or transactions have occurred subsequent to the statement of net assets available for benefits date that require disclosure in the financial statements.
