Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ramco Electric Motors, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 19, 2022 and June 30, 2022, and the related statement of changes in net assets available for benefits for the period ended October 19, 2022, and the related notes to the financial statements.

INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator
Ramco Electric Motors, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ramco Electric Motors, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. DESCRIPTION OF PLAN:

The following description of Ramco Electric Motors, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Ramco Electric Motors, Inc. (the plan sponsor or Company) who have attained the age 21 and completed six months of service. Participation is not permitted for employees who are non-resident aliens, union employees, or leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective October 19, 2022, the Plan was merged into The Arnold Magnetic Technologies Corporation Employee Retirement Savings Plan. Assets from the Ramco Electric Motors, Inc. 401(k) Plan in the amount of \$2,824,517 were transferred out of the Plan. The remaining notes refer to the Plan prior to the merger.

Contributions

Each year, participants may contribute up to 100% of their compensation (through pre-tax or Roth contributions), as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect a deferral rate or not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. The Company makes a discretionary matching contribution to eligible participants equal to 33% of the first 6% of eligible compensation that a participant contributes to the Plan. Additional discretionary profit sharing contributions may be contributed at the option of the Company and are allocated using the ratio of each participant's eligible compensation to total eligible compensation. Participants are eligible to receive the discretionary profit sharing contribution if they are employed on the last day of the Plan year and worked at least 1,000 hours of service. Contributions are subject to certain Internal Revenue Service (IRS) limitations. During the period ended October 19, 2022, discretionary matching contributions totaled \$18,419 and no discretionary profit sharing contributions were contributed.

Participant accounts

Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of benefits

Distributions are payable upon termination of employment, death, disability, or retirement. Participants may elect to receive a lump sum, ad hoc, or installment payments equal to the value of the participant's vested interest in his or her account. Participants may also make withdrawals of fully vested account balances prior to termination upon attainment of age 59 ½.

Forfeited accounts

At June 30, 2022, forfeited non-vested accounts totaled \$6,935. These accounts may be used to reduce future employer contributions or pay administrative expenses.

2. SUMMARY OF ACCOUNTING POLICIES:**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain investment related expenses are included in net depreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through October 15, 2024, the date the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S CUSTODIAN:

Management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company (Voya), the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statement of net assets available for benefits as of October 19, 2022 and June 30, 2022, and the related investment activity reflected in the statement of changes in net assets available for benefits for the period ended October 19, 2022.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at October 19, 2022 and June 30, 2022.

Pooled separate accounts: Pooled separate accounts are held in investment contracts with the custodian and are invested according to the stated objectives of the various accounts. The principal is not guaranteed. The pooled separate accounts are valued at the net asset value, which is based on the market value of its underlying investments. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The underlying investments consist primarily of registered investment companies with readily determinable fair values. The investment objectives of the accounts include to generate income, maintain liquidity, preserve capital, or attain certain performance levels based on different risk tolerance levels. The pooled separate

accounts held by the Plan are not direct filing entities and as such are reported on the Form 5500 based on the categories of the underlying assets, which primarily include registered investment companies.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of June 30, 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

5. GUARANTEED INVESTMENT CONTRACT:

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Voya totaling \$131,682 as of June 30, 2022. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

6. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:

Certain plan investments are funds managed by Voya, the custodian of the Plan, and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of the investment, as they are paid through revenue sharing, rather than direct payment. The Plan sponsor pays directly other fees related to the Plan's operations.

7. TAX STATUS:

The Plan operates under a volume submitter plan document which received a favorable opinion letter from the IRS on June 30, 2020, that stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan did not obtain its own determination letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

8. PLAN TRANSFER:

Effective October 19, 2022, the Plan was merged into The Arnold Magnetic Technologies Corporation Employee Retirement Savings Plan. Assets from the Ramco Electric Motors, Inc. 401(k) Plan in the amount of \$2,824,517 were transferred out of the Plan.
