Basis for Opinion

NOTES TO THE FINANCIAL STATEMENTS MAY 7, 2024 AND MAY 31, 2023

1. DESCRIPTION OF PLAN

The following brief description of Carthage Area Hospital Employees Pension Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more information and a complete description of the Plan's provisions.

General

The Plan was a noncontributory defined benefit pension plan covering substantially all employees of Carthage Area Hospital (the Hospital or Plan Sponsor) with the exception of employees who are members of 1199 SEIU United Healthcare Workers East, members of the New York State Nurses Association (NYSNA) who did not complete a year of service prior to December 17, 2016, and all other employees who did not complete a year of service prior to September 30, 2013. Employees became participants of the Plan upon completion of one year of qualifying service (832 hours) and attaining the age of twenty-one. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

As further described in Note 3, the Board of Directors of the Hospital approved a plan to terminate the Plan effective February 28, 2022. All assets of the Plan were disbursed by May 7, 2024. Participant balances were distributed in accordance with each participant's elected method of distribution.

Plan Amendments

Effective September 30, 2013, the Hospital amended the Plan to freeze participation and future benefit accruals for all employees except those who are members of the NYSNA.

Effective December 17, 2016, the Hospital amended the Plan to freeze participation and future benefit accruals for all employees, including employees who are members of the NYSNA.

Effective February 2, 2022, the Hospital amended the Plan to terminate the Plan effective February 28, 2022.

Administration

The Plan was administered by management of the Hospital who are appointed by authorized officers of the Hospital. Management administered the Plan in accordance with its terms and applicable laws and has all necessary and appropriate powers to carry out the provisions of the Plan. Principal Life Insurance Company (Principal) served as the custodian of the Plan's assets.

Eligibility

All regular employees who had completed a year of service prior to the respective participation freeze dates, satisfying the eligibility requirements were covered under the Plan.

Funding Policy

The Plan's funding policy was for the Hospital to contribute an amount that will meet or exceed the annual ERISA minimum funding requirement. The Hospital met the minimum funding requirements of ERISA for the period ended May 7, 2024 and the year ended May 31, 2023.

1. DESCRIPTION OF PLAN (CONTINUED)

Pension Benefits

Prior to Plan termination, employees with 5 or more years of service were entitled to annual pension benefits beginning at normal retirement age (65) equal to the greater of the participant's accrued benefit as of August 31, 1998, based on the benefit formula in effect immediately prior to September 1, 1998, or the sum of (a) and (b) where:

- (a) Equals 10% of a participant's final average compensation up to covered compensation plus 20% of a participant's final average compensation in excess of covered compensation, reduced for service less than 35 years, and
- (b) Equals 0.5% of the participant's final average compensation for each year of credited service in excess of 35 years.

Covered compensation means the participant's average compensation rounded to the nearest \$3,000 of the Social Security wage base, for the 35 calendar years prior to the normal retirement date. Final average compensation means a participant's average compensation during the five consecutive calendar years of active participation in the Plan prior to retirement or termination of employment.

The Plan allowed early retirement beginning at age 55. Employees could elect to receive their pension benefits in the form of a straight life annuity, joint and survivor annuity, contingent annuity or installments over a certain number of years. Lump-sum payments were made to participants whose accumulated plan benefits are less than or equal to \$5,000. If employees terminated before rendering 5 years of service, they forfeited the right to receive their accumulated plan benefits.

Death and Disability Benefits

If a married participant died at age 55 or older, the surviving spouse or other designated beneficiary was entitled to receive a death benefit equal to the amount that would have been paid to the spouse under a joint and survivor annuity as if the participant had begun receiving distributions at normal retirement age. If a married participant died prior to age 55, the surviving spouse or other designated beneficiary was entitled to receive a death benefit equal to the amount that would have been paid to the spouse under a joint and survivor annuity as if the participant had begun receiving distributions at age 55.

A participant with 5 or more years of service and who suffered a disability was entitled to receive his or her vested accrued benefit determined as of the date benefits commence. This benefit was to be paid commencing either at what would have been the participant's normal retirement date or, if the participant elected, at or after the participant's early retirement date in an amount actuarially reduced in accordance with the same method used for adjusting early retirement benefits which were paid prior to normal retirement age.

Purchase of Annuity Contracts

In lieu of administering benefit payments directly with participants, the Plan entered into agreements for the purchase of annuity contracts with an insurance company. Annuity contracts were purchased for individual plan participants and the insurance company assumes the obligation to pay their benefits and related risks. The Plan purchased \$3,791,951 of annuity contracts during the period ended May 7, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP). As a result of plan management's decision to terminate the Plan, as described in Notes 1 and 3, the Plan changed its basis of accounting from the going concern basis to the liquidation basis as of September 28, 2021, the date a motion to terminate the Plan was approved (see Note 3). The liquidation basis of accounting presents any assets expected to be realized in liquidation and liabilities at amounts expected to be paid. In doing so, all assets and liabilities were adjusted to the amounts expected to be realized in liquidation as of the date of the motion and investments continued to be valued at fair value because sales of investments were expected to be made in an orderly fashion. Therefore, fair value approximated liquidation value at May 31, 2023.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein; disclosure of contingent assets and liabilities and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates and such differences may be significant.

Investment Valuation and Income Recognition

Investments are stated at fair value which approximates liquidation value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by its investment advisers and custodian.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants were recorded upon distribution.

Risks and Uncertainties

The actuarial present value of accumulated plan benefits was estimated based on certain assumptions pertaining to interest rates, market, currency, and employee demographics, all of which are subject to change. Due to the uncertainties inherent in this process, it is possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported in the financial statements.

The Plan invested in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is possible that changes in their values could occur in the near term and such changes could materially affect the amounts reported in the financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Fair Value Measurement

Generally accepted accounting principles establish a hierarchy for information and valuations used in measuring fair value that is broken down into three levels based on the reliability of inputs as follows:

- Level 1 – Valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 – Valuations are based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.
- Level 3 – Valuations are based on inputs that are unobservable and significant to the overall fair value measurement.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes to the valuation techniques used during 2024 and 2023.

Pooled separate accounts: The fair values of interests in pooled separate accounts are measured based upon the net asset value (NAV), which is a readily determinable fair value, published on a daily basis, and is the basis for current transactions in a manner similar to that of a mutual fund, using the fair value of the fund's underlying assets.

Administrative Expenses

The Plan's expenses were paid either by the Plan or the Hospital, as provided by the Plan document. Expenses that were paid directly by the Hospital are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that were paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits in liquidation. In addition, certain investment related expenses were included in net appreciation (depreciation) in the fair value of investments presented in the accompanying statements of changes in net assets available for benefits in liquidation.

Fees paid by the Plan to Principal for administrative services amounted to approximately \$21,000 and \$149,000 for the period ended May 7, 2024 and the year ended May 31, 2023, respectively.

3. PLAN TERMINATION

On September 28, 2021, the Plan Sponsor's Board of Directors approved a motion to terminate the Plan and management determined that liquidation is imminent. The Plan was terminated effective February 28, 2022. The Internal Revenue Service (IRS) approved the Plan's termination in a letter dated December 14, 2023. The election window for participants to choose the form of their benefit closed on March 18, 2024, and all Plan assets were distributed by May 7, 2024. The Plan Sponsor contributed \$823,388 to the Plan to fund payment of benefits.

3. PLAN TERMINATION (Continued)

The statements of net assets available for benefits in liquidation at May 31, 2023 include \$82,296 of accrued expenses that were expected to be incurred during the liquidation period, as follows:

Upon termination of the Plan, the rights of all employees to benefits accrued are nonforfeitable. The Plan has paid insurance premiums to the PBGC (a U.S. governmental agency) to protect plan participants upon termination of the Plan. Plan assets were to be allocated in accordance with ERISA regulations. Whether a particular participant's accumulated benefits were paid depended on both the priority of those benefits and the level of benefits guaranteed by the PBGC at that time.

Active and vested terminated participants had the ability to make an election for either an annuity or a lump sum distribution. Participants who did not complete an election received annuity payments.

4. ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances – retirement, death, disability and termination of employment – are included to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by the Plan's actuary and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment. The computations of the actuarial present value of accumulated benefits were made as of June 1, 2023.

The significant actuarial assumptions used in the valuations as of June 1, 2023 are as follows:

- interest rate of 4.00%;
- assumed mortality rate based on the Pri-2012 Total table projected generationally using MP-2021; and
- normal retirement age for participants is the later of age 65 and five years of participation.

The foregoing actuarial assumptions were based on the presumption that the Plan will continue. Under the liquidation basis of accounting, termination assumptions should have been used. As discussed in Note 3, in September 2021, Plan governance elected to terminate the Plan and all actuarially determined benefits were paid out by May 7, 2024.

We noted no transactions entered into by the Plan during the period that were both significant and unusual, and of which, under professional standards, we are required to inform you, or transactions for which there is a lack of authoritative guidance or consensus. Reportable Findings

Upon inquiry, it was noted that the current TPA was not servicing this Plan when this participant terminated and therefore the current TPA could not provide these documents. However, it is the Plan administrator's responsibility to retain this type of support for the Plan.

Disagreements with Management

For purposes of this letter, professional standards define a disagreement with management as a matter, whether or not resolved to our satisfaction, concerning a financial accounting, reporting, or auditing matter that could be significant to the financial statements or the auditors' report. We are pleased to report no such disagreements arose over the course of the audit.

Circumstance Affecting the Form and Content of the Auditor's Report

We encountered no circumstances that affect the form and content of the auditor's report.

Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters. If a consultation involves application of an accounting principle to the Plan's financial statements, or a determination of the type of auditors' opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Management Representations

We have requested certain representations from management that are included in the management representation letter. This letter has been provided to you.

Independence
