### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of DPI Specialty Foods 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 14, 2024 and December 31, 2023, the related statement of changes in net assets available for benefits for the period from January 1, 2024 through May 14, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of May 14, 2024 and December 31, 2023, and for the period from January 1, 2024 through May 14, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### **Basis for Opinion**

### **Emphasis of Matter - Plan Merger**

As discussed in Note I to the financial statements, the Investment Committee, the Plan's Sponsor, voted on November 11, 2023, to merge the Plan into the KeHE Distributors, Inc. 401(k) Retirement Savings Plan effective May 1, 2024. All plan assets were transferred to the KeHE Distributors, Inc. 401(k) Retirement Savings Plan on May 14, 2024, except as disclosed in Note J. Our opinion has not been modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

### **NOTE A - DESCRIPTION OF THE PLAN**

The following description of the DPI Specialty Foods 401(k) Retirement Savings Plan (the "Plan") provides only general information. Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

#### **1. General**

The Plan was a defined contribution profit sharing and 401(k) plan covering all nonunion employees and members of DPI Specialty Foods, Inc., DPI Specialty Foods West, Inc., DPI Specialty Foods Northwest, Inc., and DPI Specialty Foods Rocky Mountain, Inc. (collectively, the "Company"). Employees were eligible to participate and receive discretionary matching contributions upon completion of two consecutive months of service. Employees were eligible to share in discretionary profit sharing contributions upon completion of one year of service and employed on the last day of the plan year. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On November 11, 2023, the Plan Sponsor voted to merge the Plan into another existing plan (Note I). Effective May 1, 2024, the Plan was considered merged into the KeHE Distributors, Inc. 401(k) Retirement Savings Plan ("Surviving Plan").

#### **2. Contributions**

The Plan was funded by voluntary contributions of participants and discretionary matching and profit sharing contributions of the Company. Participants were able to contribute to the Plan, through regular payroll deductions, and participants who had attained age 50 before the end of the calendar year were eligible to make catch-up contributions. Participants had the option to roll over amounts representing distributions from other qualified employee benefit plans. The Company made discretionary matching contributions of \$339,909 to the Plan for the period January 1, 2024 through May 14, 2024. The Company made no discretionary profit sharing contributions to the Plan for the period January 1, 2024 through May 14, 2024. Contributions were subject to certain Internal Revenue Service ("IRS") limitations.

#### 2. Contributions (Continued)

The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants had their deferral rate increased at a rate of 1% per year on April 1 up to a maximum of 10% of eligible compensation, unless otherwise elected by the participant.

#### 3. Investment Options

Participants directed their salary deferral contributions and the Company's contributions into a variety of investment funds made available and determined by the Investment Committee. Participants had the option to change their investment options at any time.

#### 4. Participant Accounts

Each participant's account was credited with the participant's contribution, an allocation of the Company's discretionary matching and profit sharing contributions, and an allocation of plan earnings. The Company's discretionary matching contribution was allocated based on a percentage of the participant's contribution. The Company's discretionary profit sharing contribution was allocated as of the last day of the plan year and was based on a ratio of each eligible participant's compensation to total compensation for all eligible participants. Plan earnings were allocated to participants' accounts in direct proportion to their respective account balances, based on the performance of participants' investment selections. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account balance.

#### 5. Vesting

Participants were immediately fully vested in participant and rollover contributions plus the actual earnings thereon. The portion of the participants' accounts attributable to the Company's contributions became 20% vested after one year of service and continued to vest at the rate of 20% for each successive year until 100% vested after five years of service. In the event of death, disability, or retirement at designated ages, participants became fully vested.

##### 6. Payment of Benefits

On termination of service, a participant had the option to receive a single, lump-sum payment equal to the value of his or her vested account balance, an annuity, or a direct rollover distribution. In-service withdrawals were permitted to participants who have reached 59 1/2 years of age. Hardship withdrawals were also permitted by the Plan.

##### 7. Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Participants were permitted to take loans from the Plan up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were collateralized by the borrowers' respective vested account balances and bore interest at rates ranging from 4.25% to 9.50%. Principal and interest were paid through payroll deductions over a period not to exceed five years, unless for the purchase of a primary residence. All notes receivable from participants were transferred over to the Surviving Plan (Note I).

##### 8. Administrative Expenses

Certain expenses incurred maintaining the Plan were paid directly by the Company and are excluded from these financial statements. Investment-related expenses were included in net appreciation in fair value of investments.

##### 9. Forfeitures

At May 14, 2024, there were no unallocated plan assets resulting from forfeited nonvested accounts. At December 31, 2023, unallocated plan assets resulting from forfeited nonvested accounts were insignificant. These accounts were used to reduce future Company contributions or to pay plan expenses. Forfeitures of approximately \$85,000 were used to reduce discretionary matching contributions related to the Plan period from January 1, 2024 through May 14, 2024. No forfeitures were used to pay plan expenses to the Plan period from January 1, 2024 through May 14, 2024.

#### 10. Securing a Strong Retirement 2.0 Act

The Securing a Strong Retirement 2.0 Act ("SECURE 2.0 Act") was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2023 and later. No optional provisions have been adopted through the report date.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### 1. Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting. The Plan recognized employee contributions and the related discretionary employer matching contributions in the period the employee contribution is withheld.

#### 2. Fair Value Measurements

Current accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include the following:

- \* Quoted prices for similar assets or liabilities in active markets;
- \* Quoted prices for identical or similar assets or liabilities in inactive markets;
- \* Inputs other than quoted prices that are observable for the asset or liability;
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's investments measured at fair value at December 31, 2023. The Plan did not have any investments held at May 14, 2024 (Note I).

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value collective investment trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2023. The Plan did not have any investments held at May 14, 2024 (Note I).

The Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisers. See Note B-2 for discussion of fair value

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

##### **4. Use of Estimates**

In preparing the Plan's financial statements, management was required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

##### **5. Payment of Benefits**

Benefits were recorded when paid.

#### **NOTE C - INFORMATION CERTIFIED BY FIDELITY MANAGEMENT TRUST COMPANY**

Certain information related to investments disclosed in the accompanying financial statements, including investments held at December 31, 2023, and net appreciation in fair value of investments and interest and dividends, and interest income on notes receivable from participants for the period January 1, 2024 through May 14, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the "Trustee" of the Plan).

#### NOTE D - TAX STATUS

Effective June 30, 2020, the Plan had adopted a nonstandardized pre-approved profit sharing plan sponsored by FMR, LLC. The pre-approved plan had received an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. However, the Investment Committee believed that the Plan was designed and being operated in compliance with the applicable provisions of the Internal Revenue Code ("IRC").

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE E - PLAN TERMINATION

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would have become fully vested in their respective account balances (Note I).

#### NOTE F - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could have occurred and that such changes could have materially affected participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments were managed by the Trustee, as defined by the Plan. Therefore, these transactions qualified as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment.

The Plan was able to issue loans to participants, which were secured by the vested balance in the participant's accounts and certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualified as party-in-interest. Employees of the Company provide administrative services for which no fees are charged to the Plan.

#### NOTE H - PLAN AMENDMENTS

Effective January 2023, the Plan was amended to exclude certain compensation from eligible plan compensation. The Plan also amended to change discretionary employer matching contribution frequency as well as making the Plan eligible for true up contributions of this type.

Effective September 2023, the Plan was amended to include predecessor employer service for KeHE Distribution, LLC (Note I).

Significant provisions of the Plan remain unchanged as a result of the restatement. Interested parties should refer to the Plan document for a complete description of the Plan's provisions.

#### NOTE I - PLAN MERGER AND TRANSFER ACTIVITY

Effective May 1, 2024, the Plan was merged into the Surviving Plan. Total assets of approximately \$67,134,000 (including transferred participant loans totaling approximately \$1,280,000) were merged into the Surviving Plan's trust on May 14, 2024. The participants' vested account balances in the Surviving Plan will equal the vested account balances in this Plan upon the transfer. The merger does not impact participant benefits as the benefit provisions were incorporated into the Surviving Plan. Interested parties should refer to the Surviving Plan's adoption agreement and plan document for a complete description of the plan.

#### NOTE J - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through December 5, 2024, the date that these financial statements were available to be issued. Plan management has determined that no events or transactions, other than as disclosed below, have occurred subsequent to the statement of net assets available for benefits date that require disclosure in the financial statements.

The Plan improperly distributed eight benefit payments totaling approximately \$587,000 to certain participants. In June 2024, the Plan received three benefit payments back totaling approximately \$489,000 that were previously improperly distributed. These amounts plus earnings totaling approximately \$510,700 were remitted to the Surviving Plan's trust in June 2024 and allocated to the corresponding participants.
