# Physician Support Systems, Inc. 401(k) Plan Notes to Financial Statements December 31, 2023 and 2022

## 1. Description of Plan

The following description of the Physician Support Systems, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan established effective September 1, 1996, as restated January 1, 2023. The Plan covers all employees, excluding employees covered by a collective bargaining agreement, unless the agreement requires the employees to be included under the Plan, leased employees, nonresident aliens and interns., of Physician Support Systems, Inc. (the "Company") who have completed 1 month of service. The Plan requires a participant to be employed as of year end to be eligible to receive employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Effective December 18, 2023, the Plan name changed from Administrative Resources 401(k) Plan to Physician Support Systems, Inc. 401(k) and the employer identification number transitioned to 11-3648648.

### Contributions

Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan document, for up to the maximum limits of the Internal Revenue Code ("IRC"). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company will make a safe harbor matching contribution in an amount equal to 100% of the first 3% of eligible compensation contributed by a participant excluding roth deferrals, plus an amount equal to 50% of the next 2% of eligible compensation contributed by the participant excluding roth deferrals. For the year ended December 31, 2023, employer matching contributions of \$138,776 were contributed to the Plan. The Company may also make an additional discretionary matching contribution at the end of the plan year in an amount determined by an integrated formula, as defined in the Plan agreement. There were no discretionary contributions during the year ended December 31, 2023. For the year ended December 31, 2023, there were no discretionary contributions to the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

### Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately 100% vested in their own contributions plus actual earnings thereon. Participants are also immediately vested in Company contributions made under the Safe Harbor provisions of the Plan plus actual earnings thereon. Any employer discretionary contributions are 20% vested after 2 years of credited service and continues to vest in increments of 20% until 100% vested after 6 years of credited service.

### Notes Receivable From Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined annually, is set at the prevailing interest rates, as defined. Principal and interest are paid ratably through payroll deductions.

## Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of rolled over to an individual retirement plan. In addition, the Plan allows for hardship distributions if certain criteria are met.

## Forfeited Accounts

Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees. Upon reaching the break-in-service requirement, as defined in the Plan agreement, forfeitures generated can be used to reduce the Company's contributions or to pay administrative expenses. During the year ended December 31, 2023, no forfeitures were used to reduce discretionary contributions or administrative expenses. At December 31, 2023 and 2022, there were no unallocated forfeitures available.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America ("U.S. GAAP").

### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value or net asset value ("NAV"), which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

### Payment of Benefits

Benefits are recorded when paid.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

The Plan's management evaluated events that occurred after December 31, 2023 through November 13, 2024, the date when the financial statements were available to be issued. There were no other material subsequent events that required recognition or additional disclosure in these financial statements.

**3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

*Level 1* - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2023 and 2022.

*Interest-bearing cash:* These investments are stated at cost, which approximates fair value.

*Registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common stocks:* Valued at the closing price reported on the active market on which the individual securities are traded.

The Plan's investments recorded at fair value include pooled separate accounts ("PSAs") valued at NAV as a practical expedient. In accordance with Subtopic 820-110, certain investments that are measured as NAV per share (or its equivalent) will not be classified in the fair value hierarchy. PSAs are valued at NAV which is based on the fair value of the underlying investments of the PSAs, less any liabilities. The underlying investments of the PSAs are mainly equity and fixed income securities and short-term investments. The investment strategies of the Plan's PSAs vary generally based on the investment objectives of the asset class of which they are a part. Such investment strategies include investments in fixed income securities and investments in equity securities in domestic and international markets for growth and value objectives as well as to replicate market indexes and to invest in emerging markets. The Plan had no unfunded commitments related to PSAs. The redemption of PSAs is subject to the preference of individual Plan participants and contains no restrictions on the timing of redemption.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its evaluation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Transfers to Another Plan**

Effective July 3, 2023, the assets of the employees who split from the company transferred to the Chaparral Medical Group, Inc. 401(k) Plan. The total amount of \$1,082,486 is reflected in transfer to another plan on the statement of changes in net assets available for benefits.

**5. Related-Party and Party-in-Interest Transactions**

The Company, which qualifies as a party in interest, absorbs certain administrative expenses of the Plan. Such transactions qualify for a statutory exemption. Fidelity Management Trust Company is a party in interest due to its managing of funds that the plan participates in. Additionally, notes receivable from participants are considered party-in-interest transactions.

**6. Information Certified by Trustee**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2023 and 2022. On January 1, 2023, the Company changed trustees from John Hancock Life Insurance Company to Fidelity Trust Company. Accordingly, Fidelity Management Trust Company, the current Trustee of the Plan, has certified the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statement of net assets available for benefits and the supplemental Schedule H, Part IV, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2023, and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the period from January 1, 2023 through December 31, 2023.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**8. Tax Status**

The Plan adopted a pre-approved plan offered by FMR LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**10. Delinquent Participant Contributions**

For the Plan year ended December 31, 2021, the Company failed to remit to the Plan certain employee contributions and loan repayments totaling \$74,541 within the period prescribed by Department of Labor regulations. Delays in remitting contributions to the Plan were due to administrative errors. The Company is in the process of rectifying the lost earnings on the employee contributions and loan repayments that were remitted late.

For the Plan year ended December 31, 2022, the Company failed to remit to the Plan certain employee contributions and loan repayments totaling \$133,928 within the period prescribed by Department of Labor regulations. Delays in remitting contributions to the Plan were due to administrative errors. The Company is in the process of rectifying the lost earnings on the employee contributions and loan repayments that were remitted late.

For the Plan year ended December 31, 2023, the Company failed to remit to the Plan certain employee contributions and loan repayments totaling \$117,339 within the period prescribed by Department of Labor regulations. Delays in remitting contributions to the Plan were due to administrative errors. The Company is in the process of rectifying the lost earnings on the employee contributions and loan repayments that were remitted late.
