## INDEPENDENT AUDITORS' REPORT

Plan Administrator  
Winston/Hamilton Home Builders 401(k) Plan  
Double Springs, Alabama

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Winston/Hamilton Home Builders 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 29, 2024 (in liquidation) and December 31, 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the period ended February 29, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Winston/Hamilton Home Builders 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of February 29, 2024 and December 31, 2023, and for the period ended February 29, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Winston/Hamilton Home Builders 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of a Matter – Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note 1 to the financial statements, during October 2023 the Plan's sponsor approved the termination of the Plan with an effective date of October 13, 2023. Plan management liquidated the remaining assets and settled the liabilities of the Plan during the 2024 plan year. In accordance with accounting principles generally accepted in the United States of America, the Plan's basis of accounting was changed to the liquidation basis in presenting the financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance

and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Winston/Hamilton Home Builders 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedules Required by ERISA**

The supplemental schedules of Assets Held for Investment Purposes at End of Year and Delinquent Participant Contributions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the

supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA

In our opinion—

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

WINSTON/HAMILTON HOME BUILDERS 401(K) PLAN

February 29, 2024

NOTE 1. DESCRIPTION OF PLAN

The following brief description of Winston/Hamilton Home Builders 401(k) Plan is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

- A. *General.* The Plan is a defined contribution plan covering substantially all employees of Winston Housing Group, LLC, Hamilton Home Builders, LLC and Platinum Homes, LLC (the “Company”) who have met certain service and eligibility requirements. The Plan was amended on October 12, 2023 to terminate the plan effective as of October 13, 2023. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. *Contributions.* Each year, participants may contribute up to the maximum percentage allowable, not to exceed the limits of Code Sections 401(k), 404 and 415 of the Internal Revenue Code. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at an initial rate of 4 percent of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. The employer makes a matching contribution of 100% of the first 4% of compensation that a participant contributes to the Plan. Employer profit sharing contributions are discretionary and are also subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.
- C. *Participant Accounts.* Each participant’s account is credited with the participant’s contribution, the employer matching contributions, employer profit sharing contributions and plan earnings. Each participant’s account is also charged with an allocation of administration expenses, when applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- D. *Vesting.* Participants were immediately 100% vested in salary deferral contributions, qualified matching contributions, qualified nonelective contributions, and actual earnings thereon. Prior to the approval of the termination of the Plan, described in Note 1, vesting in the Company’s discretionary contribution portion of their accounts plus actual earnings thereon was based on years of continuous service. A participant was 100% vested after six years of credited service. On the effective date of the Plan termination, participant contributions from all sources became 100% vested.
- E. *Investment Options.* Upon enrollment in the Plan, a participant directs the investment of their contributions into various investment options offered by the Plan.
- F. *Payment of Benefits.* Upon normal retirement age 65, death or disability, if earlier, retirement or termination of employment, the participant’s vested benefits are paid to the participant or his or her beneficiary in the form of a lump-sum distribution, or installments over a term certain not to extend beyond the life expectancy of the participant or his or her beneficiary. Participants may borrow against the vested balance in their accounts.

NOTES TO FINANCIAL STATEMENTS - (Continued)

NOTE 1. DESCRIPTION OF PLAN - (Continued)

- G. *Participant Loans Receivable.* Participants may borrow from their fund accounts a minimum of \$ 1,000 up to a maximum equal to \$ 50,000 or 50% of their vested account balance, whichever is less. These loans are secured by the balance in the participant's account and bear interest at a reasonable rate on the date of issue. Principal and interest are repaid through payroll deductions.
- H. *Forfeited Accounts.* There were no forfeited non-vested accounts at February 29, 2024 or December 31, 2023.
- I. *Plan Termination.* During 2023, the Plan Sponsor approved the termination of the Plan in a standard termination, effective October 13, 2023. Under the liquidation basis of accounting as described in Note 2, the Plan accrued income expected to be received and administrative costs expected to be incurred through the end of its liquidation. As such, the Plan recorded accrued earnings and dividends of \$22,734 and accrued expenses of \$41,965 as of December 31, 2023. All Plan obligations were fully distributed on February 29, 2024

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- A. *Basis of Accounting.* The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America. As a result of the Plan termination, approved on October 12, 2023 and effective October 13, 2023, the liquidation basis of accounting was used for the period ending February 29, 2024 and the year ending December 31, 2023 as the formal termination was considered imminent.
- B. *Investment Valuation and Income Recognition.* The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.
- C. *Payment of Benefits.* Benefits are recorded when paid.
- D. *Expenses.* Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.
- E. *Estimates.* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTES TO FINANCIAL STATEMENTS - (Continued)

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES- (Continued)

- F. *Notes receivable from participants.* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of February 29, 2024 or December 31, 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default in accordance with the Plan's Loan Policy, the participant loan balance is reduced, and a benefit payment is recorded.
- G. *Subsequent Events.* In preparing these financial statements, the Company has evaluated events and transactions for potential recognition or disclosure through the date of the Independent Auditors' Report, which is the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 and the methodologies used for assets measured at fair value are described as follows:

*Level 1.* Fair value inputs include unadjusted quoted prices in active markets for identical assets or liabilities and have the highest priority. The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The fair value of pooled separate accounts is based on net asset value which is the basis for current transactions and redemptions.

*Level 2.* Fair value inputs include significant other observable inputs other than Level 1 inputs such as quoted prices for similar assets, quoted prices in markets that are not active or other observable inputs that can be corroborated by observable market data. There were no Plan investments valued using Level 2 inputs.

*Level 3.* Fair value inputs include unobservable inputs that are supported by little or no market activity such as pricing models, discounted cash flow methodologies or similar techniques. Level 3 inputs have the lowest priority. There were no Plan investments valued using Level 3 inputs.

## NOTE 4. CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and participant loans receivable held at February 29, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on participant loans receivable from participants for the period ended February 29, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company and Principal Life Insurance Company, the custodian of the Plan.

## NOTE 5. FEDERAL INCOME TAX STATUS

The Company adopted a prototype non-standardized profit sharing and 401(k) plan. The prototype plan sponsor is Principal Life Insurance Company. The Company is relying on the opinion letter as obtained and updated by the sponsor and has not applied for an individual determination letter. The Company believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that therefore the plan qualifies under the section 401(a) and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the plan's financial statements.

The Plan's Form 5500 information returns are subject to examination by the Department of Labor generally for three years after they are filed. Management has evaluated the tax positions taken and has not identified any positions that are not more likely than not to be sustained upon examination.

## NOTE 6. RISKS AND UNCERTANTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTES TO FINANCIAL STATEMENTS - (Continued)

**NOTE 7. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Principal Trust Company and Principal Life Insurance Company. Principal Trust Company and Principal Life Insurance Company is the custodian, as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan made direct payments to the third party administrator of \$41,965 in 2024, which were not covered by revenue sharing. The Plan sponsor pays directly any other fees related to the plan's operations.

**NOTE 8. GUARANTEED INVESTMENT CONTRACTS**

The Plan holds a portfolio of investment contracts that comprises a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment. The contract issuer (Principal Trust Company) is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a monthly basis for resetting.

The Plan's ability to receive amounts due is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with Principal Trust Company. Examples of such events include the following:

1. Plan termination or merger.
2. Plan amendments or operation of the Plan in a manner which is unacceptable to issuer.
3. The Plan fails to qualify or becomes disqualified under Code section 401(a).
4. Total amount of contributions received in the preceding 12 months is less than \$25,000.
5. The sum of all Participant Annuity Account Values falls below \$25,000.
6. Premature termination of the contract.

The Plans considers that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.
