## INDEPENDENT AUDITORS' REPORT

To the Trustees and Administrators of the Nuvalence, LLC 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audit of the financial statements of the Nuvalence, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of September 18, 2024, the related statement of changes in net assets available for benefits for the year ended September 18, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Nuvalence, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period ended September 18, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Nuvalence, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Plan became effective January 1, 2020, and restated January 1, 2022, as a retirement savings plan for qualified employees of Nuvalence, LLC (the Company or Sponsor). The Plan is a defined contribution plan covering all eligible employees of the Sponsor who are 21 years of age, excluding union, leased and non-resident aliens. The Plan also includes a provision that employees are automatically enrolled at a 3% contribution rate unless they specify otherwise. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On April 26, 2024, The Company entered into an Asset Purchase Agreement with Ernst & Young U.S. LLP (EY) whereby EY purchased substantially all the assets of The Company. Employees of The Company were terminated by The Company and extended offers of employment by EY. Plan Participants rolled Plan balances into either the EY 401k plan or a retirement account of their choosing.

**Contributions** – Participants are permitted to contribute up to 92% of their annual compensation on a pre-tax or after-tax basis, as defined by the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions up to the annual limit determined by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified retirement plans and may direct the investment of their contributions into various options offered by the Plan. The Company also makes a safe harbor nonelective match of 3% of compensation and may make discretionary contributions.

**Participants' Accounts** – Each participant's account is credited with the participant's contribution and Plan earnings. The accounts are set up in participant-directed, individual accounts administered by the plan custodian. Contributions and earnings or losses are credited to the accounts as the amounts are received by the custodian. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting** – Participants are immediately 100% vested in all participant contributions plus actual earnings thereon. The employee's interest in any Company profit sharing contributions will vest based on years of vesting service, vesting at 20% for each year of service.

**Investment Options** – Participants direct the investment of their contributions into selected investment products offered by the Plan custodian. The investment options include fixed income accounts and various income, growth, value, blend, and international mutual fund accounts. Participants may change their investment options daily.

**Payment of Benefits** – Benefits are payable to participants or designated beneficiaries upon retirement, death, disability, or termination of employment, and are entitled to receive a lump-sum amount equal to the value of the participant's vested interest in their account.

Benefits may also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

**Forfeitures** – If employment with the Company is terminated, the employee receives a distribution of the entire vested portion of the account but forfeits the non-vested portion. Forfeited non-vested accounts totaled \$0 and \$3,313 at September 18, 2024 and December 31, 2023. Forfeitures can be used to offset plan expenses.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** – The financial statements are prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America. The Plan follows accounting principles set forth in FASB Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

**Use of Estimates in the Preparation of Financial Statements** – The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Receivables/Allowance for Doubtful Accounts** – The Plan estimates its allowance for doubtful accounts based on historical experience with doubtful receivables. The Plan has not experienced bad debts since inception, and accordingly has not estimated an allowance for doubtful accounts.

**Investment Valuation and Income Recognition** – In accordance with FASB ASC 962, the Plan's investments are stated at fair value except for its investment in the fully benefit responsive investment contract, which is valued at contract value. Recent amendments to ASC 962, designate contract value as the only required measure for fully benefit-responsive investment contracts, and eliminate fair value measurement and certain disclosures.

Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

During the period ended September 18, 2024, the Plan's investments, including net gains and losses on investments sold during the year, increased in fair value by \$512,061. All investments are participant directed.

**Plan Administration Costs** – Administrative expenses of maintaining the Plan may be paid by the Company or the Plan, as provided by the Plan document. Expenses that are paid directly by the Sponsor are excluded from these financial statements. Certain administration fees are charged directly to the participant’s account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

**Payment of benefits** – Benefits are recorded when paid.

**Subsequent Events** – Management has evaluated, for potential recognition or disclosure in the financial statements, subsequent events that have occurred through December 10, 2024, which is the date that the financial statements were available to be issued.

**NOTE 3 – INFORMATION CERTIFICATION**

The Plan Administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C). As permitted under such election, no independent auditing procedures were performed with respect to the information certified as complete and accurate by the Plan’s trustee, Empower Trust Company, LLC (Empower). Empower has certified its statement of accounts as of and for the periods ended September 18, 2024, and December 31, 2023. The statement of accounts includes beginning and ending balances of investments held, notes receivable from participants, and detail of transactions during the period, including investment earnings and interest income on notes receivable from participants.

**NOTE 4 – INCOME TAX STATUS**

The Plan has adopted a prototype format and is relying on the prototype sponsor’s IRS determination letter for qualification. In the prototype sponsor’s tax determination letter dated June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 18, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

#### NOTE 5 – FAIR VALUE MEASUREMENTS

Fair value accounting guidance establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plans have the ability to access.
- Level 2** Inputs to the valuation methodology other than quoted prices included in Level 1 are observable for the asset or liability, each directly or indirectly, and include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at September 18, 2024. The methods described above could produce a fair value calculation that is not indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan administrator believes these valuation methods are appropriate, the use of different methodologies or assumptions could result in different fair value measurements at the reporting date.

Below is a description of the valuation methodologies used for assets measured at fair value.

**Registered investment company funds** – Valued at the daily closing price as reported by the fund, these funds held by the Plan are registered with the SEC, must publish their NAV and transact at that price, and are deemed to be actively traded.

**NOTE 6 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the plan custodian as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.
