We have performed audits of the financial statements of LRS Healthcare 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of May 31, 2024 and December 31, 2023 and the related statement of changes in net assets available for benefits in liquidation for the period from January 1, 2024 to May 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 31, 2024 and December 31, 2023 and for the period from January 1, 2024 to May 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

As discussed in Note 1 to the financial statements, the Retirement Committee of LRS Healthcare, the Plan's Sponsor, voted to terminate the Plan effective December 31, 2023. As a result, the Plan reported on a liquidation basis of accounting as of May 31, 2024 and December 31, 2023, and for the period from January 1, 2024 to May 31, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. Plan Description

The following brief description of the LRS Healthcare 401(k) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and Plan Termination

The Plan was established as a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Lawrence Recruiting Specialists Inc. (the Company).

The Retirement Committee of the Plan Sponsor voted to terminate the Plan effective December 31, 2023. As a result, management determined liquidation was imminent in 2023. Upon Plan termination, all participants became fully vested and Plan assets were allocated to each participant's account. Effective January 1, 2024, participants began participating in either the Jackson Healthcare 401(k) Savings Plan or the Jackson Partners 401(k) Plan. Participants had the following options related to the vested portion of their accounts in the Plan: 1) participants could elect to rollover their balance to either the Jackson Healthcare 401(k) Savings Plan or the Jackson Partners 401(k) Plan; 2) participants could elect to rollover their balances to an individual retirement account of their choosing; or 3) participants could elect to receive a lump sum distribution, subject to applicable taxes. The final liquidation payments were paid in May 2024 and the Plan was fully terminated.

Prior to December 31, 2023, employees were eligible to make pre-tax and designated after-tax Roth salary deferral contributions after completion of three months of service. Employees were eligible to receive Company safe harbor matching contributions and Company discretionary profit-sharing contributions after completing one year of service with at least 1,000 hours. In order to share in the allocation of discretionary profit-sharing contributions, a participant was required to be employed by the Company on the last day of the Plan year or complete at least 1,000 hours of service during the Plan year. This condition did not apply to participants who were deceased, became disabled or had retired after meeting normal retirement age of 65 during the Plan year. Employees were not eligible to participate in the Plan after December 31, 2023.

Contributions

Prior to December 31, 2023, participants could make voluntary salary deferral contributions up to the maximum dollar amounts allowable by law. Participants could also contribute amounts representing distributions from other qualified plans. Company safe harbor matching contributions were made in an amount equal to 100% of the amount of the participant's elective deferrals up to 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals greater than 3% and up to 5% of the participant's compensation. The Company could also make discretionary profit-sharing contributions. No discretionary profit-sharing contributions were made during the period from January 1, 2024 to May 31, 2024. All participants who were eligible to make deferral contributions and who were projected to attain age 50 before the close of the calendar year were eligible to make catch-up contributions. Contributions were subject to certain limitations. No contributions were allowed into the Plan after December 31, 2023.

Participant Accounts

Each participant's account was credited with the participant's contributions and allocations of a) the Company's safe harbor matching contributions b) the Company's discretionary profit-sharing contributions and c) Plan earnings or losses. The Company's safe harbor matching contributions were allocated among participants based upon each eligible participant's elected salary deferral. The Company's discretionary profit-sharing contributions were allocated among participants using a comparability formula in an amount designated by the Company to be allocated to each group. Plan earnings or losses were allocated on the basis of actual results of investments held in participant accounts. Investments were maintained in individual member accounts managed by Massachusetts Mutual Life Insurance Company and Empower Trust Company, LLC, both subsidiaries of Empower Annuity Insurance Company of America (Empower).

Vesting

As a result of the decision to terminate the Plan during 2023, all participants became fully vested in their account balances.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary could receive a single lump sum payment equal to the value of the vested funds allocated to the participant's account. The Plan required that distribution payments between \$1,000 and \$5,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant did not elect otherwise. Distributions under \$1,000 were paid out to the participant in the event the participant did not elect otherwise. Participants could also receive in-service and hardship distributions, as permitted in the Plan document. Benefits were recorded when paid.

Deposits with Insurance Company

The guaranteed interest accounts, which are part of an investment contract, credit interest daily.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of the Company's contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used in any permissible method, which includes paying administrative expenses, reducing the Company's contributions, or reallocating to participants. There were no forfeited non-vested accounts at May 31, 2024 and December 31, 2023.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

Due to the decision to terminate the Plan during 2023, management determined that liquidation of the Plan was imminent and, accordingly, the financial statements have been prepared using the liquidation basis of accounting as required under Financial Accounting standards Board ASC 205-30-25.

Under the liquidation basis of accounting, the Plan recognized all income and expenses it expected to incur to liquidate the Plan during the year ended December 31, 2023. The Plan settled its payments to Plan participants, in accordance with their election, by liquidating the remaining investments. The final liquidation payments from the Plan occurred during the period from January 1, 2024 to May 31, 2024. All investments were measured at liquidation value as of December 31, 2023, which approximated fair value and contract value.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments, except for fully benefit-responsive investment contracts, were reported at fair value, which represents liquidation value. Fair value was the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion on fair value measurements.

Fully benefit-responsive investment contracts were reported at contract value, which approximates liquidation value. Contract value was the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invested in investment contracts through a guaranteed interest account.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Net appreciation included the Plan’s gains on investments bought and sold as well as held during the year.

Other

Audit fees were paid by the Company and are excluded from these financial statements. Certain investment management and recordkeeping expenses were paid by the Company or the Plan. Other expenses, specifically incurred or attributable to individual participants, were paid from the applicable participants’ accounts and are included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits in liquidation date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through December 9, 2024, noting no items requiring disclosure.

3. Information Certified by Empower

The plan administrator elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Empower except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
 - If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023. There were no Plan investments as of May 31, 2024.

Pooled Separate Accounts: Valued at the net asset value (NAV) of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per share to estimate the fair value as a practical expedient as long as certain requirements are met. It is the Plan's assessment that these accounts meet those requirements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no Plan investments as of May 31, 2024.

5. Investment Contract with Insurance Company

The Plan had entered into an investment contract with Empower. Empower maintained the contributions in pooled separate accounts and a guaranteed interest account. The accounts were credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Empower.

The pooled separate accounts, as reported to the Plan by Empower, were included in the financial statements at fair value, which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses.

As the guaranteed interest account was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account. Contract value, as reported to the Plan by Empower, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic developments. No events were probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

6. Tax Status

The Plan was a qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and was exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator analyzed the tax positions taken by the Plan and concluded that there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Related-Party Transactions

Certain Plan investments were pooled into separate accounts and a guaranteed interest account managed by Empower, through its subsidiaries Massachusetts Mutual Life Insurance Company and Empower Trust Company, LLC.
