Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Marymount Health Care Systems Affiliates 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits in liquidation as of February 16, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits in liquidation for the period January 1, 2024 through February 16, 2024 and year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Marymount Health Care Systems Affiliates 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of February 16, 2024 and December 31, 2023, and for the period January 1, 2024 through February 16, 2024 and year ended December 31, 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Marymount Health Care Systems Affiliates 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Basis of Accounting

As discussed in Note 2 to the financial statements, the governing body of Marymount Health Care Systems Affiliates 401(k) Plan approved a plan of liquidation on October 9, 2023, and management determined liquidation was imminent. As a result, the Plan changed its basis of accounting to the liquidation basis. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Marymount Health Care Systems Affiliates 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. NOTES TO FINANCIAL STATEMENTS

PERIOD JANUARY 1, 2024 THROUGH FEBRUARY 16, 2024 AND YEAR ENDED DECEMBER 31, 2023

1. Description of Plan:

General:

The following brief description of Marymount Health Care Systems Affiliates 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan was a defined contribution plan covering all full-time employees of Marymount Health Care Systems (the "Company" and the "Plan Sponsor") who completed two months of service and are age 21 or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees was responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Board of Trustees of the Plan Sponsor approved to terminate the Plan effective October 9, 2023 and the final distribution for the plan was completed on February 16, 2024. (Note 10).

Contributions:

The Plan provided for employee salary 401(k) contributions up to a maximum of 100% of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code (IRC). Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

There were no discretionary employer matching contribution during the period January 1, 2024 through February 16, 2024. During 2023, the Plan provided a discretionary employer matching contribution, which was 50% of the first 6% of compensation deferred by the participant. Additionally, the Company had the ability to make discretionary profit sharing contributions, as determined by the Company's Board of Trustees. No discretionary profit sharing contributions were made in 2024 or 2023.

Participant accounts:

Each participant's account was credited with employer and participant contributions. Plan earnings and losses were allocated based upon account balances.

Vesting:

Participants were 100% vested immediately with respect to their compensation deferrals. Participants became 100% vested in discretionary employer matching and discretionary profit sharing contributions due to the plan termination (Note 10)

1. Description of Plan (continued):

Other:

Income/loss was allocated to participant accounts based on earnings/losses in the respective investment accounts.

Forfeitures of nonvested accounts were held by the Mutual of Omaha, custodian of the Plan, and could be used to pay plan expenses and reduce employer contributions. Forfeitures of \$7,783 in 2024 and \$4,878 in 2023 were used for plan expenses. At February 16, 2024 and December 31, 2023, there were no amounts and \$7,774, respectively, of forfeited amounts.

The Plan was administered by the custodian who was appointed by the Company.

Payment of benefits:

Participants could elect to withdraw all or a specified portion of their contributions prior to their termination of employment subject to certain restrictions under the Plan. If participants suffered serious financial hardship, as defined by the Plan, they could withdraw any portion of their vested account in order to meet their financial needs. Participants could withdraw from their account when reaching the normal retirement age of 65. All accounts were subject to distribution upon the participant's termination, retirement, total disability or death. On termination of service, participants could elect to receive a lump sum amount equal to the vested value of their account.

Benefits were recorded when paid.

Investment options:

Upon enrollment in the Plan, a participant could direct employee contributions, including the employer's matching and discretionary contributions, into a number of investment options. Participants could change their investment elections daily.

The Plan had a qualified default investment alternative (QDIA) if a participant did not provide investment directions. A participant could transfer funds out of the QDIA into other available investment alternatives at any time without restrictions, surrender charges, liquidation or exchange fees or similar expenses within the first 90 days after being invested in the QDIA. The Plan's QDIA was the target date fund series known as the State Street Retirement Right funds.

1. Description of Plan (continued):

Participant notes:

Participants could borrow from their accounts. The minimum participant note was \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of the participant balance. These transactions were treated as transfers between investment funds and the participant notes fund. Repayment of a participant note had to be made over a period not to exceed five years, unless the participant note is used to purchase a principal residence, in which case the participant note was to be repaid over a reasonable period of time that may have exceeded five years. Participant notes were secured by the balance in the participant's account and with interest at market rate. Principal and interest were paid through payroll deductions and interest is included in interest on participant notes on the statements of changes in net assets available for benefits in liquidation. Interest rates on these notes were between 5.25% and 10.00% at December 31, 2023 through February 16, 2024, when all outstanding loans were distributed as part of the plan termination (Note 10).

Participant notes were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and expensed when they were incurred. No allowance for credit losses was recorded as of December 31, 2023. If a participant ceased to make note repayments and the plan administrator deemed the participant note to be in default, the participant note balance was reduced and a benefit payment was recorded.

2. Summary of significant accounting policies:

Basis of accounting:

As a result of the Board of Trustees of the Plan Sponsor decision to terminate the Plan effective October 9, 2023, the liquidation basis of accounting was used in presenting the statement of net assets in liquidation and the statement of changes in net assets in liquidation as of and for the period January 1, 2024 through February 16, 2024 and year ended December 31, 2023.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates and assumptions.

Investment valuation and income/loss recognition:

There were no investments held by the Plan as of February 16, 2024. At December 31, 2023, the Plan maintained investments with United of Omaha Life Insurance Company dba Mutual of Omaha for the guaranteed interest accounts and the pooled separate accounts. The guaranteed interest accounts are the insurance company's guarantee backed by the underwriting insurance company's general asset account. The pooled separate accounts are an insurance company's separate account maintained by the insurance company that invests in the underlying mutual funds.

4. Fair value (continued):

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual of Omaha calculates unit value for each separate account investment based on the underlying assets, which include a mix of mutual funds, collective trusts and managed accounts. All underlying investment options are valued daily. This daily price is considered the selling price for transfers and withdrawals and is calculated each day the principal market is open. The investment options are available for trading each day the principal market is open, and are available to any participant in the plan, unless restricted by the plan administrator.

5. Investment contracts with insurance company:

The Plan participated in fully benefit-responsive investment contracts with Mutual of Omaha. Mutual of Omaha maintained the contributions in a separate account. The accounts were credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. Contract value, as reported to the Plan by Mutual of Omaha, represented contributions made under contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contracts issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest accounts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits in liquidation attributable to the guaranteed interest accounts contracts.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limited the Plan’s ability to transact at contract value with Mutual of Omaha. Such events include the following (a) amendments to the plan documents (including complete or partial termination or merger with another plan), (b) changes to plan’s prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with plan participants, is probable.

5. **Investment contracts with insurance company (continued):**

The guaranteed interest accounts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The weighted average interest rates for the guaranteed investment contract was 5.2706% in 2023, and for the lifetime guaranteed income account was 5.5737% in 2023.

6. **Administrative expenses:**

Certain administrative expenses of the Plan were paid by the Company. Certain administrative functions were performed by employees of the Company. Neither any such employee, nor the Company, received compensation from the Plan for these functions.

7. **Party-in-interest transactions:**

The Plan investments are managed by affiliates of Mutual of Omaha. Mutual of Omaha is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Certain fees related to the administration of the Plan were paid by the Plan or the Plan Sponsor, which qualify as party-in-interest transactions. The Plan issues notes to participants, which are secured by the vested balance in the participant's account and certain fees related to the administration of the Plan were paid by the Plan or the Plan Sponsor, which also qualify as party-in-interest.

8. **Information certified by custodian:**

Certain information related to investments and participant notes disclosed in the accompanying financial statements and supplemental schedule, including investments and participants notes held at December 31, 2023, and net increase in value of investments and interest and dividends for the period January 1, 2024 through February 16, 2024 and year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mutual of Omaha.

9. **Income tax status:**

The Internal Revenue Service (IRS) on June 27, 2014 has determined that the prototype plan under which Marymount Health Care Systems Affiliates 401(k) Plan is organized is designed in accordance with applicable sections of the IRC. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes the Plan is being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is exempt from taxation.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and the DOL. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Plan termination:

The Company had the right at any time within its sole discretion to reduce, suspend or discontinue contributions to the Plan or to terminate the Plan subject to the provisions of ERISA. The Board of Trustees of the Plan Sponsor elected to terminate the Plan effective October 9, 2023. Final distributions were determined on all participants being 100% vested. The final distribution was made on February 16, 2024. In accordance with U.S. GAAP, the Plan changed its basis of accounting from the ongoing plan basis to the liquidation basis in 2024 and 2032.

11. Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participant account balances and the amounts reported in the statements of net assets available for benefits in liquidation.

12. Subsequent events:

In preparing these financial statements, the Plan's management has evaluated events and transactions for potential recognition or disclosure through December 11, 2024, the date the Plan's financial statements were available to be issued.
