INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Plan Participants
Line Quest 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Line Quest 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of April 10, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through April 10, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Line Quest 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period from January 1, 2023 through April 10, 2023 and year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Line Quest 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the financial Statements

NOTE 1: DESCRIPTION OF THE PLAN

General

The Line Quest 401(k) Plan (the "Plan") is a defined contribution plan covering all the eligible employees of Line Quest, LLC (the "Company", or "Plan Sponsor"). The Plan was a qualified plan as defined by Section 401(a) of the Internal Revenue Code and contains a provision for salary reduction contributions under Section 401(k) of the Internal Revenue Code. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

On August 16, 2022, plan management approved the merger of the Plan into the GridHawk 401k plan ("GridHawk"). Effective April 10, 2023, the Plan merged with Gridhawk and all plan assets were transferred.

Eligibility

Prior to the merger, non-excluded employees who have reached the age of 18 years of age are eligible to participate in the Plan. Participants are eligible to enroll in the Plan on the first pay period in the month after satisfying eligibility requirements of 60 days of service. Each employee will be automatically enrolled in the Plan at a two percent pre-tax contribution rate.

Contributions

Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 2% of eligible compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant. There were no employee contributions in the current year.

The Company may make a discretionary matching contribution in an amount equal to a percentage of each participant's elective contribution or a discretionary dollar amount. The Company matched employee contributions up to 4% of each participant's eligible compensation on a pay period basis. The Company may also make a discretionary profit-sharing contribution for participants employed on the last day of the plan year. There was no discretionary profit-sharing contribution made to the Plan in 2023.

Contributions are subject to certain statutory limitations.

NOTE 1: DESCRIPTION OF THE PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions, rollovers, income or loss, less expenses. Income or loss for each of the investment choices is allocated to the participants' accounts on a daily basis and is based on the relative units of participation. Benefits paid to participants under the Plan are limited to the vested balance in each participant's account.

Vesting and Payment of Benefits

All participants are immediately vested in their contributions, rollovers, and Plan earnings and losses. Prior to the merger, Company contributions vested according to the following schedule:

0-1 Years	0%
1-2 Years	33%
2-3 Years	67%
3 Years and Over	100%

Normal retirement age under the Plan is 65. During employment, vested benefits may be paid from the Plan under hardship provisions for a minimum of \$500, or to electing participants that have attained the age of 59½. Upon a participant's termination, mandatory automatic distributions are made for participant balances less than \$5,000. If death or permanent disability occurs during employment, an employee's entire account becomes fully vested. Certain minimum distributions are required for inactive employees who have reached the age of 70½ to meet the minimum distribution requirements of the Internal Revenue Code regulations. Separating participants may elect to rollover their account into another plan, as permitted by Internal Revenue Service regulations.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable are secured by the participant's account and are valued at amortized cost, which approximates fair value. Principal and interest payments are made ratably through payroll deductions. Participants may only have one active loan outstanding at a time.

Forfeitures

Forfeitures of unvested balances are used to reduce Company contributions to the Plan or to pay Plan expenses. Forfeitures used to pay plan expenses totaled \$2,659 in 2023. No forfeitures were used to reduce the Companies' contributions or allocated during 2023. Forfeitures were ratably allocated to participants during the plan merger. The forfeitures balance was \$0 and \$108,930 at April 10, 2023 and December 31, 2022, respectively.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of additions and expenses during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Distributions to participants are recorded when paid.

Administrative fees

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants, withdrawals, and certain investment transaction fees are charged directly to the participant's account and are included in administrative fees. Other investment-related expenses are included in net appreciation in fair value of investments.

NOTE 3: TAX STATUS

The Plan is an adoption of a volume submitter arrangement designed by Nova Associates, Inc., which received a determination letter dated March 31, 2014 from the Internal Revenue Service (IRS) that qualified the volume submitter arrangement as tax-exempt under the appropriate section of the Internal Revenue Code (IRC). Under Internal Revenue Service Announcement 2001-77, when such providers receive a favorable determination letter from the Internal Service Revue regarding the qualification of the Plan document for tax exempt status, an adopting Plan may rely on this opinion letter. The Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 4: ADMINISTRATION AND INVESTMENTS

Administration

All the Plan's investments are administered by TransAmerica Financial Life Insurance Company, Inc. ("TransAmerica"). Among other duties, TransAmerica receives contributions, invests and reinvests the Plan's assets, collects income, and makes distributions from the Plan's assets as directed by the Plan Sponsor.

Investments

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, TransAmerica certified that the accompanying investment balances and income information for the period from January 1, 2023 through April 10, 2023 and year ended December 31, 2022 was complete and accurate. Accordingly, the Plan's independent auditors did not perform any procedures with respect to this information, except comparing and reconciling such information to the financial statements.

NOTE 5: FAIR VALUE MEASUREMENTS

FASB ASC 820-10 provides standards and disclosures for assets and liabilities that are measured and reported at fair value. As defined in FASB ASC 820-10, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). FASB ASC 820-10 requires disclosure that establishes a framework for measuring fair value and expands disclosure about fair value measurements.

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market for the asset or liability is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

These inputs include: a) quoted prices for similar asset or liabilities in active markets b) quoted prices for identical or similar assets or liabilities in markets that are not active c) inputs other than quoted market prices that are observable and d) inputs that are derived primarily from or corroborated by observable market data by correlation or other means.

Level 3: Measured based on unobservable inputs for the asset or liability for which there is little, if any, market activity for the asset or liability at the measurement date. This input includes management's own assumptions about the assumptions that market participants would use in pricing the asset or liability. The inputs are developed based on the best information available in the circumstances, which might include management's own data.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of April 10, 2023 and December 31, 2022.

Pooled Separate Accounts: The fair value of these mutual funds is a publicly quoted pricing input used in determining the NAV of the pooled separate account, which is not publicly quoted. Pooled separate accounts are valued at the NAV or equivalent based on units of the pooled separate accounts. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. The funds are valued daily.

As required by FASB ASC 820-10, financial assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement. The Company's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of the fair value of assets and liabilities and their placement within the fair value hierarchy levels.

NOTE 6: RELATED PARTY TRANSACTIONS

The Plan invests in investments that are managed by TransAmerica, who is also the custodian for the Plan. During the period from January 1, 2023 through April 10, 2023 and the year ended December 31, 2022, the Plan paid TransAmerica \$7,166 and \$25,239, respectively, in administration expenses that are included in administrative fees. The Plan believes the fees charged by TransAmerica's mutual funds and its administrative fees are no different than those that would be charged by other companies engaged in managing pension assets.

NOTE 7: RISKS AND UNCERTAINTIES

Plan participants make choices regarding their investments securities, and are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that reduction in value can occur in the near term and that such changes could materially affect participant account balances reported in the statement of net assets available for benefits.

NOTE 8: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, each participant's account balance becomes 100% vested.

NOTE 9: INCOME TAX STATUS

The Plan did not have unrecognized tax benefits as of April 10, 2023 and December 31, 2022 and does not expect this to change significantly over the next twelve months. The Plan will recognize interest and penalties accrued on any unrecognized tax benefits as a component of income tax expense. As of April 10, 2023 and December 31, 2022, the Plan has not accrued interest or penalties related to uncertain tax positions.
