## Independent Auditors' Report

To the Retirement Committee of the  
TBC Retail 401(k) Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the TBC Retail 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation as of February 29, 2024 and December 31, 2023, the related statements of changes in net assets in liquidation for the period ended February 29, 2024 and year ended December 31, 2023 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of February 29, 2024 and December 31, 2023, and for the period ended February 29, 2024 and year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management has determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter - Basis of Accounting***

As discussed in Note 1 to the financial statements, the governing body of the Plan approved a plan of liquidation on June 1, 2023, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting to the liquidation basis used in presenting the 2024 and 2023 financial statements. Our opinion is not modified with respect to that matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

## Notes to the Financial Statements

February 29, 2024 and December 31, 2023

### (1) Description of plan

The following description of the TBC Retail 401(k) Plan (the "Plan"), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

In connection with the sale of the Plan Sponsor to Mavis Tire Supply, LLC on June 1, 2023, the decision was made to terminate the plan effective June 1, 2023. The Plan transferred certain net assets to the Mavis Tire Supply, LLC 401(k) Plan and rolled over certain net assets directly to participants during June 2023. As of February 29, 2024, all participant assets were distributed.

#### (a) General

The Plan was a defined contribution plan which was adopted on March 3, 1963 to provide retirement benefits for employees of TBC Retail Group, Inc. ("the Plan Sponsor") and its affiliates (collectively the "Participating Employers"). The Plan covered substantially all full-time employees who were age twenty-one or older and had completed three months of service ("participants"). The Plan's adoption agreement and subsequent amendments detailed specific excluded employees of some of the Plan's Participating Employers. Participants should refer to the Plan agreement for a more complete description of eligibility requirements. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### (b) Contributions

Prior to June 1, 2023, participants could voluntarily make qualified retirement contributions to the Plan which were deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). Participants could have also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans. In order to participate, employees must have made a minimum contribution of 1% of compensation not to exceed 85% of compensation. There were no participant contributions after June 1, 2023.

Employees were automatically enrolled in the Plan at a deferral rate of 1% of their compensation unless the employee elected not to participate or chose a different percentage to defer.

The Plan provided that the Participating Employers may have made a matching contribution to participants who elected to make salary deferral contributions to the Plan as determined annually by the Plan Sponsor. Until June 1, 2023, the Participating Employers matched an amount equal to 50% of each participant's contributions up to 4% of eligible compensation. Participating Employer and participant contributions could not exceed the maximum amount deductible for federal income tax purposes. There were no matching contributions after June 1, 2023.

(c) Participant accounts

Each participant's account was credited (charged) with the participant's contributions, and allocations of Participating Employer contributions, investment earnings (losses) and administrative expenses. Allocations were based on participant compensation or account balances as defined in the plan document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

(d) Vesting

Participants were immediately vested in their elective salary deferral and the Participating Employer contribution and actual earnings (losses) thereon.

(e) Notes receivable from participants

Each participant could borrow from his or her fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her account balance. The loans were secured by the balances in the respective participants' accounts and bore interest at fixed rates ranging from 4.25% to 9.25% at December 31, 2023, which were calculated at the prime rate plus one percent. Principal and interest were collected through payroll deductions.

(f) Payment of benefits

On termination of service due to death, permanent disability, retirement or termination of service, a participant could elect to receive either a lump-sum payment or annual installments over a specified period equal to his or her entire account. Withdrawals by a participant while employed were limited to those requested due to events of financial hardship as defined by the plan document and to those participants that had attained age 59½.

(g) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the plan document. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

(h) Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and are excluded from these financial statements. Certain recordkeeping fees and fees related to the processing of notes receivable and distributions are included in administrative expenses and were charged directly to the applicable participants' accounts. Investment related expenses are included in net appreciation in fair value of investments.

### (2) Summary of significant accounting policies

#### (a) Basis of accounting

As described in Note 1 of the financial statements, the Plan Sponsor elected to terminate the Plan effective June 1, 2023. In accordance with accounting principles generally accepted in the United States of America ("GAAP"), the plan has changed its basis of accounting to the liquidation basis for the period ended February 29, 2024 and the year ended December 31, 2023.

#### (b) Investment valuation and income recognition

Investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividend income was recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### (c) Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the plan document.

#### (d) Payment of benefits

Benefits were recorded when paid.

#### (e) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### (f) Events occurring after reporting date

The Plan's management has evaluated events and transactions that occurred between February 29, 2024 and December 5, 2024, which is the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

### (3) Certified information

The non-interest bearing cash, investments at fair value, and notes receivable from participants held at February 29, 2024 and December 31, 2023, and the net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants as of and for the period ended February 29, 2024 and as of and for the year ended December 31, 2023, as reported and disclosed in the accompanying financial statements, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by State Street Bank and Trust Company ("State Street") and Transamerica Trust Company ("Transamerica").

### (4) Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 and level 3 inputs are not applicable to the Plan.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

- (i) *Cash*: Valued at its outstanding balance as reported by State Street.
- (ii) *Mutual funds*: Valued based on the funds' reported closing net asset values ("NAV") as of the last business day of the plan year. The funds are deemed to be actively traded.
- (iii) *Self-directed brokerage fund*: The self-directed brokerage fund is invested primarily in mutual and money market funds and is valued based on the funds' reported closing NAV as of the last business day of the plan year. The funds are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Income tax status

The Plan Sponsor adopted a pre-approved profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the pre-approved plan is designed in accordance with the applicable sections of the IRC. The pre-approved plan has been amended since receiving the opinion letter. However, the plan administrator believes that the adopted pre-approved plan was designed and was being operated in compliance with the applicable requirements of the IRC and was therefore, qualified and exempt from taxation.

(6) Related party and party-in-interest transactions

Cash and a collective trust fund are managed by State Street and Transamerica Retirement Solutions, the recordkeeper of the Plan, and, therefore, these transactions qualified as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers and held notes receivable from participants which also qualified as party-in-interest transactions.
