INDEPENDENT AUDITOR'S REPORT

To the Trustees  
Correll Insurance Group 401(k) Retirement Plan  
Spartanburg, South Carolina

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Correll Insurance Group 401(k) Retirement Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Emphasis of Matter**

As discussed in Note 8 to the financial statements, the Company merged the Plan into the BroadStreet 401(k) Plan effective January 1, 2023, with the Plan assets being transferred out of the Plan on February 28, 2023 and December 8, 2023. Our opinion is not modified with respect to this matter.

NOTES TO THE FINANCIAL STATEMENTS  
DECEMBER 31, 2023

---

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Correll Insurance Group (the “Company”) 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all full-time employees of the Company who have completed one year of employment, 1,000 hours of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute up to the annual limit as established by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and guaranteed interest accounts as investment options for participants. The Company contributes 100% of the first 1% of base compensation plus 50% of contributions over 1% up to 6% that a participant contributes to the Plan. Contributions are subject to certain limitations. During the year-ended December 31, 2023, the Plan did not accept any deferral or rollover contributions due to the Plan beginning a blackout period effective January 1, 2023. See Note 8 for information on the Plan’s transfer of assets to the BroadStreet 401(k) Plan.

Participant Accounts: Each participant’s account is credited with an allocation of (a) the Company’s contribution, (b) investment earnings or losses, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 2 years of service for employer matching contributions, and after 6 years for any employer non-elective or additional matching contributions.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant’s account and bear interest at rates ranging from 4.25% to 6.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

## NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

Payment of Benefits: On termination of service due to death, disability or retirement at the normal retirement age, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. Installments are allowed only for required minimum distributions. For termination of service due to other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account of amounts under \$5,000 as a lump sum distribution.

Forfeited Accounts: At December 31, 2022 forfeited nonvested accounts totaled \$624. At December 31, 2023, there was no forfeited nonvested account balance as it was transferred to the BroadStreet 401(k) Plan. When there is a balance in the forfeitures account, these will be used to pay administrative expenses and any remaining forfeitures will be used to reduce employer matching contributions.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting. The Form 5500 is also prepared on the accrual basis of accounting.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2023 and 2022, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of the investments.

## NOTE 3 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs.

- Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stock, corporate bonds, and U.S. Government securities are based on the closing price reported on the active market where the individual securities are traded.

- Level 2 Fair Value Measurements

Fair values for guaranteed investment contracts are based on inputs other than quoted price included within Level 1 that are observable for valuing the asset or liability, either directly or indirectly. Observable inputs include quoted price for similar assets or liabilities in active or nonactive markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

- Level 3 Fair Value Measurements

There are no Level 3 investments in the Plan at December 31, 2023 and 2022.

### NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)

Due to the Plan transferring all assets to another plan, further described in Note 8, the Plan had no investments as of December 31, 2023.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2022 are reported in net depreciation in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2022, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

### NOTE 4 – GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANY

The guaranteed investment contracts are invested in the general funds of the Empower Life & Annuity Insurance Company. The accounts are credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contracts are included in the financial statements at estimated fair values as reported to the Plan by Empower Life & Annuity Insurance Company and are not fully benefit-responsive.

### NOTE 5 – PARTY-IN-INTEREST

The Plan's investments at December 31, 2022 include funds managed by Empower Life & Annuity Insurance Company. Empower Life & Annuity Insurance Company is the Trustee as defined by the Plan. Certain expenses charged by the Trustee are paid by the Company.

#### NOTE 5 – PARTY-IN-INTEREST (CONTINUED)

Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$41,417 for the year ended December 31, 2023.

The Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### NOTE 6 – TAX STATUS

The Internal Revenue Service has determined and informed the Company by letter dated March 31, 2014 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

#### NOTE 7 – INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

At December 31, 2023 and 2022, Empower Life & Annuity Insurance Company (the “Trustee”), held the Plan’s investments. The following is a summary of the Plan’s financial information that is included in the financial statements based on information certified by the Trustee as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

The net decrease and the transfer of assets to new plan reported in the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2023 was certified by the Trustee.

## NOTE 8 – TRANSFER OF PLAN ASSETS

On November 2, 2022, the Company approved the termination of this Plan in order to consolidate the assets into the BroadStreet 401(k) Plan, with the black out period beginning January 1, 2023. As a result, all Plan assets were transferred into the BroadStreet 401(k) Plan managed by Fidelity Investments on two dates. On February 28, 2023 and December 8, 2023, the Company transferred \$14,713,261 and \$899,555, respectively, to the BroadStreet 401(k) Plan. During the year ended December 31, 2023, the Company also transferred notes receivable totaling \$64,673. The Plan continued to operate through out the year, and filed its final Form 5500 as of December 31, 2023.

## NOTE 9 – CARES ACT

In March 2020, the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act was signed into law to provide relief to those affected by the COVID-19 pandemic. The CARES Act allowed for coronavirus-related distributions of up to \$100,000, not to exceed the participant’s account balance, without a 10% early withdrawal penalty. The CARES Act also allowed participants to borrow up to \$100,000, an increase from \$50,000 previously allowed under IRC Section 72(p) for loans made from March 27, 2020 through September 22, 2020, and repayment on these loans can be delayed. The CARES Act also allowed the suspension of loan payments from March 27, 2020 through December 31, 2020, as well as the suspension of the required minimum distributions (RMDs) for 2020. During the year ended December 31, 2020, the Plan allowed for coronavirus-related distributions with the increased limit and no early withdrawal penalty. The remaining provisions of the CARES Act related to employee benefit plans were adopted into the Plan during the year ended December 31, 2022.

## NOTE 10 – SECURE ACT

In January 2020, the Setting Every Community Up for Retirement Enhancement (“SECURE”) Act was signed into law. The SECURE Act increased the cap on payroll contributions to 15% for automatic-enrollment safe harbor plans and allowed long-term part-time workers to participant in 401(k) plans, except in the case of collectively bargained plans. The SECURE Act also allows for in-service withdrawals for childbirth and adoption expenses and allows retirees to delay taking RMDs until age 72, up from the prior age of 70 ½, for participants in 401(k) and other defined contribution plans or defined-benefit pension plans. During the year ended December 31, 2020, the Plan also placed some of the provisions of the SECURE Act into operation, including the delay of taking RMDs until age 72. The remaining provisions of the SECURE Act were also adopted into the Plan during the year ended December 31, 2022.

## NOTE 11 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

## NOTE 12 – SUBSEQUENT EVENTS

The Plan administrator has evaluated subsequent events through December 6, 2024 which is the date the financial statements were available to be issued, and concluded that no subsequent events have occurred that would require recognition in the financial statements or disclosure in the notes to the financial statements.
