SCOPE AND NATURE OF THE ERISA SECTION 103(a)(3)(C) AUDIT

We have performed audits of the financial statements of Retina Physicians Retirement Program as adopted by Tennessee Retina (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets in liquidation available for benefits as of April 30, 2023 and December 31, 2022, and the related statement of changes in net assets in liquidation available for benefits for the period from January 1, 2023 through April 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of April 30, 2023 and December 31, 2022 and for the period from January 1, 2023 through April 30, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

OPINION

In our opinion, based on our audits and on procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## BASIS FOR OPINION

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## EMPHASIS OF MATTER - PLAN TERMINATION AND LIQUIDATION BASIS OF ACCOUNTING

As further discussed in Notes 1 and 8 to the financial statements, the Retirement Committee of Retina Physicians Retirement Program as adopted by Tennessee Retina approved a plan of liquidation in September 2021, and management determined liquidation is imminent. As a result, Retina Physicians Retirement Program as adopted by Tennessee Retina changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

## RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## AUDITOR'S RESPONSIBILITIES FOR THE AUDIT OF THE FINANCIAL STATEMENTS

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

APRIL 30, 2023

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of Retina Physicians Retirement Program as adopted by Tennessee Retina (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

Prior to liquidation, the Plan was a participant directed defined contribution multiple employer plan ("MEP"), covering substantially all eligible employees of Tennessee Retina, P.C. (the "Participating Employer"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Retirement Committee was responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

In September 2021, the Participating Employer underwent a restructuring and became affiliated with another Company. Effective January 1, 2023, the Plan was merged into the 401(k) Plan of Retina Consultants of America LLC. On the effective date, Plan assets and eligible Plan participants were subject to the provisions of the 401(k) Plan of Retina Consultants of America LLC. The Participating Employer and the new Company, and their respective defined contribution plans, entered into a Contribution Agreement and Plan of Reorganization Agreement ("the Agreement") whereas the Participating Employer agreed to transfer the Plan into the new Company's plan, remove the Participating Employer as the plan sponsor and plan administrator and name the new Company as the plan sponsor and plan administrator. The Agreement appoints a new plan service provider, Fidelity Management Trust Company ("Fidelity"), to provide investment options as well as certain third-party administrator functions for the Plan. Plan assets were transferred from Pentegra to Fidelity as soon as administratively practical from the Agreement date. The merger does not impact participant benefits as the benefit provisions were incorporated in the new Company's plan and as protected under the Internal Revenue Code ("IRC").

Eligibility

Prior to liquidation of the Plan, all employees were eligible to participate in the Plan beginning the January 1 or July 1 after reaching age 21 and completing one year of service, as defined in the plan document.

Contributions

Prior to January 1, 2023, participants could elect to defer up to 100% of their compensation, as defined in the plan document. Participants could also contribute amounts representing distributions from other qualified plans. Participants could change their salary deferral percentage at any time. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions.

Contributions to the Plan ceased effective January 1, 2023 in accordance with the Agreement.

The Participating Employer made safe harbor contributions of 100% of elective deferrals up to 3% of compensation and 50% of elective deferrals up to the next 2% of compensation. The Participating Employer could also make certain discretionary contributions, as defined in the plan document. For the year ended December 31, 2022, the Participating Employer subsequently made a discretionary profit sharing contribution totaling \$508,297 into the 401(k) Plan of Retina Consultants of America LLC on September 15, 2023, which is included within Employer contributions receivables on the statements of net assets available for benefits as of April 30, 2023 and December 31, 2022. The Participating Employer did not make any discretionary match contributions or an Employer discretionary profit sharing contribution for the 2023 Plan year.

Contributions were subject to certain limitations in accordance with applicable regulatory requirements.

Participant accounts

Prior to liquidation, each participant's account was to be credited with the participant's contributions, allocations of Employer contributions and plan earnings, and reduced by an allocation of administrative expenses, any distributions and plan losses. Allocations were based on participant earnings, account balances or specific participant transactions, as defined by the plan document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Investment options

Prior to liquidation, participants directed the investment of their contributions into various investment options offered by the Plan. Participants were able to change their investment options any time throughout the year.

Vesting

Prior to liquidation, participants were immediately vested in their contributions, plus actual earnings thereon. Vesting in Employer contributions was based on years of continuous service. Participants were 20% vested after two years of service and vested 20% each year thereafter until fully vested after six years of credited service. Irrespective of years of service, a participant was 100% vested if they were employed on or after normal retirement age of 65 or if they died or became disabled.

On January 1, 2023, all participants became 100% vested in their Employer contributions in accordance with the Agreement.

Notes receivable from participants

Prior to liquidation, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the vested balance in the participant's account and bore interest at 4.25% which was commensurate with local prevailing rates as determined by the Plan Administrator. Loan terms were for a maximum of 5 years, or longer if used for the purchase of a primary residence. Principal and interest were paid ratably through payroll deductions.

Payment of benefits

Prior to liquidation, benefit distributions equal to a participant's vested account balance were payable to the participant or beneficiary upon normal retirement (age 65), death, disability or termination of employment. The method of distribution shall be determined by the Plan Administrator in accordance with the provisions of the Plan.

Forfeitures

Forfeitures result from termination of employment under circumstances which do not entitle the participant to be fully vested in their Employer contributions. Forfeitures remaining at April 30, 2023 and December 31, 2022, amounted to \$0 and \$6,091, respectively, and were available to reduce Employer contributions. No forfeitures were used to reduce Employer contributions during 2023. All the forfeitures as of December 31, 2022 were transferred into the 401(k) Plan of Retina Consultants of America LLC in accordance with the Agreement.

In-service withdrawals

Prior to liquidation, in-service withdrawals were permitted by participants who had reached the age of 59 and 1/2. Early withdrawals may also be made in the case of financial hardship, as determined by the Participating Employer.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

Due to the decision to terminate the Plan during 2023, management determined that liquidation of the Plan is imminent and the financial statements for 2023 have been prepared using the liquidation basis of accounting. The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates

The preparation of financial statements in conformity with GAAP requires the Plan to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Prior to liquidation, investments were stated at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determined the valuation policies utilizing information provided by the investment advisers and the Trustee. See Note 4 for discussion of fair value measurements.

All investments reported in the statement of net assets in liquidation available for benefits as of April 30, 2023, are reported at liquidation value. For all investments, fair value approximated the amount the Plan expected to collect upon liquidation.

Purchases and sales of securities were recorded on a trade-date basis. Interest income is recorded on the liquidation basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Prior to liquidation, notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the liquidation basis. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses as incurred.

No allowance for credit losses has been recorded as of April 30, 2023 and December 31, 2022. If a participant ceased to make loan repayments and the Plan Administrator deemed the participant loan to be a distribution, the participant loan balance was reduced and a benefit payment was recorded.

Payment of benefits

Benefit payments were recognized when paid.

Expenses

Expenses of maintaining the Plan were paid by the Plan unless paid by the Participating Employer. Expenses paid by the Participating Employer were excluded from these financial statements. Investment-related expenses were included in net appreciation in fair value of investments.

Events occurring after reporting date

The Plan has evaluated events and transactions that occurred between April 30, 2023 and February 9, 2024, the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

NOTE 3 - INFORMATION CERTIFIED BY TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at April 30, 2023 and December 31, 2022, and investment income and interest income on notes receivable for the period from January 1, 2023 through April 30, 2023, was obtained by management and agreed to or derived from information certified by Reliance Trust Company, the Trustee of the Plan.

NOTE 4 - FAIR VALUE

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using unadjusted quoted prices from active markets for identical assets), Level 2 (not traded on an active market, but for which observable market inputs are readily available) and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets and liabilities measured at fair value:

There have been no changes in the valuation methodologies used at April 30, 2023 and December 31, 2022.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Prior to liquidation, there were no participant redemption restrictions for these investments; the notice period is applicable only to the Plan. If the Plan initiated a full redemption of the account, the issuer reserved the right to require 12 months' notification in order to ensure that security liquidations would be carried out in an orderly business manner.

The description of the significant investment strategies for each category of investment in the collective trust funds follows:

- (a) This category seeks to track the performance of its benchmark, the MSCI EAFE Index.
- (b) This category seeks to track the performance of the Russell 2000 Index.
- (c) This category seeks to match the performance of its benchmark, the S&P MidCap 400 Index.
- (d) This category seeks to capture the growth potential of large companies and achieve broad diversification with low costs by fully replicating the S&P 500 Index.
- (e) This category includes fixed income instruments which underlie Stable Value contracts and seeks to earn current income while preserving capital and maintaining principal stability.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invested in investment securities which are exposed to various risks, such as interest rate, credit and overall market risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

At December 31, 2022, the Plan had a concentration of investments in three funds, which represented approximately 64% of total investments.

NOTE 6 - INCOME TAX STATUS

The Plan adopted a pre-approved plan document (Pre-Approved Plan). The Pre-Approved Plan received its latest opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated the Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not applied for a separate determination letter.

The Plan Administrator and the Plan's tax counsel believe the Plan and Pre-Approved Plan are designed and have been operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been provided in the financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

NOTE 7 - PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Participating Employer and certain others. Plan investments are held by the Trustee, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, rather than a direct payment.

These party-in-interest transactions are exempt from the prohibited transactions provisions of ERISA and the IRC.

NOTE 8 - PLAN MERGER AND TERMINATION

As discussed in Note 1, the Participating Employer discontinued employee and Employer contributions into the Plan as of January 1, 2023. The Participating Employer has the right to terminate the Plan subject to provisions of ERISA. Liquidation was imminent at the end of the Plan year end and substantially all of the assets of the Plan merged into the 401(k) Plan of Retina Consultants of America LLC during the period from January 1, 2023 through April 30, 2023.

As of April 30, 2023, the Plan had an Employer contribution receivable of approximately \$780,000 which related to the Plan year ending December 31, 2022. Subsequently, during September 2023, the Employer made this contribution directly into the 401(k) Plan of Retina Consultants of America LLC for the benefit of those participants as of December 31, 2022. Accordingly, the Plan has also recorded a payable of approximately \$780,000 to reflect the transfer of this Employer contribution into the 401(k) Plan of Retina Consultants of America LLC and this amount is included within transfer to the 401(k) Plan of Retina Consultants of America LLC on the statement of changes in net assets in liquidation available for benefits.

NOTE 9 - NONEXEMPT TRANSACTIONS

During 2022, the Employer failed to remit timely \$64,514 of participant contributions to the Plan. To comply with ERISA requirements for timely remittance of participant contributions, the Employer is required to segregate employee contributions from its general assets as soon as practicable. Later remittances constitute loans from the Plan to the Employer, which are prohibited transactions. The Employer is required to report these transactions to the Department of Labor and pay the specified penalty taxes. Additionally, the Employer is required to calculate lost earnings for those participants affected during the year and remit such amounts to the Plan. In management's opinion, the amount of such lost earnings is not significant and has not been accrued in the accompanying financial statements. Management intends to contribute the lost earnings to the Plan in 2024.
