Dear Sir or Madam,

Our firm switched to ADP a few short years ago from OASIS, A Paychex Company, which was also our PEO. I recently received a letter from ADP Retirement Solutions to file "Form 5500" for 2023, the deadline being October 15, 2024. After a lengthy conversation with Retirement Solutions, and after having logged onto www.Login.gov and having received my User & PIN, for the first time, the ADP portal would not allow me to file the 2023 Form 5500. When I looked at the dropdown menu, it showed that 2022 and 2021 were listed as "late", thus, not yet filed. It also would not let me file the 2023 Form 5500.

I was instructed to write this letter to Dept. of Labor explaining why 2022 and 2021 were not filed. The current mailing we received about this is the first time we have ever received a letter from ADP instructing us to file a "Form 5500." Also, I checked my email history from ADP and there have been hundreds of emails regarding timeclock issues or upcoming events, but nothing regarding the filing of a Form 5500. We were also never briefed about this at our ADP "orientation" from our representative either, when we switched over from OASIS. We were under the presumption that if any filings needed to be made, that ADP would make them automatically, or at least notify us to do so. I was told for the first time in today's conversation that ADP can file our Form 5500 for a "fee."
