## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors and Plan Administrator  
403(b) Thrift Plan of St. Alexius Medical Center and Garrison Memorial Hospital  
Bismarck, North Dakota

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the 403(b) Thrift Plan of St. Alexius Medical Center and Garrison Memorial Hospital, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 5, 2024 and December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the period ended January 5, 2024 and year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 403(b) Thrift Plan of St. Alexius Medical Center and Garrison Memorial Hospital's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the periods ended January 5, 2024 and December 31, 2023 and 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). **NOTE 1 PLAN DESCRIPTION**

The following description of the 403(b) Thrift Plan of St. Alexius Medical Center and Garrison Memorial Hospital (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was established effective January 1, 2008 under the Employee Retirement Income Security Act of 1974, as amended (ERISA), as an employer-sponsored individual account employee pension benefit plan (other than a money purchase pension plan) that is intended to make contributions to annuity contracts described in Code section 403(b) or custodial accounts described in Code section 403(b)(7) on behalf of Participants. The Plan was established so that eligible employees may have an additional source of retirement income.

The Plan is administered by the sponsor and trustee – St. Alexius Medical Center. The Plan is a defined contribution plan covering employees of St. Alexius Medical Center and Garrison Memorial Hospital (Company). Third party administrators maintain the records of the participant data and hold the Plan assets.

Effective January 5, 2024, the assets of the Plan were merged into CommonSpirit Health ERISA 403(b) Plan.

**Eligibility**

Employees of the Company are generally eligible to make contributions to the Plan immediately. To be eligible to receive the employer non-elective base, employees must complete one year of service (consisting of at least 1,000 hours) and attain age 21. For an employee to receive the employer matching contributions, they must satisfy the requirements of the employer non-elective base and be deferring in the Plan.

**Contributions**

Participants may contribute up to the maximum dollar amount allowed under federal regulations for the Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions.

The Company matches 100% of the first 1% of eligible compensation plus 50% of the next 5% of eligible compensation for a maximum match of 3.5% for the plan year. For the employer non-elective base contributions, the Company allocates 2.5% of eligible compensation with a minimum of \$1,000 per plan year.

Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and the employer base and matching contributions. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

**Participants' Investment Options**

Participants must direct their salary deferral contributions and employer base and match contributions to selected investments as made available and determined by the Plan. Participants may change their investment options throughout the year by contacting the record keeper of the Plan, Empower Retirement.

**Payment of Benefits**

On termination of employment, death, disability or retirement, a participant may receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum payment, installment payments, or annuity payments. Hardship distributions are permitted for participants who have not separated from service. Participants must attain age 59 1/2 to qualify for in-service distributions. Generally, certain minimum distributions are required for participants who have separated from service and have reached required minimum distribution age.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer base and matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service with certain exceptions for death and disability. A participant is 100% vested after three years of credited service or attaining age 65.

**Forfeitures**

Forfeitures are used to reduce future employer base and matching contributions or to pay plan expenses. At January 5, 2024 and December 31, 2023 and 2022, forfeited nonvested accounts totaled \$0, \$193,244, and \$230,201, respectively. During the year ended December 31, 2023, \$266, were used to reduce Company contributions. On January 5, 2024, the Plan transferred \$188,766 of forfeitures into the new Plan.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates equal to 1% above prime rate at the time of the loan. The term of the loan cannot exceed five years, unless it is for the purchase of a principal residence, which must be repaid within fifteen years. Principal and interest are paid ratably through payroll deductions.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the custodian and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

**Contributions**

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Defaulted participant loans are reclassified as deemed distributions based upon terms of the Plan.

**Payment of Benefits**

Benefit distributions are recorded when paid.

**Administrative Expenses**

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Administrative expenses reported by the Plan consist of recordkeeping and advisory fees.

Certain administrative expenses that are paid by the Company are not reflected in the accompanying financial statements. 12b-1 fees are credited back to the participants invested in the revenue-paying funds.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**NOTE 3 TAX STATUS**

The Plan sponsor is a tax-exempt organization under 501(c)(3) of the Internal Revenue Code (IRC). The organization has adopted a 403(b) tax-sheltered annuity (TSA) plan. 403(b) plans are not required to receive a favorable determination letter from the Internal Revenue Service indicating that the Plan is qualified under Section 403(b). The Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 FAIR VALUE MEASUREMENT**

Financial Accounting Standards Board Statement ASC Topic 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:  
Quoted prices for similar assets or liabilities in active markets;  
Quoted prices for identical or similar assets or liabilities in inactive markets;  
Inputs other than quoted prices that are observable for the asset or liability;  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at January 5, 2024 and at December 31, 2023 and 2022.

Custodial account - mutual funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Total Plan assets were merged into the CommonSpirit Health ERISA 403(b) Plan on January 5, 2024 and, therefore, there are no assets to report within the fair value hierarchy for the year then ended.

**NOTE 6 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Empower Retirement is the record keeper as defined by the Plan and, therefore, qualifies as a party-in-interest. Participant fees are withheld from participants' accounts and credited to an unallocated plan account on a quarterly basis. \$14,532 and \$235,124 were withheld from participant accounts by the record keeper for the periods ended January 5, 2024 and December 31, 2023, respectively. Fees are then paid from this unallocated plan account. Fees totaling \$12,038 and \$173,098 were paid to Empower Retirement during the periods ended January 5, 2024 and December 31, 2023, respectively.

Empower Retirement receives revenue (also known as 12b-1 fees) from mutual fund service providers for services Empower Retirement provides to the funds. This revenue is credited to participants with balances in the revenue-paying funds on a quarterly basis. Total revenue attributed to investments of the Plan was \$0 and \$44,793 for the periods ended January 5, 2024 and December 31, 2023, respectively. The amounts shown as other income on the accompanying financial statements reflect the amounts of revenue remitted to the plan.

NFP Retirement, Inc. is the broker/adviser to the Plan and, therefore, qualifies as a party-in-interest. Fees paid to NFP Retirement, Inc. were \$6,223 and \$91,924 for the periods ended January 5, 2024 and December 31, 2023, respectively.

The Plan issues notes receivables to participants which are secured by the balances in the participants' accounts. These transactions qualify as party-in-interest transactions.

**NOTE 7 NON-EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

The Company did not remit the following participant contributions to the custodian as required by the Department of Labor (DOL) Regulation 2510.3-102.

The Company has calculated amounts representing the earnings that the contributions would have earned if they had been deposited timely. The lost earnings from the late remittances for the year ended December 31, 2022 were deposited subsequent to the period ended January 5, 2024.

**NOTE 8 AMENDMENT AND TERMINATION**

The Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. As stated earlier, the Plan merged into the CommonSpirit Health ERISA 403(b) Plan in early 2024. Participants' eligibility and vesting transferred into the new plan.

**NOTE 9 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10 SUBSEQUENT EVENTS**

The Plan was merged into the CommonSpirit Health ERISA 403(b) Plan on January 5, 2024. As such, no significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through October 14, 2024, which is the date these financial statements were available to be issued.
