Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Rockford Gastroenterology Associates, Ltd. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Rockford Gastroenterology Associates, Ltd. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion



NOTE 1 DESCRIPTION OF PLAN

The following description of Rockford Gastroenterology Associates, Ltd. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and was established on July 1, 1981 for employees of Rockford Gastroenterology Associates, Ltd. (the Company) except for those covered by a collective bargaining agreement, those who are leased employees, or nonresident aliens who received no earned income which constitutes income from services performed within the United States. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective October 1, 2021. The Plan provides for participant tax deferred savings under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan also allows participants to make after tax Roth contributions.

Eligibility

Employees become eligible on the first day of the first month and seventh month of the Plan year following the date the employee attains age 21 and completes one year of service.

Contributions

Participants may elect to contribute to the Plan a percentage of their compensation up to a maximum amount as defined by the IRC. If employee contributions cause the Plan to exceed the 401(k) discrimination limits, excess contributions are refunded to the participants.

The Plan provides for the Company to make safe harbor contributions quarterly. The contributions equal 3% of each participant's eligible wages. Employer safe harbor contributions made in 2023 totaled \$284,537. Employer profit sharing contributions to the Plan are at the discretion of the Company's Board of Directors; however, the total contributions may not exceed the maximum allowable by the IRC. Employer profit sharing contributions made in 2023 totaled \$684,164.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participant Accounts

Each participant's account is credited with the participant's voluntary contributions, the Company's safe harbor contributions, an allocation of the Company's profit sharing contribution, and the administrative expenses paid by the Plan, income, losses, appreciation, and depreciation. Forfeitures are allocated to participants' accounts. The allocations of the Company's profit sharing contributions to the participants' accounts are based on the participant's eligible compensation. Plan earnings are allocated based on account balances.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their voluntary tax deferred and Roth contributions, Company safe harbor contributions, and earnings thereon. Participants are vested in the Company's profit sharing contributions based on years of service. A participant becomes vested in the Company's profit sharing contributions according to the following schedule:

1	20%
2	40%
3	60%
4	80%
5 or More	100%

A participant must work at least 1,000 hours during a Plan year to increase the vested portion of Company profit sharing contributions. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Investment Options

Participants must direct all contributions to selected investment models as made available and determined by the Plan administrator. Participants have the option to transfer monies between models and change allocations of their investment options on a daily basis.

Benefit Payments

Upon termination of service due to death, disability, retirement, or termination, a participant may elect to receive either a lump-sum amount equal to the value of his/her account or another method of payment providing for installments in approximately equal amounts over a period not exceeding the life expectancy of the participant and his/her beneficiary. If the vested benefits are less than \$5,000, the balance will be distributed as either a cash distribution or rolled into an individual retirement account (IRA). If the participant does not elect a method of payment and the vested balance is greater than \$1,000, it will automatically be rolled over into an IRA. Balances of \$1,000 or less will be distributed in a lump sum to the participant. If the balance is more than \$5,000, an election to receive the benefit must be made.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of 50% of the vested balance of the participant's account or \$50,000. Notes receivable from participants cannot exceed five years unless they are for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. The interest rates were 4.25% – 9.25% and 4.25% - 6.50% as of December 31, 2023 and December 31, 2022, respectively.

Forfeited Accounts

Forfeitures, based on Plan discretion are either used to pay Plan expenses, reduce Company contributions, or are re-allocated to participant accounts as defined in the Plan. There were no forfeitures re-allocated to participant accounts were in 2023. There were no forfeitures used to pay administrative expenses in 2023. Forfeitures used to reduce Company contributions were \$2,972 for the year ended December 31, 2023. The balance in the forfeiture account at December 31, 2023 and 2022 was \$11,191 and \$2,972, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the Plan documents.

Benefit Payments

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through December 10, 2024, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

AdvisorTrust, Inc, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022, the statement of changes in net assets available for benefits for the year ended December 31, 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2023.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2023 and 2022:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan provides for various investment options in various combinations of investment funds. Investment funds are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter, dated June 30, 2020, received from the Internal Revenue Service (IRS) on the volume submitter plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore, not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by AdvisorTrust, Inc., the qualified institution of the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees paid by the Plan amounted to 171,490 for the year ended December 31, 2023. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Certain administrative functions are performed by officers or employees of the Company for which they receive no compensation from the Plan.

NOTE 9 PROHIBITED TRANSACTIONS

During 2023, the Plan Sponsor failed to deposit participant deferrals within the required time frame as stated by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. The Plan Sponsor is in the process of correcting the prohibited transactions by depositing the lost earnings.
