## Spinal Group, Inc. 401(k) Plan Notes to Financial Statements

### **1. Description of Plan**

The following description of the Spinal Group, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan Document.

#### **General**

The Plan is a defined contribution profit sharing plan covering all employees of Spinal Group LLC, Spinal Technology LLC, Spinal Systems LLC (and their predecessor companies Spinal Group, Inc., Spinal Technology, Inc. and Spinal Systems, Inc. respectively), Lower Limb Technology, LLC, Orthotic and Prosthetic Center of Boston, LLC, and Orthotic and Prosthetic Center of Cape Cod and Islands, LLC (collectively the Company or Employer), except for interns, contract employees, co-op exchange students and clinical residents. Employees become eligible to enter the Plan after reaching 21 years of age and after completion of 12 consecutive months from the date of employment during which employees must complete 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All investments are participant-directed. Reliance Trust Company (Reliance) is the Trustee of the Plan and ADP Retirement Services (ADP) provides recordkeeping services for the Plan as of February 29, 2024 and December 31, 2023, and for the period from January 1, 2024 to February 29, 2024 and year ended December 31, 2023.

Effective February 29, 2024 the Employer merged the Plan into the Ortho Dev America Corp 401(k) Plan, and thus the Plan ceased to exist.

#### **Participant Contributions**

Participants may elect to contribute up to 85% of their eligible annual compensation, subject to annual limitations as provided by the Internal Revenue Code (the IRC). Participants may make pre-tax or Roth contributions to their accounts. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (Rollover Contributions). Contributions are subject to certain dollar limitations as set forth by the Internal Revenue Code. Such limit on participant contributions was \$23,000 for the period from January 1, 2024 to February 29, 2024 and \$22,500 for the year ended December 31, 2023, respectively, with the exception of certain allowable catch-up contributions for participants over the age of 50. The maximum amount a participant may contribute as a catch-up contribution for 2024 and 2023 was \$7,500, respectively.

Employees, upon eligibility to participate in the Plan, are automatically enrolled to defer 3% of their eligible compensation, as defined. A Participant may choose not to defer or may choose a different percentage once enrolled. Automatic enrollment deferrals are invested in the applicable lifecycle fund, as defined, based on the employee's birth date. The automatic pre-tax deferral election and the default investment option remain in effect until the Participant changes them.

**1. Description of Plan (continued)**

**Employer Contributions**

*Employer Profit Sharing Contributions*

The Company may, in its sole discretion, make a profit-sharing contribution on behalf of eligible participants. Participants are eligible for the Employer Profit Sharing Contribution after completing 1,000 hours during the Plan year and are employed on the last day of the Plan year unless termination of employment due to death, disability or normal retirement age. Employer Profit Sharing Contributions are allocated to Participants based on their compensation divided by the total compensation of all participants eligible to share. The Company did not make any Employer Profit Sharing Contributions to the Plan for the period from January 1, 2024 to February 29, 2024 and year ended December 31, 2023.

**Participant Accounts**

Each Participant's account is credited with the Participant's contributions, the respective Employer contributions and allocation of the Plan's investment earnings and is charged with an allocation of certain expenses. Allocations are based on Participant compensation or account balance, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

**Vesting**

Participants are immediately vested in their Participant contributions, catch-up contributions, rollover contributions, and Employer Safe Harbor Matching Contributions, plus allocated earnings thereon. Participants vest in the Company's Profit-Sharing Contributions in accordance with the following schedule. Participants will always, however, be 100% vested in their profit-sharing contributions if they are employed on or after their Normal Retirement Age or upon death or disability.

Participants are credited with a year of service for any year in which they work 1,000 hours or more.

**Payment of Benefits**

Upon severance of service due to death, disability, termination, or retirement, a Participant or beneficiary may elect to receive a lump-sum distribution, a partial distribution, or installment payments in an amount equal to the value of the Participant's vested interest in his or her account. The payment can either be a cash distribution to the Participant, subject to income tax withholdings, or a tax-free rollover to an individual retirement account or another qualified plan. If a Participant's vested account is more than \$1,000 but less than \$5,000, the Plan Administrator, after notification, may distribute the benefit into an individual retirement account. If the vested account balance is less than \$1,000, the Plan Administrator may distribute the account balance to the Participant in a lump sum payment. In-service withdrawals from a Participant's vested account balance are permitted upon reaching age 59½. Active participants may also withdraw funds from their accounts under certain hardship conditions, as defined in the Plan Document.

**Notes Receivable from Participants**

A Participant may borrow from their account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 minus the highest outstanding balance of loans in the past 12 months or 50% of their vested balance. Notes are secured by the Participant's vested account balance. Interest is charged at the Prime Rate plus 2.00%. Principal and interest are paid ratably through payroll deductions, over a period not to exceed five years from the date of the loan, unless the loan is used to acquire the Participant's principal residence, then the term is determined by the Plan Administrator. When participants are terminated, their loans become due and payable in full immediately. If a Participant ceases to make loan repayments and the Plan Administrator deems the loan to be in default, the Participant's loan balance is reduced and a benefit payment is made in accordance with the plan document. Loans to Participants are reported as notes receivable from participants at the unpaid principal balance plus any accrued but unpaid interest.

**Forfeited Accounts**

A Participant who is no longer employed by the Company forfeits any non-vested balance after the earliest of (1) five consecutive one year breaks in service, or (2) the distribution of the Participant's entire vested account balance. Forfeitures, as designated by the Plan Administrator, may be used to pay Plan expenses, applied to reduce or add to future Employer contributions, or allocated to Participants based on compensation. Forfeitures included in Plan assets as of February 29, 2024 and December 31, 2023 were \$0 and \$1,908, respectively.

**Plan Administration**

The Company is the Plan Administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Individual participant accounts may be charged directly for all administrative expenses, if not paid by the Company. The Plan does not seek reimbursement from the Company. Individual participant accounts are charged directly for loan recordkeeping, if applicable.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in accordance with GAAP requires plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

**Investments, Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further information on fair value measurements utilized by the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year/period. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**2. Summary of Significant Accounting Policies (continued)**

**Unit Value**

The Plan's investment in common collective trusts are measured using the net asset value (NAV) per share of the investment as a practical expedient as permitted by Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement and Disclosures* (ASC 820) and ASC 946, *Financial Services – Investment Companies*. Participants do not have beneficial ownership in the specific underlying securities or other assets in the trusts but do have an interest therein represented by units which are valued daily. The trusts earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each trust are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the Participants' accounts are charged or credited with the number of units properly attributable to each Participant.

**Notes Receivable from Participants**

Interest income on notes receivable from participants is recognized on the accrual basis of accounting. Related fees are recorded as administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2023.

**Payments of Benefits**

Benefits are recorded during the period in which they are paid.

**3. Information Prepared and Certified by the Plan's Trustee**

The Plan's investments are held and administered by the Trustee, Reliance Trust Company. All investment information disclosed in the accompanying financial statements, including investments held at December 31, 2023, interest income, dividends and net appreciation (depreciation) in fair value of investments for the period from January 1, 2024 to February 29, 2024 and year ended December 31, 2023 was obtained and certified as complete and accurate by Reliance Trust Company.

**4. Fair Value Measurements**

Under GAAP, a framework for measuring fair values has been established to clarify the definition of those fair values and expand disclosures about assets and liabilities measured at fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy described under GAAP are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at February 29, 2024 and December 31, 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts - Valued at the Net Asset Value (NAV) of units in the collective trust. The NAV, as provided by Reliance Trust Company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Generally, contributions to and withdrawals from the fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the Participants' accounts are charged or credited with the number of units properly attributable to each Participant.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Plan Merger**

The Plan was merged with the Ortho Dev America Corp 401(k) Plan effective February 29, 2024 and ceased to exist. Subsequent to February 29, 2024, no contributions, distributions, loan payments or new loans were allowed into or out of the Plan.

**6. Risks and Uncertainties**

The Plan invests in investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the statements of net assets available for benefits.

**7. Tax Status**

The underlying prototype non-standardized profit sharing plan with CODA (cash or deferred arrangement) has received an opinion letter from the Internal Revenue Service, dated July 16, 2014, stating that the form of the Plan is qualified under Section 401(a) of the IRC, is exempt from federal income taxes under Section 501(a) of the IRC and that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter, however, the Plan Administrator believes the Plan is currently designed in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax-exempt as of the financial statement dates.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. It is the Plan's policy to account for any uncertainties as described under the income tax laws. Under the income tax laws, the tax-exempt status of an entity is considered a tax position. No such uncertain tax positions have been recognized by the Plan.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**8. Party-In-Interest Transactions**

During the Plan 2024 period and 2023 Plan year, \$4,562 and \$29,969, respectively, of administrative fees were paid to Reliance Trust Company. Notes receivable and interest from participants also qualify as exempt party-in-interest transactions as defined by ERISA.

**9. Subsequent Events**

The Plan has evaluated subsequent events through December 13, 2024, the date the financial statements were approved and authorized for issuance by management.
