Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 403(b) Thrift Plan of Koinonia Homes, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits in liquidation as of February 29, 2024, and the related statement of changes in net assets available for benefits in liquidation for the period January 1, 2024 through February 29, 2024, statement of net assets available for benefits in liquidation as of December 31, 2023, and the related statement of changes in net assets available for benefits in liquidation for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 403(b) Thrift Plan of Koinonia Homes, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of February 29, 2024 and for the period January 1, 2024 through February 29, 2024 and as of and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of 403(b) Thrift Plan of Koinonia Homes, Inc. and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As further described in Note 2 to the financial statements, the Board of Trustees of 403(b) Thrift Plan of Koinonia Homes, Inc. approved a plan termination effective December 31, 2023 and management determined liquidation was imminent. As a result, the Plan changed its basis of accounting to the liquidation basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. 1. Description of Plan:

General:

The following brief description of the 403(b) Thrift Plan of Koinonia Homes, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan established January 1, 1997 is a defined contribution plan covering all employees of Koinonia Homes, Inc. (the Organization and Plan Sponsor) who meet the eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

On November 15, 2023, the Board of Trustees of the Organization elected to terminate the Plan effective December 31, 2023 (see Note 8). The Plan was formally amended effective December 31, 2023 so that no employee shall be eligible to become a participant of the Plan, no contributions and rollover contributions shall be accepted into the Plan, and any participant accounts that were not 100% vested will become 100% vested.

Contributions:

Prior to the Plan termination, participants could elect to contribute up to 100% of their compensation (which may not exceed annual dollar limits established by the Internal Revenue Service) into the Plan on a pre-tax basis or after tax (Roth) basis. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Organization could make discretionary matching contributions to participants' accounts as determined periodically by the Organization's Board of Trustees. During 2023, the Organization elected to make a discretionary matching contribution of \$75,644 (\$85,000 less \$9,356 of forfeitures). The discretionary matching contributions were allocated to the participants based on the percentage of the participant's deferral to the total amount of participant deferrals during the Plan year. Highly compensated employees were excluded from the match calculation pursuant to the plan. Discretionary matching contributions were not permitted for 2024.

Participant accounts:

Separate accounts for each participant were maintained by Mutual of America Life Insurance Company. Each account was credited with contributions and earnings/losses from investments held in the account. Prior to the Plan termination, participants could direct their contributions, including the employer's portion, into a number of investment fund options. Participants could change their investment elections daily.

1. Description of Plan (continued):

Vesting:

Prior to the Plan termination, participants were 100% vested immediately with respect to their compensation deferrals and rollovers. Participants vested in discretionary matching contributions in accordance with the following schedule:

Upon the Plan termination, participants became 100% vested in all contributions. Forfeitures of nonvested accounts were retained in the Plan and used to reduce future employer contributions. The forfeiture account totaled \$0 at February 29, 2024 and \$6,533 at December 31, 2023.

Payment of benefits:

Participants who suffered serious financial hardship, as defined by the Plan, could withdraw the total balance of their account in order to meet their financial needs. Once participants attained age 59-1/2, they could also elect to withdraw from their account, any amount not to exceed their vested portion. All accounts were subject to distribution upon the participant's termination, disability, retirement or death.

On termination of service, participants could elect to receive a lump sum distribution equal to the vested value of their account balance, or in installments not to exceed the life of the participant. All distributions were to be made in cash.

Benefits were recorded when paid.

2. Summary of significant accounting policies:

Basis of accounting:

As a result of the Board of Trustees of the Plan Sponsor decision to terminate the Plan effective December 31, 2023, the liquidation basis of accounting was used in presenting the statement of net assets and the statement of changes in net assets as of February 29, 2024 and for the period January 1, 2024 through February 29, 2024 and as of and for the year ended December 31, 2023.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates and assumptions.

2. Summary of significant accounting policies (continued):

Investment valuation and income recognition:

The Plan's investments were valued at fair value at December 31, 2023, as provided by Mutual of America Life Insurance Company (the Trustee). The Plan's investments were held by the Trustee at December 31, 2023. The Trustee executed transactions as directed by the Plan's participants.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. These amounts were provided by the Trustee.

Guaranteed interest account (general account):

The Plan's guaranteed interest account with the Trustee was recorded at face value, which approximated fair value for the insurance company's general account, as provided by Mutual of America Life Insurance Company. The guaranteed interest account was considered a cash equivalent (subject to credit and market risk) and was not subject to the fair value hierarchy (see Note 3). The average yield was 0.42% in 2024 and 1.75% in 2023.

3. Fair value:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

3. Fair value (continued):

For pooled separate accounts, investments consist solely of investments in mutual funds registered with the Securities and Exchange Commission and were carried at net asset value at which the mutual shares are actively traded.

4. Administrative and investment expenses:

Certain administrative and investment expenses of the Plan were paid by Plan Sponsor. Certain administrative functions were performed by employees of the Plan Sponsor. No such employee, nor the Plan Sponsor received compensation from the Plan.

5. Party-in-interest transactions:

Certain Plan investments were managed directly by the Trustee, Mutual of America Life Insurance Company, representing the cash equivalent and pooled separate accounts that were the insurance company's assets with the Plan maintaining rights to assets underlying the investments. Mutual of America Life Insurance Company was the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Certain fees related to the administration of the Plan were paid by the Plan or the Plan Sponsor, which qualify as party-in-interest transactions.

6. Information certified by Trustee:

Certain information related to investments disclosed in the accompanying financial statements, including investments held at December 31, 2023, and net appreciation in fair value of investments and interest for the period January 1, 2024 through February 29, 2024 and year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company (Trustee of the Plan).

7. Income tax status:

The Internal Revenue Service had determined that the 403(b) Thrift Plan of Koinonia Homes, Inc. was designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan was required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes the Plan was being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan was qualified and the related trust was exempt from taxation.

7. Income tax status (continued):

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Plan termination:

The Plan Sponsor had the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. On November 15, 2023, the Board of Trustees of the Plan Sponsor elected to terminate the plan effective December 31, 2023 due to the Plan Sponsor merger on 10/1/2023 with another nonprofit organization. The Plan's assets of participants who did not request a distribution were converted to individual annuities on February 29, 2024. In accordance with U.S. GAAP, the Plan changed its basis of accounting from the ongoing plan basis to the liquidation basis at December 31, 2023.

9. Risks and uncertainties:

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could have occurred in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets in liquidation available for benefits.

10. Subsequent events:

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through December 13, 2024, the date the Plan's financial statements were available to be issued.
