### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of C.R.T.S., Inc. 401(k) Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of February 2, 2024 and December 31, 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to February 2, 2024 (in liquidation) (“period ended February 2, 2024”), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of February 2, 2024 (in liquidation) and December 31, 2023 (in liquidation), and for the period ended February 2, 2024 (in liquidation), stating the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Plan Termination**

As discussed in Note 1 to the financial statements, the governing body of the Plan approved a Plan liquidation effective August 31, 2023. The Plan was liquidated and terminated as of February 2, 2024 and all participant balances have been distributed by the date of this report. Our opinion is not modified with respect to this matter.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

### Note 1—Description of the Plan

The following description of the C.R.T.S., Inc. (the “Company”) 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

*General* – The Plan is a defined contribution plan covering substantially all employees of the Company who have completed six months of service and are over 18 years old. Participants may enter the Plan on the first day of each Plan year quarter upon meeting the service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective August 31, 2023, the Company approved a plan of termination, and management determined liquidation was imminent. Contributions to the Plan ceased effective August 31, 2023, and no new employees were eligible to participate in the Plan after August 31, 2023. Final distributions were based on all participants being 100% vested. The investments held by the Plan were liquidated and distributed to participants. All participant accounts were distributed by the date of this report.

*Contributions* – Each year participants may contribute up to 75% of pre-tax annual compensation as defined in the Plan, within regulatory guidelines through payroll deduction. The Plan has a 3% automatic deferral election, meaning if an eligible participant does not specifically designate they do not want to participate, then 3% of their eligible compensation, as defined in the Plan, will be automatically deferred into the Plan. The automatic deferral percentage will increase 1% per year up to a maximum of 9% of eligible compensation starting on January 1<sup>st</sup> of the second calendar year after the participant first has automatic deferrals withheld, unless the participant elects otherwise. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. All contributions are participant directed and are subject to certain limitations.

The Plan provides for a discretionary employer matching contribution equal to a uniform percentage or dollar amount of participant deferrals. The Plan’s trustees elected to provide an employer match of 15% of the first 3% of compensation for each pay period that a participant contributes to the Plan. The Company contributed \$0 in total employer matching contributions for the period ended February 2, 2024.

*Participant Accounts* – Each participant’s account is credited with the participant’s contribution including any rollover amounts from qualified plans, the Company’s discretionary-matching contribution and allocations of (a) the Company’s discretionary profit sharing contribution (if any), (b) Plan earnings, or (c) forfeitures, and charged with the participant’s distributions and allocations of administration expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* – Effective August 31, 2023, all participants became fully vested in all balances. See Note 1 for more information.

*Investment Options* – Participants may direct contributions to selected investments as made available and determined by the Plan administrator. Participants may change their investment options at any time throughout the year via direct phone and internet access to the third-party administrator.

*Payment of Benefits* – On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the vested interest in his or her account or may elect to leave the value of the vested interest in his or her account in the appropriate investment funds until normal retirement age. The Plan will allow an in-service distribution on account of hardship upon meeting the financial burden statutory requirements.

### Note 1—Description of the Plan (continued)

*Forfeited Accounts* – Any amounts forfeited would first be used to pay Plan expenses. If forfeitures exceed the Plan expenses, the remaining amounts would be used to reduce future employer contributions. At February 2, 2024 and December 31, 2023, there were no forfeited nonvested balances.

### Note 2—Summary of significant accounting policies

*Basis of Presentation* – The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”) under the liquidation basis of accounting.

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 3 – *Fair Value Measurements* for further discussion).

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

*Administrative Expenses* – Unless stated otherwise, Plan administrative expenses are generally paid by the Company. The Plan does allow for certain expenses to be paid from Plan assets, such as trustee fees, recordkeeping fees, investment advisor fees, and expenses deducted at the investment fund level.

*Risks and Uncertainties* – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

*Payment of Benefits* – Benefits are recorded when paid. As of February 2, 2024 and December 31, 2023, there were no benefit payments requested and not yet disbursed.

*Excess Contributions Payable* – Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding increase in benefit payments. The Plan distributed the excess contributions to the applicable participants in the subsequent period.

### Note 3—Fair value measurements

U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset and liability, in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used to value the investments at February 2, 2024 and December 31, 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

*Money Market Funds* – These investments are valued in accordance with Rule 2a-7 of the Investment Company Act of 1940 at amortized cost, which approximates fair value. Under the amortized cost method, discount or premium is amortized on a constant basis to the maturity of the security. These investments are classified within Level 2 of the valuation hierarchy.

*Mutual Funds* – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4—Information certified by the Plan's qualified institution (unaudited)**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company (the "qualified institution"), has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments, at fair value, as shown in the statements of net assets available for benefits as of February 2, 2024 (in liquidation) and December 31, 2023 (in liquidation).
- Net appreciation in fair value of investments and dividends as shown in the statement of changes in net assets available for benefits for the period ended February 2, 2024 (in liquidation).

The Plan's independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements.

**Note 5—Party-in-interest transactions**

Trustee and recordkeeping services, and distribution fees paid to Ascensus Trust Company by the Plan totaled \$7,065 for the period ended February 2, 2024. These fees were deducted directly from distributions to participants and therefore are presented in the total of benefit payments. Ascensus Trust Company is the qualified institution, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan sponsor utilizes an investment advisor whose fees are deducted from the Plan's assets on a quarterly basis. These transactions qualify as party-in-interest transactions and total fees paid to the investment advisor totaled \$440 for the period ended February 2, 2024.

**Note 6—Plan termination**

As noted in Note 1, effective August 31, 2023, the Company approved a plan of termination, and management determined that liquidation was imminent. Contributions to the Plan ceased effective August 31, 2023, and no new employees are eligible to participate in the Plan after August 31, 2023. Final distributions were based on all participants being 100% vested.

**Note 7—Tax status**

The Plan uses a prototype plan document sponsored by Ascensus Trust Company. Ascensus Trust Company received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, which stated the prototype document satisfies the applicable provisions of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the opinion letter. The Plan itself has not received a determination letter from the IRS. However, the Plan’s administrator and management believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to re-evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of February 2, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
