INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Cardiovascular Medicine, P.C. (the Company) 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Cardiovascular Medicine, P.C. (the Company), who have completed a minimum of 1,000 hours of service in 12 consecutive months and are at least 19 years old. The Plan allows employees, once they become eligible to participate, to enter the plan the first day of the Plan Year quarter following eligibility. The Plan was established under Section 401(a) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company has established a Board of Trustees that is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Participants may contribute a percentage of their eligible compensation to the Plan in the form of a salary reduction up to the maximum percentage allowable by certain Internal Revenue Service Code Sections. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company made safe harbor nonelective contributions of 3 percent of compensation for all eligible participants for the year ended December 31, 2023. The Company may make discretionary profit sharing contributions to the Plan as determined annually by their Board of Directors. Participants who have completed 1,000 hours of service during the plan year and who are employed on the last day of the plan year, as well as those who terminate employment due to death, disability or normal retirement, will receive an allocation of the Company's discretionary profit sharing contribution. The Company made discretionary profit sharing contributions of \$0 and \$1,458,921 for the period and year ended February 29, 2024 and December 31, 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's safe harbor nonelective and discretionary profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows each participant to choose their own investment mix for salary deferrals and employer contributions. If a participant does not designate any investment options, all contributions to their account will be deposited into the American Funds Balanced Fund.

Vesting

Participants are immediately vested in their voluntary contributions and employer safe harbor non-elective contributions plus actual earnings (losses) thereon. A participant will vest in the discretionary employer non-elective contributions on a five-year graduated vesting schedule. Participants will also fully vest in Company contributions if they terminate employment due to total and permanent disability or death.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Plan Merger

Effective February 29, 2024, the Cardiovascular Medicine, P.C. 401(k) Profit Sharing Plan (Plan) was merged into the CVAUSA 401(k) Plan. As a result of the merger, the plan was frozen for any payroll contributions for periods after December 31, 2023 and effective January 1, 2024 all contributions were made into the CVAUSA 401(k) Plan.

Hardship Withdrawals

Hardship distributions are permitted from pre-tax and Roth elective deferral accounts, employer nonelective safe harbor and rollover accounts.

Forfeitures

Any forfeiture arising under the Plan is used to reduce future Company contributions. Forfeitures of \$0 and \$8,000 were used to reduce Company contributions during the period and year ended February 29, 2024 and December 31, 2023, respectively. Unused forfeitures as of February 29, 2024 and December 31, 2023 were \$0 and \$12,435, respectively.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000, or 50% of the employee sourced account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. The term of the loan may exceed five years for loans used to acquire a principal residence. Participants may only have one loan of each type (general purpose and principal residence) outstanding at a time.

Payments of Benefits

On termination of service, a participant may elect to receive either a lump-sum payment, an annuity contract or an installment payment over a fixed number of years. The amount paid is equal to participant's contributions and earnings thereon plus their vested share of the Company's contributions and earnings. Accounts with a vested balance of less than \$5,000 will be distributed as a rollover to an individual retirement account designated by the Plan Administrator as soon as administratively feasible if no election is made by the participant upon termination. The Plan also allows for in-service distributions and hardship withdrawals under certain circumstances as defined in the plan agreement.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ significantly from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. If available, quoted market prices are used to value investments. Shares of mutual funds are valued at prices, which represent the net asset value of shares held by the Plan at year end. See Note 6 for further discussion regarding the valuation methodology used by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Payments of benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions in accordance with the terms of the plan agreement. For Department of Labor reporting on Form 5500, the receivables are still included as investments and titled Participant Loans.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company. Fees related to the administration of participant notes receivable and withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses for accounts certified by Vanguard Fiduciary Trust Company are included with the net appreciation in fair value of investments. Investment related expenses for self-directed brokerage accounts (SDBA) are charged directly to participants' SDBA.

NOTE 3 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Vanguard Fiduciary Trust Company, Plan Trustee. Vanguard held the Plan's investment assets and executed investment transactions. The Plan uses the services of an outside investment consultant and incurs fees related to investment consulting. These transactions qualify as party-in-interest transactions. The total fees paid by the Plan for these administrative and investment-consulting services amounted to \$6,840 and \$95,387 for the period and year ended February 29, 2024 and December 31, 2023, respectively.

The Plan also incurs fees for the annual audit. The Plan Sponsor, Cardiovascular Medicine, P.C. pays these fees. These transactions qualify as exempt party-in-interest transactions.

NOTE 4 - TAX STATUS OF THE PLAN

The Plan has adopted a volume submitter plan that was sponsored by Vanguard Fiduciary Trust Company (Vanguard). The volume submitter plan has received an opinion letter from the Internal Revenue Service as to its qualified tax status, and is, exempt from federal income taxes. The volume submitter plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since, the plan sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the income tax code.

NOTE 4 - TAX STATUS OF THE PLAN (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

The Plan's policy is to include penalties and interest associated with income taxes as income tax expense and interest expense, respectively. The Plan did not incur any penalties or interest on income taxes for the periods being reported.

NOTE 5 - INFORMATION CERTIFIED BY THE CERTIFYING ENTITY (UNAUDITED)

At February 29, 2024 and December 31, 2023, the Plan's investments were held by Vanguard Fiduciary Trust Company (Vanguard). The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by Vanguard as complete and accurate in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule, related to the following assets:

NOTE 6 - FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

NOTE 6 - FAIR VALUE MEASUREMENTS (Continued)

Level 2 - Inputs to the valuation methodology include -

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of the observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 29, 2024 and December 31, 2023.

Common collective trust fund - The Plan invests in the Vanguard Retirement Savings Trust III (the Trust) Fund. The Trust invests primarily in synthetic investment contracts backed by high-credit-quality fixed income investments and traditional investments issued by insurance companies and banks. The Trust seeks to provide current and stable income, while maintaining a stable share value of \$1. Participants with money in the Trust can transfer some or all of the funds into a stock, balanced or bond fund with an average duration of 3 years or more. The funds must remain there for 90 days before they can be transferred into a shorter-term bond or money market fund. The net asset value (NAV) is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Mutual funds - Valued based on quoted prices in active markets on which the funds are traded.

Common stocks - Valued based on unadjusted quoted prices in the active markets on which the stocks are traded.

The preceding methods may produce a fair value calculation that is not indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 - FORM 5500

Department of Labor regulations regarding Form 5500 Annual Return/Report of Employer Benefit Plan require the income and net investment gain (realized and unrealized) on both common collective trusts and self-directed brokerage accounts to be reclassified and reported with other forms of investment income. As a result, there are differences between the amounts of interest and dividend income and net investment gains (losses) reported on the financial statements and on the Form 5500.
