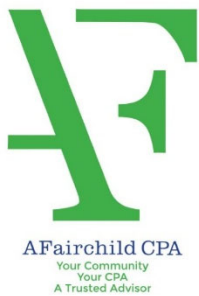

## Independent Auditor's Report

To the Plan Administrator of the  
Genesys Aerosystems 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Genesys Aerosystems 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 29, 2024 and September 30, 2023, and the related statement of changes in net assets available for benefits for the five months ended February 29, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Genesys Aerosystems 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from Minnesota Life Insurance Company as of February 29, 2024 and September 30, 2023, and for the five months ended February 29, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter**

As discussed in Note 2 to the financial statements, on March 1, 2024, the Plan transferred all Plan assets and merged with the Moog Inc. Employees' Retirement Plan. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Genesys Aerosystems 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. **NOTE 1 - PLAN DESCRIPTION**

The following description of the Genesys Aerosystems 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is sponsored by S-TEC Corporation (the "Company" or "Plan Sponsor"). The Plan was established in May of 2014.

The Plan is a defined-contribution, safe harbor plan, covering all employees who have attained the age of 18. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The financial statements and supplemental schedule of the Plan have been consistently prepared in conformity with accounting principles generally accepted in the United States of America (US GAAP), and with ERISA.

The Plan was amended effective January 1, 2022 to a Plan Year ending on September 30<sup>th</sup>. The Plan's records are maintained on a twelve-month period of time, except for the short Plan Year which began on January 1, 2022 and ended September 30, 2022. Subsequent Plan years began on October 1<sup>st</sup>.

The assets were merged with Moog Inc.'s Employees' Retirement Plan on March 1, 2024. See note 2.

Plan Administration

The Plan is administered by the management of the Company. The Company determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors. Securian Financial Group is responsible for the recordkeeping for the Plan. Minnesota Life Insurance Company (the "Custodian") is responsible for the custody and administration of the Plan's assets.

Contributions

Eligible employees, as defined, may elect to defer and contribute up to 100% of their compensation to the Plan, with an annual maximum of \$22,500 (\$30,000 if the employee is age fifty or older) for the calendar year ended December 31, 2023. Participants may designate all or any portion of their salary deferral as a Roth contribution.

The plan allows for a discretionary match and the Company matches 100% of the participant's elective deferrals up to 4% of the participant's eligible compensation, plus 50% of the participant's elective deferrals that exceed 4% of the participant's eligible compensation up to 6% of the participant's eligible compensation.

**NOTE 1 - PLAN DESCRIPTION (CONTINUED)**

All contributions made by the Company and the participants are invested based upon participant elections. All employees, employed on the last day of the Plan year, regardless of the amount of service completed, are eligible to participate in the profit sharing contribution for that Plan year. Participants who separate due to death, disability, termination of employment after normal retirement age or after early retirement date, as defined, will share in the profit sharing plan in the year of separation. The discretionary profit sharing contribution as determined by management is allocated based on each employee's eligible compensation as a percentage of the total compensation of all employees eligible to share in the contribution.

Participant Accounts

Each participant's account is credited with the participant's salary reduction contribution, if applicable, an allocation of Plan earnings or losses which are allocated based on the earnings or losses of the participant's selected investments and the Sponsor's net contributions, if applicable.

Vesting

Participants' elective deferrals and rollovers are immediately vested. Contributions made by the employer for discretionary matches and profit sharing are vested based on the number of years of continuous service. A participant vests 30% after one year, 70% after two years and 100% after three years of credited service. Additionally, participants or their beneficiaries become immediately and fully vested in their Company contributions and related earnings upon full and permanent disability or death.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, vested benefits less than \$5,000 will be paid in a single lump-sum payment based on the participant's vested balance. Other benefits are paid at the participants' direction. Prior to termination of employment, participants may take withdrawals for financial hardship, as defined, death, or at the attainment of age 59 1/2.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In the event of termination of the Plan, all participants will become fully vested.

Forfeited Accounts

Any forfeitures from nonvested accounts are used to pay administrative expenses, with the remaining forfeitures used to reduce Plan Sponsor contributions. The Plan had \$16,302 in forfeited account balances at September 30, 2023. The Plan had no forfeited account balance at February 29, 2024.

**NOTE 1 - PLAN DESCRIPTION (CONTINUED)**

Notes Receivable from Participant Loans

Participants are permitted to borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of the vested account balance or \$50,000. A participant may have no more than one loan outstanding at any given time. The loans are secured by the remaining balance in a participant's account and bear a commercially reasonable fixed rate of interest at the time of the loan as determined by the administrator of the Plan. Loans are required to be repaid within five years. Loans are repaid ratably through biweekly payroll deductions. However, if the loan is for the purchase of a principal residence, the administrator may permit a longer repayment term. If employment is terminated, a loan generally becomes due and payable in full immediately. Loan refinancing is permitted under the Plan.

Administrative Expenses

Certain administrative expenses of the Plan may be paid by the Plan Sponsor. These costs include certain legal, accounting and administrative fees. Expenses paid by the Plan include investment management fees, recordkeeping fees, and other costs not paid by the Plan Sponsor.

**NOTE 2 - PLAN MERGER**

On March 1, 2024, the Plan was merged into the Moog Inc. Employees' Retirement Plan. The following net assets were transferred into the Moog Inc. Employees' Retirement Plan:

**NOTE 3 - SIGNIFICANT ACCOUNTING POLICIES**

The following is a summary of significant accounting policies followed by the Plan in preparing its financial statements.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with US GAAP and have been consistently applied.

**NOTE 3 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Investment Valuation and Income Recognition

Investments of the Plan are stated at fair value or at estimated fair value. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses for investments purchased and sold during the Plan year.

Payment of Benefits

Benefits are recorded when paid.

Tax Status

The Company has adopted the Minnesota Life Insurance Company Defined Contribution Prototype Plan. The Internal Revenue Service ruled on March 31, 2014 that the Plan qualifies under Section 401(a) of the Internal Revenue Code, and therefore, is not subject to tax under the present income tax law.

US GAAP requires the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor. As of February 29, 2024, the Plan Sponsor has not identified any uncertain tax positions for the Plan.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with US GAAP requires the Plan's management to make estimates and assumptions. These estimates and assumptions affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements, as well as reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. US GAAP also establishes a fair value hierarchy, which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

**NOTE 3 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Three levels of inputs may be used to measure fair value:

- Level 1: Quoted prices in active markets for identical assets or liabilities.
- Level 2: Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3: Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

An asset or liability's classification within the fair value hierarchy is based on the lowest level of significant input to its valuation. Fair value estimates are made at a specific point in time and the methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair value. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Pooled separate account investments are valued at estimated net asset value as a practical expedient for fair value as reported by the issuer, based on the fair value of the underlying investments plus contributions and less any distributions and fees paid by the fund for its expenses.

The Plan also invests in a Guaranteed Return Account which is carried at contract value as reported by the trustee. See Note 5.

Investments reported at estimated net asset value as a practical expedient for fair value and fully benefit responsive investment contracts reported at contract value are not required to report within the fair value hierarchy table.

**NOTE 4 - INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)**

The plan administrator has elected the method of annual reporting permitted by 29 CFR 2520.103-8 of ERISA. Accordingly, as permitted under such election, the plan administrator has instructed the Plan's independent auditor not to perform any auditing procedures with respect to the following investment information, and related activity certified by the Custodian as accurate and complete, except for comparing such information to corresponding information included in the Plan's financial statements.

**NOTE 5 - GUARANTEED RETURN ACCOUNT**

In 2014, the Plan entered into a guaranteed investment contract with the Custodian. The Custodian maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.0%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract is a fully benefit-responsive investment contract and therefore is reported at contract value, rather than fair value.

The Plan's ability to receive amounts due under the contract is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**NOTE 6 - EXCESS CONTRIBUTION PAYABLE**

Amount payable to employer totaling \$422 for contributions in excess of amount recorded as employer contributions payable, with a corresponding reduction to the five months ended February 29, 2024 contribution. The Plan transferred all assets to the Moog Inc. Employees' Retirement Plan on March 31, 2024. The Plan will work with the new record keeper to have the funds removed. There were no excess contributions for the year ended September 30, 2023.

**NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary to the Plan or party rendering services to the Plan, the employer and certain others. As such, transactions conducted with the Sponsor, auditors, trustee, custodian and third party administrator qualify as party-in-interest transactions.

The Plan invests in certain funds managed by the Trustee which qualify as party-in-interest transactions.

**NOTE 8 - RISKS AND UNCERTANTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 - SUBSEQUENT EVENTS**

Subsequent events were evaluated through December 13, 2024 which is the date the financial statements were available to be issued.
