All participant account balances and Plan assets were merged into the SOBI, Inc 401(k) Retirement Plan on the date of the merger. Our opinion is not modified with respect to this matter.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of Plan

The following description of the CTI BioPharma Corp. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering substantially all employees of CTI BioPharma Corp. ("the Company") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Plan Merger - On June 26, 2023, the Company was purchased by Swedish Orphan Biovitrum Corporation (SOBI). The Company adopted a resolution effective January 2, 2024, to merge the Plan with the SOBI Inc 401(k) Retirement Plan (SOBI Plan). In anticipation of the merger, the Plan sold all investments with a trade date on December 29, 2023, the sale was not settled until January 2, 2024, as a result, the pending transaction was reported as an amount due from broker as of December 31, 2023. Assets of \$18,384,655 were transferred to the SOBI plan in January 2024. As discussed in note 4, forfeitures owed to terminated participants will be paid out of the SOBI Plan. The transfer consisted of the following:

Contributions - Participants may elect to contribute up to 80% of their eligible compensation to the Plan as pretax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants are also allowed to contribute amounts representing distributions from other eligible retirement plans (rollover contributions).

The Company may make discretionary matching and nonelective contributions as determined by the Company's Board of Directors. For the period from January 1, 2024 to January 2, 2024, there were no discretionary matching or nonelective contributions.

Contributions are subject to certain limitations set by the Internal Revenue Service (IRS).

Participant Accounts - Each participant's account is credited with the participant's contributions and matching contributions, as well as allocations of the Company's nonelective contributions (if any) and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on years of continuous service. A participant is 100% vested after three years of credited service.

Note 1 - Continued

Notes Receivable From Participants - Participants may borrow from their account \$1,000 and \$50,000 from their fund accounts, limited to 50% of the vested portion of their account balances at the date of the loan. Loans are repaid in equal semi-monthly installments of principal and interest over terms ranging from one to five years. Loans used to acquire a primary residence may provide for periodic repayment over a reasonable period of time that may exceed five years. Loans are secured by the balance in the participant's account. Interest rates are set at 1% above the prime rate, as defined.

Benefit Payments - Upon termination of service, death, disability, or retirement, a participant or his or her beneficiary shall be entitled to receive a lump-sum amount equal to the value of the participant's vested value in his or her account. Withdrawals may be made in the event of certain other conditions, as specified in the plan document, such as financial hardship or termination of the Plan.

Forfeitures - Forfeitures may be used to offset employer matching contributions. At December 31, 2023 forfeited nonvested accounts totaled \$1,858; which, were transferred to the SOBI Plan on January 2, 2024.

Note 2 - Summary of Accounting Policies

Basis of Accounting - The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2023.

Benefits Paid to Participants - Benefits paid to participants are recognized when they are paid.

Subsequent Events - The Plan's management has evaluated subsequent events through December 8, 2024, the date on which the Plan's financial statements were available to be issued.

Note 3 - Certified Investments

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investment income or loss for the period January 1, 2024 to January 2, 2024, that is disclosed in the accompanying financial statements, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

Note 4 - Plan Termination

During 2023, SOBI acquired the Company. As a result of the acquisition, the Company terminated various employees during 2023 and determined there was a partial termination. All affected participants became fully vested in their accounts.

Note 5 - Tax Status

The Company adopted an ADP, LLC pre-approved plan document. ADP, LLC received an approval letter from the IRS dated October 6, 2020, which states that the form of the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan’s management believes that the Plan is designed and currently being operated, in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 7 - Party-in-Interest Transactions

ADP provides recordkeeping services for the Plan, and as such, fees paid by the Plan to ADP qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.
