NOTES TO FINANCIAL STATEMENTS

**NOTE A - DESCRIPTION OF PLAN**

The following brief description of Yasufuku U.S.A., Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. The Plan covers employees of Yasufuku U.S.A., Inc. (the Company). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**Plan Merger.** The Plan was amended effective January 1, 2024, to merge into the ADP Totalsource Retirement Savings Plan. As of March 31, 2024, all participants' accounts were transferred to the multiemployer plan.

**General.** The Plan, which became effective January 1, 1993, and was most recently amended January 1, 2020, was a defined contribution plan covering certain groups of employees of the Company, who had attained the age of 21 and had completed one year of service with at least 1,000 hours in the Plan year. Entry was available on the first day of the Plan year or the first day of the seventh month of the Plan year after the employee's completion of the participation requirements. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors was responsible for oversight of the Plan, determined the appropriateness of the Plan's investment offerings, and monitored investment performance.

**Elective Contributions.** Eligible employees could make pre-tax salary reduction contributions up to 75% of plan compensation, as defined by the Plan, not to exceed Internal Revenue Code limitations. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined contribution plans (rollover). The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 2% of eligible compensation and their pre-tax contributions were invested in a designated target date fund that matched their retirement date based on their birthday until changed by the participant.

**Employer Contributions.** The Company could make a discretionary matching contribution or discretionary nonelective contribution on behalf of each eligible participant. Discretionary matching contributions were determined each Plan year and were based on elective deferrals. Nonelective contributions were based on a uniform percentage of participant compensation. Any discretionary contributions made were on behalf of all participants with at least 1,000 hours of service in the Plan year and who were employed on the last day of the Plan year. The Company did not elect to make a discretionary matching contribution during the period ended March 31, 2024 or year ended December 31, 2023. During the year ended December 31, 2023, the total discretionary nonelective contribution was \$30,000.

**Participant Accounts.** Each participant's account was credited with the participant's contribution, and allocations of the Company's contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting.** Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant became 100% vested after three years of credited service, if they were an employee and reached normal or early retirement age, upon death, or total permanent disability.

NOTES TO FINANCIAL STATEMENTS

**NOTE A - DESCRIPTION OF PLAN - CONTINUED**

**Notes Receivable from Participants.** Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested interest in the Plan. The loans were secured by the balance in the participant's account. The loan interest rate was set at 1% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

**Payment of Benefits.** On termination of service due to death, disability, retirement, or termination, a participant may elect to receive a cash distribution in the form of: (a) a lump sum or (b) substantially equal installments or (c) partial withdrawals with no minimum required. Distributions could be made to a participant who had not separated from service upon reaching normal retirement age. Distributions were to be made as soon as administratively feasible at the participant's election.

Termination of employment prior to normal retirement requires distribution if the account balance does not exceed \$5,000. The participant could elect to receive: (a) a direct rollover to an IRA or another qualified retirement plan or (b) a payment in cash, subject to federal tax withholding and generally a penalty tax if under age 59½. If no election was made, the benefit could be rolled over to an IRA. If the account balance was less than \$1,000, the distribution would be paid in cash. If the vested account balance was greater than \$5,000, the participant could defer distribution until normal retirement age or further defer to age 73.

Hardships withdrawals were permitted for purposes specified by the Internal Revenue Code. Withdrawals could not exceed the amount of financial need plus any amount necessary to pay taxes or penalties as a result of the withdrawal from accounts that are fully vested.

**Forfeited Accounts.** Forfeiture accounts were used to reduce the Company's discretionary contribution and pay administrative expenses. At March 31, 2024 and December 31, 2023, these accounts totaled \$0 and \$1,022, respectively. During the year ended December 31, 2023, \$340 of forfeitures were used to pay administrative expenses. The Plan transferred the balance in their forfeitures account to the new multiemployer plan by March 31, 2024.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting.** The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition.** The Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan utilized a framework to prioritize the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

**Investment Valuation and Income Recognition - Continued.**

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full-term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. See Note C for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in net assets includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Employer Contribution Receivable.** Employer contribution receivable was measured at the amount owed to participants by the Company at December 31, 2023. There was no employer contribution receivable at March 31, 2024.

**Notes Receivable from Participants.** Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses had been recorded as of March 31, 2024 and December 31, 2023. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan agreement.

**Payment of Benefits.** Benefits were recorded when paid.

**Expenses.** Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Expenses incurred for the administration of the Plan were the responsibility of the Plan. If incurred directly by the Plan, these expenses were included in administrative expenses on the statement of changes in net assets available for benefits. Other investment related expenses were included in net appreciation of fair value of investments.

**Use of Estimates.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**NOTE C - FAIR VALUE**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used during the period January 1, 2024 to March 31, 2024 and for the year ended December 31, 2023.

*Money market fund:* Money market funds were valued at cost plus accrued interest. The money market fund held by the Plan was deemed to be actively traded.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that are registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE D - PLAN TERMINATION**

On January 1, 2024, the Plan merged with a multiemployer plan and transferred substantially all asset into the new plan in March 2024.

NOTES TO FINANCIAL STATEMENTS

**NOTE E - TAX STATUS**

The Plan was based on the Non-Standardized Pre-Approved Profit-Sharing/Money Purchase/CODA Plan of Union Bank & Trust Company, which received a determination letter from the IRS dated June 30, 2020, stating that the Plan was designed in accordance with provisions of the Internal Revenue Code (IRC). Although the Plan had been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

For the period January 1, 2024 to March 31, 2024 and the year ended December 31, 2023, the Plan had no tax liability on unrelated business activity. The Plan believed that it had appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements. The Plan's Federal Returns for the period January 1, 2024 to March 31, 2024 and years ended December 31, 2023, 2022, and 2021, are subject to examination by the IRS, generally for three years after they were filed.

**NOTE F - RISKS AND UNCERTAINTIES**

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could have occurred in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE G - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements, including investments and notes receivable from participants held at March 31, 2024 and December 31, 2023, and net appreciation in fair value of investments, dividends, realized gains, and interest from notes receivable from participants for the period January 1, 2024 to March 31, 2024 and for the year ended December 31, 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Union Bank & Trust Company (the trustee of the Plan). **NOTE H - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

The Plan received custodial services from Union Bank & Trust Company and its affiliates, the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The Plan also paid for recordkeeping services. Fees paid by the Plan were \$3,293 and \$20,041 for the period January 1, 2024 to March 31, 2024 and for the year ended December 31, 2023, respectively. The Plan has amounts due to the party-in-interest totaling \$0 and \$3,211 at March 31, 2024 and December 31, 2023, respectively. Additional indirect compensation was paid to Matrix Clearance and Settlement, which is included in net appreciation in fair value of investments.
