Dear Sir/Madam

In reference to the Tebarco Mechanical Profit Sharing Plan, ("the Plan"), the required Independent Qualified Public Account (IQPA Report) report as of December 17, 2024 to accompany Form 5500 has been delayed. We are diligently working to have the audited financial report completed and will provide it as soon as possible. Below is an outline of the reasons for delay.

Brown and Nelms has been Tebarco's CPA/Certified Public Accountant since 2015. Brown and Nelms provided the 2020 and 2021 401(k) audits for the Plan and was scheduled to audit 2022. In 2022, Brown and Nelms was acquired by Carr, Riggs & Ingram. Also, during that time period Tebarco engaged the services of a PEO/Professional Employer Service (ADP) and assigned payroll and benefit services to ADP including the management and oversight of the Plan.

There were miscommunications regarding who would be responsible for providing an audit of the Plan's financial statements for 2022. Ultimately, neither ADP nor Carr, Riggs & Ingram were able to provide timely audits to accompany Form 5500. Therefore, the Plan has engaged Rushton, LLC to complete the necessary audit. We anticipate that this will be completed by the end of January 2025.
