Report on the Financial Statements

We were engaged to audit the accompanying financial statements of Red Card Systems LLC Employees Savings Trust (the Plan) which comprise the statement of net assets available for benefits as of January 7, 2020, and the related statement of changes in net assets available for benefits for the year then ended and the related notes to the financial statements.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditors' Responsibility

Our responsibility is to express an opinion on these financial statements based on conducting the audit in accordance with auditing standards generally accepted in the United States of America. Because of the matter described in the *Basis for Disclaimer of Opinion* paragraph, however, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion.

Basis for Disclaimer of Opinion

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the plan administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information summarized in Note 3, which was certified by Transamerica Life Insurance Company, the trustee of the Plan, except for comparing such information with the related information included in the 2020 financial statements. We have been informed by the plan administrator that the trustee holds the Plan's investment assets and executes investment transactions. The plan administrator has obtained a certification from the trustee as of and for the year ended January 7, 2020, that the information provided to the plan administrator by the trustee is complete and accurate.

Disclaimer of Opinion

Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* paragraph, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the 2017 financial statements. Accordingly, we do not express an opinion on the 2020 financial statements.

Other Matter - 2019 Financial Statements

The financial statements of the Plan as of December 31, 2019 were audited by predecessor auditors. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the plan administrator instructed the predecessor auditors not to perform, and they did not perform, any auditing procedures with respect to the information certified by the trustee. Their report, dated July 31, 2020, indicated that (a) because of the significance of the information that they did not audit, they were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion, and accordingly, they did not express an opinion on the financial statements (b) the form and content of the information included in the financial statements other than that derived from the information certified by the trustee, were presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Report on Form and Content in Compliance with DOL Rules and Regulations 2020

The form and content of the information included in the 2020 financial statements, other than that derived from the information certified by the trustee, have been audited by us in accordance with auditing standards generally accepted in the United States of America and, in our opinion, are presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

January 7, 2020 and December 31, 2019

Note 1 - Description of plan:

The following description of the Red Card Systems LLC Employees Savings Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan sponsor is Red Card Systems, LLC. (the Company, Plan Sponsor, or Plan Administrator). The Plan is a defined contribution plan covering substantially all employees of the Company who become eligible for participation on their first day of employment, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

The Plan sponsor, and its single owner, Red Card Holdings, LLC had a merger transaction with Zelis Healthcare during the year ended December 31, 2019. As a result of the merger, the Plan was terminated subsequent to the year-ended December 31, 2019 and plan assets totaling \$8,968,868 and loans of \$115,574 were transferred on January 7, 2020, to the Zelis Healthcare 401(k) Retirement Plan (Zelis Plan).

Contributions

Participant contributions could be made, at the option of the participant, up to an annual maximum of 75% of the participant's pre-tax annual compensation subject to the annual limits set under the Internal Revenue Code (IRC). Participants age 50 or older during the year were eligible to make catch-up contributions subject to IRC limitations. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company made safe harbor contributions equal to 3% of eligible compensation that a participant contributed to the Plan. There were no participant or safe harbor contributions for the period ended January 7, 2020. The Company also made a discretionary profit sharing contribution to be determined annually based on a percentage of eligible employee salaries. The Company did not make a discretionary profit sharing contribution for the period ended January 7, 2020.

Participants directed the investment of their contributions into various investment options offered by the Plan. Through Transamerica Life Insurance Company (Transamerica), the Plan offered various registered investment company investments held in a pooled separate account and a guaranteed interest account held in the insurance company-administered general account.

Note 1 - Description of plan - continued:

Participant accounts

Each participant's account was credited with the participant's contributions, an allocation of the Company's safe harbor and/or profit sharing contributions, and Plan earnings, and was charged with withdrawals, an allocation of Plan losses, and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant was entitled was the benefit that can be provided from the vested portion of the participant's account.

Vesting

Participants were immediately vested in their voluntary contributions and safe harbor contributions, plus actual earnings thereon. Vesting in the Company's safe harbor and discretionary profit sharing contributions and earnings thereon was based on years of service. Vesting in employer profit sharing contributions was 0% until three years of credited service, at which point the participant became 100% vested. The Plan Sponsor has not made a profit sharing contribution since the inception of the Plan. Participants are also immediately vested upon reaching normal or early retirement age, as defined in the plan document, or upon death or disability while still employed by the Company.

Notes receivable from participants

Participants may borrow from the Plan in any amount greater than or equal to \$1,000 up to 50% of the participant's vested account balance, not to exceed \$50,000. Note terms are for a period not exceeding five years unless for the purchase of a principal residence, in which case the maximum note repayment period must be consistent with commercial practices. Notes are secured by the balance in the participant's account and bear interest at an agreed-upon percentage based on prevailing market rates. Principal and interest are paid ratably through payroll deductions. Participants are allowed one outstanding note receivable. There were no new notes taken during the period ended January 7, 2020. All outstanding notes were transferred to the Zelis Plan.

Payment of benefits

A participant is entitled to receive a lump-sum payment equal to the vested value of his or her account upon attainment of age 59½, termination of service, retirement, disability, or death. If the amount of the distribution is \$5,000 or less, participants received a lump-sum distribution as soon as administratively feasible after termination of employment. Participants with account balances exceeding \$5,000 had their funds maintained in the Plan until a written request was submitted to the Plan Sponsor for payment.

Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Company and are excluded from these financial statements. The Company reserves the right to elect to pay, or have the Plan pay, administrative costs in the future. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Forfeited accounts

At January 7, 2020 and December 31, 2019, forfeited nonvested accounts totaled \$0 and \$17, respectively. Forfeited non-vested accounts will be used to reduce future employer contributions or pay administrative expenses. During the period ended January 7, 2020, no forfeiture balances were used to reduce employer contributions or pay administrative expenses as the \$17 balance was transferred to the Zelis Plan.

Note 2 - Summary of significant accounting policies:

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investments measured at contract value

The Plan held a guaranteed investment contract. This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The value of the guaranteed investment contract at December 31, 2019 was \$642,631. There were no investments held at January 7, 2020.

Investments measured at contract value - continued

The contract issuer was contractually obligated to repay the principal and interest at a specified interest rate that was guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The contract could not be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with benefit-responsive investment contract was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and other providers.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date.

Payment of benefits

Benefits are recorded upon distribution to participants.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of January 7, 2020 or December 31, 2019. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

New accounting pronouncements

In August 2018, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update (ASU) No. 2018-13, Fair Value Measurement (Topic 820) Disclosure Framework - Changes to the Disclosure Requirements for Fair Value Measurement (ASU 2018-13). ASU 2018-13 changes the fair value measurement disclosure requirements of Accounting Standards Codification 820, Fair Value Measurement (ASC 820). Applicability of the provisions in ASU 2018-13 can depend on whether the reporting entity is a non-public entity. Eliminated and modified disclosure requirements under ASU 2018-13 impact the reporting of transfers between Level 1 and Level 2 assets (defined in Note 4), Level 3 asset disclosures, and disclosures about investments in certain entities valued at net asset value. ASU 2018-13 is effective for all entities for fiscal years beginning after December 15, 2019. Early adoption was permitted. Management adopted ASU 2018-13 effective January 1, 2020. The adoption of ASU 2018-13 did not have a material impact on the Plan's financial statements.

Subsequent events

The Plan has evaluated subsequent events through December 11, 2024, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of January 7, 2020, have been incorporated into these financial statements.

Note 3 - Information certified by Transamerica:

Transamerica held the Plan's investment assets and executed investment transactions. Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2019, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the period ended January 7, 2020, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Transamerica.

Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan held no investments as of January 7, 2020.

The following is a description of the valuation methodology used for assets and liabilities measured at fair value.

- The fair value of pooled separate accounts is based on the fair value of the underlying mutual funds held by the pooled separate accounts, as adjusted for earnings and certain expenses. Each pooled separate account holds shares of a single underlying fund, and although the underlying funds make distributions from time to time, the pooled separate accounts never make any distributions to unit holders. Distributions received from an underlying fund are reinvested into additional shares of the underlying fund and the reinvestment of such distributions results in the pooled separate account holding more fund shares, at a lower per share price, but the total dollar amount invested does not change. In addition, the pooled separate accounts levy administrative maintenance charges and can also include Cost of Class Funds. These are paid by each pooled separate account unit class by selling sufficient shares of respective underlying funds to pay the charges. These charges are levied daily at a class level for each pooled separate account, and therefore reduce the price per unit of each class of a pooled separate account from what it would be in the absence of these charges.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodology are appropriate and consistent with other market participants, the use of different methodology or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Related-party transactions:

Certain Plan investments were units of pooled separate accounts or guaranteed investment contract managed by Transamerica. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation.

Note 6 - Plan termination:

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts. Effective December 2019, the Plan merged into the Zelis Plan and all participants became eligible to participate in the Zelis Plan. As of January 7, 2020, all assets had to be transferred into the Zelis Plan.

Note 7 - Tax status:

The underlying volume submitter plan has received an opinion letter from the IRS dated March 31, 2014, stating that the form of the Plan is qualified under Section 401(a) of the IRC and; therefore, the related trust is tax-exempt. The Plan Sponsor has determined that it is eligible to, and has chosen to, rely on the current IRS volume submitter plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
