Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Deep South Delivery LLC 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

September 30, 2023

1. Description of the Plan

The following brief description of the Deep South Delivery LLC 401(k) Profit Sharing Plan & Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

General

The Plan was a defined contribution 401(k) plan covering all eligible employees of Deep South Delivery LLC (the “Company”). The Plan became effective January 1, 2022. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and qualifies under Section 401(a) of the Internal Revenue Code (the “IRC”). The custodian of the Plan is Mid Atlantic Trust Company (“Mid Atlantic”). Effective May 2, 2023, the Plan merged into the Norlyn Enterprises Inc. 401(k) Profit Sharing Plan & Trust and all assets transferred out by September 30, 2023.

Eligibility

Employees were eligible to participate in the Plan upon attainment of age 18 and the completion of two months of service. Union employees and nonresident aliens were not eligible to participate. The entry date upon meeting eligibility is the first day of each month. Newly eligible employees were automatically enrolled in the Plan with a deferral percentage of 3% as soon as administratively feasible, unless the employee elects to opt out of the Plan. The deferral percentage was automatically increased annually by 1% up to a maximum of 10%.

Contributions

Participants could contribute a percentage of their eligible compensation on a pre-tax and after-tax basis not to exceed the annual limit established by the IRC. Participants who have attained age 50 before the end of the year were eligible to make catch-up contributions in excess of the annual deferral limitation. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company could make additional discretionary employer matching contributions and profit sharing contributions for eligible participants that were employed on the last day of the Plan year, although none were made in 2023. The participant is eligible for the matching and profit sharing contributions upon the completion of six months of service. Participants direct the investment of their contributions into various investment options offered by the Plan.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and Plan earnings and may be charged with an allocation of Plan expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account balance.

Administrative Expenses

All reasonable expenses of administration of the Plan could be paid from the assets of the Plan. The Company could, at its discretion, pay such expenses.

Vesting

Participants were immediately 100% vested in their salary deferrals and rollover contributions plus actual earnings thereon. Vesting in the employer matching contributions and profit sharing contributions is according to the following schedule:

Payment of Benefits

Vested benefits were paid to participants upon death, disability, retirement or termination of employment by either arranging for a rollover to another plan, lump sum payment or partial lump sum. Hardship withdrawals were also available. For terminated participants' account balances that were less than \$5,000, the plan administrator could distribute the entire amount in a lump sum without the participant's consent. For terminated participants' account balances that were at least \$5,000 the participant could elect to maintain the vested portion in the Plan.

1. Description of the Plan (continued)

Forfeitures

Forfeitures were used at the Company's discretion to reduce future employer contributions or pay administrative expenses. At September 30, 2023 and December 31, 2022, the forfeited invested account balance was \$0.

Notes Receivable From Participants

Participants were permitted to borrow the lesser of \$50,000 or 50% of their vested account balance. The minimum that could be borrowed is \$1,000 and two loans could be outstanding at a time. Notes receivable from participants were secured by the balance in the participant's account and bear interest at prime plus 1 percent. Loan applicants were charged a one-time loan fee payable when the loan is originated. Loan repayments were automatically deducted through after-tax payroll deductions over a period generally not to exceed five years.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the balances of all individual accounts will be distributed as soon as administratively practicable after the Plan terminates.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are reported on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States. Benefits are recorded when paid to participants.

2. Summary of Significant Accounting Policies (continued)

Risks and Uncertainties

Financial instruments which potentially subject the Plan to concentrations of credit risk consist primarily of securities in which the Plan invests. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the near-term could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

Accounting Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect certain amounts reported in the financial statements and the accompanying notes and schedule. Accordingly, actual results could differ from these estimates.

Valuation of Investments and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Subsequent Events

The Plan has evaluated subsequent events through December 5, 2024, the date the financial statements were available to be issued.

3. Investments

All investment information disclosed in the accompanying financial statements, notes and schedule, including investments and notes receivable from participants held at September 30, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest and dividend income and interest income from notes receivable from participants for the period from January 1, 2023 to September 30, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mid Atlantic.

4. Fair Value Measurements

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2—Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liabilities;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Party-in-Interest Transactions

Plan investments were managed by Mid Atlantic. Transactions such as these qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules.

6. Income Tax Status

The underlying non-standardized prototype plan has received an opinion letter from the Internal Revenue Service (“IRS”) dated August 31, 2020, stating that the form of the plan is qualified under Section 401(a) of the IRC, and therefore, the related trust is tax exempt. The Company has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Subsequent to receiving the IRS opinion letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

7. Delinquent Participant Contributions

During the year ended December 31, 2022 the Company inadvertently failed to deposit \$9,277 of participant contributions within the required timeframe prescribed by the Department of Labor Regulation 29 CFR 2510.3-102. The delayed contributions are considered prohibited, or nonexempt, transactions. As of September 30, 2023, the Plan administrator is in the process of taking corrective action, including payment of lost interest and related taxes and penalties.
