NOTE 1 – DESCRIPTION OF PLAN

General

The following description of the A & H Employees Savings and Protection Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering substantially all employees of Amring Worldwide, Inc., formerly A&H Mfg. Co., LLC (the Company), who have attained one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On January 2, 2024, the trustee of the American Ring Company, Inc. Profit Sharing Plan (ARC Plan) approved the merger of this Plan into the ARC Plan, effective March 1, 2024. As a result, all investments were transferred from the Plan into the ARC Plan on that date.

Transfers of plan assets due to merger totaling \$5,516,364 reported in the statement of changes in net assets available for benefits for the period ended March 1, 2024 consisted of the following:

Contributions

Each year, participants may elect to contribute up to 90 percent of their eligible compensation, as defined in the plan agreement. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). The Company may make a discretionary contribution. There was no discretionary contribution for the period ended March 1, 2024. Contributions are subject to certain statutory limitations imposed by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, and an allocation of (a) the Company's contribution, if any, (b) Plan net earnings or net losses, and charged with an allocation of any administrative expenses of the Plan, if not paid by the Company. Allocations are based on participant earnings or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their contributions, including rollover contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is fully vested after six years of continuous service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in a participant's account and bear interest at the prime rate. Notes receivable balances must be repaid within five years, with the exception of loans whose proceeds are used for the purchase of a participant's principal residence, which must be repaid within fifteen years. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, participants will be entitled to 100 percent of the amounts credited to their accounts. For termination of service due to other reasons, participants will be entitled to the vested amounts credited to their accounts. Benefits are paid in the form of lump-sum payments.

The Plan allows in-service withdrawals of vested account balances, subject to ERISA regulations for those participants that are at least age 59 ½.

The Plan does not allow for hardship withdrawals.

Forfeitures

Forfeitures of terminated participants' non-vested account balances will be used to pay Plan expenses for the plan year in which such forfeitures occur with the balance, if any, used to reduce employer contributions. There were no forfeitures during the plan period ended March 1, 2024.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results may differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year less investment related expenses.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of March 1, 2024. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Fees for the investment management services and recordkeeping services are included in administrative expenses. Administration of notes receivable from participants and participant distributions are also included in administrative expenses and are charged directly to the participant's account. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events were evaluated through December 6, 2024, which is the date the financial statements were available to be issued.

Investment and Securities Transactions

The Plan's investments are stated at fair value. All Plan assets were transferred to the ARC Plan before close of business on March 1, 2024.

NOTE 3 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification Section 820, “Fair Value Measurement and Disclosures” provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 1, 2024 and December, 31 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of the units held of the collective trust. The net asset value is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – PARTY IN INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor (DOL) Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. For the period ended March 1, 2024, the Plan's transactions with parties-in-interest were as follows:

All Plan investments were in the custody of Matrix, the trustee as defined by the Plan and therefore, any transactions between the Plan and Matrix qualify as party-in-interest transactions.

Fees paid by the Plan for the investment management services and recordkeeping services amounted to \$10,641 for the period ended March 1, 2024.

Certain employees and officers of the Company who were participants in the Plan also performed administrative services to the Plan at no cost to the Plan.

Notes receivable from participants qualify as party-in-interest transactions which are exempt from prohibited transaction rules.

Investment related expenses included in net appreciation in fair value of investments are considered party-in-interest transactions.

NOTE 5 – TAX STATUS

The Plan has adopted a Volume Submitter Profit Sharing Plan with CODA (prototype plan). The Prototype Plan has received from the IRS a determination letter, dated March 31, 2008, indicating that the Prototype Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the DOL. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 1, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The Plan's annual returns filed for the year ended December 31, 2019, and all prior years, are no longer subject to income tax examination.

NOTE 6 – PLAN INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Matrix, the trustee of the Plan has certified to the completeness and accuracy of all Plan assets and related activity in the accompanying statements of net assets available for benefits as of March 1, 2024 and December 31, 2023, the statement of changes in net assets available for benefits for the period ended March 1, 2024, and the accompanying supplemental schedule of assets (held at end of period) as of March 1, 2024.

NOTE 7 – NONDISCRIMINATION AND COMPLIANCE TESTS

The plan is subject to multiple nondiscrimination and compliance tests. The nondiscrimination and compliance tests have not been completed for the period ended March 1, 2024 and the year ended December 31, 2023.
