## Report of Independent Auditors

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter**

As described in Note 1 and Note 2 to the financial statements, the termination and liquidation of the Plan was effective on November 9, 2023. As a result, the Plan changed its basis of accounting from the going concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the EQRx 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to Financial Statements

April 10, 2024

### 1. Description of the Plan

The following brief description of the EQRx 401(k) Plan (the Plan), provides only general information. Participants should refer to the Plan Agreement and Summary Plan Description for a more complete description of the Plan's provisions.

#### General

The Plan was a defined contribution plan, established January 1, 2020, and most recently amended December 1, 2022. The Plan covered all eligible employees of EQRx International, Inc., (the Company), who attained the age of 21, except employees covered by a collective bargaining agreement, leased employees, nonresident aliens who did not receive any earned income from the Company which constitutes United States source income, Interns and Student co-ops. Eligible employees began participation in the Plan immediately upon meeting eligibility requirements.

The Company announced on August 1, 2023, a definitive agreement through which Revolution Medicines, Inc. would acquire the Company in an all-stock transaction. The Plan was terminated effective as of the closing of this transaction on November 9, 2023. Effective April 10, 2024, the Plan was liquidated and the value of all participant accounts were either transferred as a rollover or a lump sum distribution to each former participant.

The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions and Funding

Eligible employees contributed from 1% to 100% of their annual compensation through November 9, 2023, subject to Internal Revenue Code limitations. Participants who attained age fifty before the end of the Plan year were eligible to make catch-up contributions. Participants also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed their contributions into various investment options offered by the Plan.

The Plan also permitted Roth elective deferrals. Roth elective deferrals are treated in the same manner as participant elective deferrals, except that Roth elective deferrals are not "pre-tax" deferrals as defined in the Code.

The Company made safe harbor matching contributions equal to 100% of the first 3% plus 50% of the next 2% contributed through November 9, 2023.

### Notes to Financial Statements (continued)

#### 1. Description of the Plan (continued)

##### Contributions and Funding (continued)

The Company may also make a discretionary profit sharing employer contribution. To be eligible for the discretionary profit sharing contribution, a participant must be employed at the end of the year. For the period January 1, 2024 through April 10, 2024 and the year ended December 31, 2023, the Company made no profit sharing contribution.

##### Participant Accounts

Each participant's account was credited with the participant's contribution, allocations of the employer's contribution, Plan earnings (losses), and administrative expenses, as applicable. The benefit to which a participant was entitled was the benefit that was provided from the participant's vested account.

##### Vesting

Participants were immediately vested in their contributions and the safe harbor contributions plus actual earnings thereon.

Vesting in the Company's profit-sharing contribution, if any, plus actual earnings thereon was based on years of continuous service. A participant was 100% vested after one year of credited service.

In the event of death, permanent disability or retirement, a participant's account became fully vested.

##### Forfeitures

If participants terminated service prior to being fully vested in the employer's contribution account, they forfeited the amount which was not vested. Forfeitures were used to offset future employer contributions to the Plan and to pay plan expenses. The balance in the forfeiture account at April 10, 2024 and December 31, 2023, was \$-0- and \$-0-, respectively. During the period January 1, 2024 through April 10, 2024 and the year ended December 31, 2023, forfeitures of \$-0- and \$6,209, respectively, were used to offset employer contributions.

### 1. Description of the Plan (continued)

#### Notes Receivable from Participants

Participants could borrow from their vested account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested balance and reduced by the highest loan balance over the previous twelve months. Participants were required to comply with loan provisions including only one loan outstanding at a time, level payments of principal and interest repaid at least quarterly over the term of the loan, and the term of the loan could not exceed five years unless for the purchase of a principal residence. The loans were secured by the balance in the participant's account and bore interest at a rate of prime plus 1%.

#### Payment of Benefits

Upon separation of employment due to termination, death, disability or retirement, a participant received the value of the vested interest in his or her account as a lump-sum amount. Prior to termination of employment, a participant could withdraw their deferred compensation balance in the event of certain hardship circumstances or upon reaching 59 1/2 years of age. The form of payment was a lump sum or other forms of distribution per the plan document.

### 2. Summary of Accounting Policies

#### Basis of Presentation

As a result of the Plan termination, the financial statements of the Plan were prepared on the liquidation basis of accounting.

#### Investment Valuation and Income Recognition

Under the liquidation basis of accounting, the Plan's investments were stated at fair value, which approximates the liquidation value of the investments. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Fund management fees charged to the Plan for the management of investments were deducted from income earned on a daily basis and were not separately reflected. Consequently, fund management fees were reflected as a reduction of investment return for such investments.

#### **2. Summary of Accounting Policies (continued)**

##### **Administrative Expenses**

The Plan's expenses were paid either by the Plan or the Company, as provided by the Plan document. Expenses that were paid directly by the Company were excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that were paid directly by the Plan were recorded as deductions in the accompanying statements of changes in net assets available for benefits.

##### **Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants was recorded when it was earned. Delinquent participant loans were reclassified as distributions based upon the terms of the plan document.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

##### **Payment of Benefits**

Benefits were recorded when paid.

#### **3. Investments**

All investment information and notes receivable from participants disclosed in the accompanying financial statements, including investments held and notes receivable from participants at April 10, 2024 and December 31, 2023, and net appreciation (depreciation) in fair value of mutual funds, interest, dividends and interest income on notes receivable from participants for the period January 1, 2024 through April 10, 2024 and the year ended December 31, 2023, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Ascensus, LLC, an affiliate and agent for Ascensus Trust Company, the trustee of the Plan.

#### 4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

The following is a description of the valuation methodologies used by the Plan. There were no changes in the valuation methodologies at April 10, 2024 and December 31, 2023.

*Mutual funds* were valued daily at the closing price per share, as reported by the fund. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

#### 4. Fair Value Measurements (continued)

The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All mutual fund investments held at December 31, 2023 were Level 1 within the fair value hierarchy.

#### 5. Parties-In-Interest

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and the management of investments held by the trustee were considered party-in-interest transactions.

#### 6. Income Tax Status

The Plan adopted the non-standardized pre-approved profit-sharing plan of Ascensus LLC. The non-standardized pre-approved profit-sharing plan sponsor received an advisory letter from the IRS dated June 30, 2020 in which the Internal Revenue Service stated that the form of the non-standardized pre-approved profit sharing plan was in compliance with the applicable requirements of the Internal Revenue Code (Code) Although the Plan has been amended since receiving the advisory letter, the plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting standards require recording uncertain income tax positions that exist in the Plan's financial statements. Plan management has determined there are no uncertain tax positions and believes there is no adjustment or disclosure required in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 7. Subsequent Events

The Company has evaluated all subsequent events through December 16, 2024, the date the financial statements were available to be issued. During this period, there have been no other material events that would require recognition in the financial statements or disclosures to the financial statements.
