Opinion

Notes to Financial Statements

Note 1. Description of the Plan

The following description of Dolese Bros. Co. Welfare Benefits Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan was established October 1, 1991, for the purpose of providing health care and other benefits for eligible employees of Dolese Bros. Co. (the Company). Plan assets were held in a voluntary employee's beneficiary association (VEBA) trust until March 2022 when the VEBA trust was dissolved. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration: The Plan is administered by the Company through a committee of the Company's employees. Administrative services are provided under an administrative services-only contract for services with CVS Caremark (CVS) and The Kempton Group Administrators, Inc. (KGA).

Benefits: The Plan provides group health benefits (medical, dental, vision and prescription drug), and life and accidental death and dismemberment insurance coverage to eligible participants, retirees and the dependents of employees or retirees of the Company. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured benefits: The Company purchases annual insurance contracts for life and accidental death and dismemberment benefits. Premiums for these policies are paid to the respective insurance companies.

Self-insured benefits: All other plan benefits are self-insured. The claims for self-insured benefits are processed by CVS or KGA. CVS and KGA pay claims directly to or on behalf of participants and is then reimbursed by the Plan. Despite the Plan's utilization of the third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefits manager (PBM), which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Stop-loss coverage: The Plan has entered into stop-loss insurance arrangements in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Experience-rated contracts: Certain insurance contracts are subject to experience-rating adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company) are determined by the insurance company in the following year and may result in a premium surplus or deficit.

Contributions: In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs based on the current group rate premium cost. The participants' contribution rate is determined annually by the Plan's oversight committee. Contributions are made by withholdings from the participants' regular payroll checks, along with periodic contributions by the Company. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company.

The Company pays the full cost of basic life insurance, basic accidental death and dismemberment insurance, and stop-loss insurance. The costs of the postretirement benefit plan are shared by the Company and retirees. Retirees pay monthly premiums set annually by the Company, and any claim expense exceeding premiums received are paid with plan assets.

Note 1. Description of the Plan (Continued)

Administrative expenses: The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These fees are reported as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan and are excluded from these financial statements.

Note 2. Summary of Accounting Policies

Basis of accounting: The Plan prepares financial statements on the basis of cash receipts and disbursements. Revenue and related assets are recognized when received rather than when earned, and expenses are recognized when paid rather than when the obligation is incurred. Accordingly, the accompanying financial statements are not intended to present the net assets and changes in net assets in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP). Because of the basis of accounting used, the Plan has not implemented certain provisions of the Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 965, Plan Accounting—Health and Welfare Plans. ASC 965 would require the Plan to disclose benefit obligations on the face of the financial statements. These obligations are disclosed in Note 4.

Valuation of investments and income recognition: Investments are reported at fair value. See Note 5 for a discussion of investments and fair value measurements. Interest income is recorded when received.

Payment of benefits: Benefits are recorded when paid. Premiums paid by the Plan are recorded as premium expenses in the accompanying statement of changes in net assets available for benefits. Medical, dental, prescription drug and short-term disability claims are paid by the Plan. Disability and death benefits are paid by insurance contracts.

Stop-loss: Premiums for stop-loss insurance are included in premium expenses. Stop-loss refunds are recorded when received and have been netted with claims paid.

Pharmacy refunds: Refunds from the Plan's PBM are recorded when received and are netted against claims paid.

Risks and uncertainties: Amounts on deposit in the Plan's bank accounts from time to time exceed the Federal Deposit Insurance Corporation's insured limit. However, the Plan has not experienced any losses on its deposits in these accounts. The Plan's management believes that the Plan is not exposed to any significant credit risk on interest-bearing cash.

Subsequent events: Management has evaluated subsequent events through December 17, 2024, the date the financial statements were available to be issued.

Note 3. Stop-Loss Coverage

The Plan obtained reinsurance coverage for the periods ended December 31, 2022 and 2021, as shown below:

Coverage period from January 1, 2022 through December 31, 2022: This coverage provides for reinsurance coverage for specific health claims in excess of \$250,000. The specific coverage is for claims incurred from January 1, 2021 through December 31, 2022, and paid from January 1, 2022 through December 31, 2022.

Note 3. Stop-Loss Coverage (Continued)

The reinsurance contracts do not relieve the Plan from its obligations to the Plan's participants.

During the year ended December 31, 2022, the Plan received reinsurance recoveries of approximately \$1,082,000. Recoveries are reflected as offsets to claim payments. The Plan paid premiums for reinsurance coverage of approximately \$1,075,000 during the year ended December 31, 2022.

Note 4. Plan Obligations

The amount reported for postretirement benefit obligations represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future by current plan participants. Postretirement benefits include future benefits expected to be paid to or for: (1) currently retired or terminated employees and their beneficiaries and dependents, and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Company and from existing plan assets.

Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability or withdrawal) between the valuation date and the expected date of payment. For measurement purposes, the significant assumptions used in the valuations were as follows:

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations.

The weighted-average health care cost trend rate assumption has a significant effect on the amounts reported as postretirement benefit obligations. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2022 and 2021, by approximately \$233,000 and \$270,000, respectively.

Note 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used at December 31, 2022 and 2021.

Interest-bearing cash: Fair value is determined as cost plus any accrued interest.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan recognizes any transfers between levels in fair value hierarchy as of the end of the reporting period. There were no transfers between levels for the year ended December 31, 2022.

Note 6. Income Tax Status

The Plan is exempt under section 501(c)(9) of the Internal Revenue Code (IRC), and accordingly, the Plan's net investment income is exempt from income taxes. The Plan obtained a favorable tax determination letter from the Internal Revenue Service. The Plan has been amended since then, but the Company believes that the Plan continues to qualify and to operate in accordance with applicable provisions of the IRC.

Management has evaluated the Plan's tax positions and concluded the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Plan Termination

The Company has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. On November 11, 2021, the Board of Directors of the Company voted to terminate the VEBA Trust no later than December 31, 2021. However, this termination occurred during March 2022. This vote did not terminate the Plan nor impact any of the future benefits available to employees.

Note 8. Transactions With Related Parties and Parties in Interest

KGA is the medical and dental claims administrator and Pan-American Life Insurance Company provided stop-loss coverage for the Plan. CVS is prescription drug Rx administrator. These parties are considered parties in interest. These parties were collectively paid \$2,031,552 for the year ended December 31, 2022.


