### 1. DESCRIPTION OF THE PLAN

The following description of Sehlke Consulting LLC (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### **General**

The Plan was a defined contribution plan, which was established by Sehlke Consulting, LLC (the Company), on January 1, 2013. The Plan covered all employees of the Company. Employees were eligible to participate in the Plan upon reaching 21 years of age and could enter the Plan on the first day of the month coinciding with or following the satisfaction of eligibility requirements. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended and restated effective January 1, 2022.

#### **Participant Contributions**

Prior to the Plan merger which was effective December 31, 2022 (Note 7), participants could elect to contribute on a tax-deferred basis up to 84% of their eligible compensation, as defined by the Plan, not to exceed the maximum allowable contribution under the Internal Revenue Code (the Code). Participants could also make Roth elective contributions. A participant's Roth elective contributions were allocated to a separate account maintained for such contributions. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions, subject to limitations imposed by the Code. Participants were permitted to make rollover contributions from another qualified plan.

#### **Company Contributions**

The Company provided a safe harbor matching contribution equal to 100% of salary deferrals not to exceed 4% of eligible compensation. All employees who were eligible to participate and make elective deferrals into the Plan were eligible to receive Company safe harbor matching contributions. Safe harbor matching contributions were calculated and remitted each pay period. There were no safe harbor matching contributions for the period from January 1, 2023 through January 31, 2023.

The Company could also make an annual discretionary nonelective contribution to the Plan. The Company did not make a discretionary nonelective contribution to the Plan for the period from January 1, 2023 through January 31, 2023.

#### **Participant Accounts**

Each participant's account was participant-directed and was credited with the participant's contributions and Company contributions in accordance with the investment options selected by the participant. Plan earnings, losses, and administrative expenses were allocated to each participant's account based upon the balance in each account. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

#### Notes Receivable from Participants

Participants could borrow up to 50% of their vested account balances, not to exceed \$50,000, without regard to the intended use of the funds. The minimum amount that could be borrowed was \$500 and participants could have a maximum of three notes outstanding at any given time, only one of which could be a primary residence note. Notes were collateralized by the participant's vested account balance. Notes bore interest at the prime rate as published in the Wall Street Journal effective as of the date of note origination plus 2%. Interest and principal repayments were made ratably through payroll deductions. Notes originated for reasons other than the purchase of a primary residence were to be repaid within five years. Notes originated for the purpose of the purchase of a primary residence were to be repaid within a period of no more than thirty years.

#### Vesting

Participants were immediately vested in their contributions as well as Company safe harbor matching contributions. Participants vested in Company discretionary nonelective contributions according to the following vesting schedule:

Participants became fully vested in all Company discretionary nonelective contributions upon the attainment of normal retirement age or in the event of death, disability or termination of the Plan.

#### Forfeitures

Forfeitures of Company contributions could be applied to pay administrative expenses or reduce future Company contributions. Forfeitures became available to the Plan as of the earlier of the last day of the Plan year in which a former employee incurred five consecutive one-year breaks in service or a distribution of the participant's entire vested account balance occurred. There were no forfeitures available to the Plan as of December 31, 2022. There were no forfeitures applied to reduce Company safe harbor contributions for the period from January 1, 2023 through January 31, 2023. No forfeitures transferred to the Aeyon LLC 401(k) Profit Sharing Plan and Trust (Note 7) during the period from January 1, 2023 through January 31, 2023.

#### Payment of Benefits

Upon termination of service, death, disability, normal retirement (age 65), or attainment of age 59 ½, a participant, or his or her beneficiary in the event of death, was entitled to a distribution of the participant's account balance. Distributions from the Plan were payable in the form of a lump sum payment or in the case of required minimum distributions, installment payments equal to the value of the participant's vested interest in his or her account. Upon termination, if a participant's account balance was less than \$5,000, the Plan could elect to automatically distribute the participant's vested account balance. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts could be withdrawn for a hardship purpose. Distributions were subject to the applicable provisions of the Plan agreement. Certain income tax penalties could apply to withdrawals or distributions prior to age 59 ½. There were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not received such distributions as of January 31, 2023 and December 31, 2022.

#### Plan Expenses

Expenses incurred in the administration of the Plan were required to be paid by the Trustee with assets of the Plan unless the Company, at its discretion, elected to pay them. The Plan paid direct expenses totaling \$13,568 during the period from January 1, 2023 through December 31, 2023. Loan and distribution fees were paid by the Plan and its participants. Investment related expenses were included in net appreciation in fair value of investments.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan provides for investments in financial instruments that are exposed to risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur in the near term and materially affect the amounts reported in the statements of net assets available for benefits.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

#### Fair Value Measurement

Accounting Standards Codification 820, *Fair Value Measurement (ASC 820)*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2     Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### Fair Value Measurement – cont'd.

The assets' or liabilities' fair value measurement level within the fair value hierarchy are based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Interests in registered investment companies:* Valued at the actively traded quoted closing price of shares held by the Plan at year-end.

*Interest in common/collective trust:* Valued using the net asset value (NAV) practical expedient of units held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2023 and December 31, 2022.

There were no Plan investments as of January 31, 2023.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes are treated as distributions based on the terms of the Plan agreement.

#### Payment of Benefits

Benefits are recorded when paid.

#### Subsequent Events

The Plan evaluated for disclosure any subsequent events through November 22, 2024, the date the financial statements were available to be issued and determined that there were no material events that warrant disclosure.

### 3. INVESTMENTS

Investment data contained in the accompanying financial statements, including assets held as of December 31, 2022, was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan.

### 4. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by Reliance Trust Company. The Plan loaned funds to its participants according to the applicable provisions of the Plan agreement. The Company provided the Plan with certain accounting and administrative services for which no fees were charged. All such transactions qualified as party-in-interest transactions which were exempt from the prohibited transaction rules.

### 5. PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. While not a Plan termination, as further described in Note 7, the Plan merged into the Aeyon LLC 401(k) Profit Sharing Plan and Trust effective December 31, 2022.

### 6. INCOME TAX STATUS

The Plan had adopted a standardized prototype plan which received a favorable opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the Plan is qualified under Section 401(a) of the Code and therefore, the related trust is exempt from taxation. Subsequent to the issuance of the opinion letter, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties, and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2023 and December 31, 2022.

The Plan was subject to routine audits by the IRS and Department of Labor; however, there are currently no audits in progress for any open tax periods.

### 7. PLAN MERGER

Effective December 31, 2022, the Plan merged with the Aeyon, LLC 401(k) Profit Sharing Plan and Trust (the Aeyon Plan). In conjunction with this merger, the Plan's investment balances totaling \$8,179,732 and participants' notes receivable balances totaling \$307,729 were transferred out of the Plan to the Aeyon Plan. Additionally, the Plan's remaining excess contributions payable, which totaled \$15,939 as of December 31, 2022, were included as part of the transfer, reducing the total balance transferred as the payable will be settled by the Aeyon Plan. All assets were transferred out of the Plan during the period from January 1, 2023 through January 31, 2023. As a result of this change, a blackout period for the Plan was in effect from January 25, 2023, through January 31, 2023, for loans, distributions, and investment allocation changes. During this time, participants were unable to access their accounts, request a loan, obtain a distribution, or diversify their investments from the Plan. Participants were, however, able to make contributions directly to the Aeyon Plan during the blackout period.
