### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Tiffin Motor Homes, Inc. 401k Profit Sharing Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 28, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended February 28, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of February 28, 2024 and 2023, and for the year ended February 28, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by the qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. As further discussed in Note 4 to the financial statements, the Plan participants merged into the Thor Industries, Inc. 401(k) Plan, effective February 28, 2024. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Tiffin Motor Homes, Inc. 401k Profit Sharing Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

### **NOTE 1 - PLAN DESCRIPTION**

The following description of Tiffin Motor Homes, Inc. (Sponsor) 401k Profit Sharing Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement or Summary Plan Description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a contributory, defined contribution 401(k) plan available to all qualifying employees of the Sponsor. The Plan originated in October 1977. To be eligible to participate in the Plan, the employee must complete three months of service and be at least eighteen years of age. An eligible employee may enter the Plan on the first day of the month coinciding with or the next month after eligibility has been met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Committee is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

#### **Contributions**

Participants may contribute a percentage of their annual compensation up to the maximum allowed by law, as defined by the Plan, with contributions and earnings thereon being nontaxable until withdrawn from the Plan. Upon reaching age fifty, participants are eligible to make catch-up contributions to the Plan. Participants may also contribute their after-tax annual compensation for Roth elective deferral purposes, subject to certain limitations, with the contributions and earnings thereon being nontaxable when withdrawn from the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Such transfers from other qualified plans are reported as rollover contributions.

The Sponsor made a discretionary, matching contribution at a rate of one hundred percent of the first three percent of participant compensation plus fifty percent of the next two percent of compensation, as defined by the Plan. The Sponsor stopped making discretionary, matching contributions on July 24, 2023. Participants direct the investment of their contributions into various options offered by the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's and the Sponsor's contributions and an allocation of net Plan earnings. The benefit to which a participant is entitled is based on the participant's vested balance. Participants may direct the investment of their account balances into various investment options offered by the Plan.

### **NOTE 1 - PLAN DESCRIPTION - Continued**

#### **Vesting**

Participants are immediately vested in their elective deferrals and safe-harbor contributions and any income or loss thereon. Participants become one hundred percent vested in discretionary Sponsor contributions after six years of service. Amounts not vested at the time a covered employee ceases to participate in the Plan are forfeited.

#### **Notes Receivable from Participants**

Participant loans are not permitted under this Plan. Effective March 1, 2022, preexisting loans from merged plans are permitted under this Plan to continue under their existing terms until repaid.

#### **Payment of Benefits**

Upon termination of service, due to death, disability, retirement or separation of service, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. The Plan also permits withdrawals from the Plan due to circumstances of financial hardship, in accordance with provisions specified in the Plan document. If a terminated participant's vested interest in his or her account is less than \$5,000 and he or she does not elect to receive a distribution from the Plan, benefits will be paid in a single, lump-sum distribution as soon as administratively feasible.

#### **Forfeitures**

The nonvested portion of a terminated employee's account balance shall be forfeited and used to reduce administrative expenses or discretionary Sponsor contributions, otherwise payable for the Plan year in which such forfeitures arise or for any succeeding Plan year. Unallocated forfeiture balances for the Plan years ended February 28, 2024 and 2023 totaled \$0 and \$6,207, respectively.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments. The Sponsor, at its discretion, pays the administrative costs of the Plan associated with any professional services provided to the Plan and the cost of communications to the participants. Administrative expenses recorded in the Plan represent third-party administrator fees, other recordkeeping fees paid directly from the Plan, and any remaining fees not paid by the Sponsor.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America. In preparing the financial statements, management evaluated subsequent events through December 16, 2024, the date the financial statements were available to be issued.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Concentration of Market Risk**

As of February 28, 2023, approximately 29% of the Plan's net assets were invested in one pooled separate account and one mutual fund. The underlying value of the investments are dependent on the performance of the individual investment holding and the market's evaluation of such performance. It is at least reasonably possible that changes in the fair value of the investments and their investment holding in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Income Recognition**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Realized gains and losses from security transactions are reported on the average cost method.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses were recorded as of February 28, 2024 and 2023. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

**Fair Value**

The established framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value is the price the Plan would expect to receive to sell an asset or pay to transfer a liability in an orderly transaction with a market participant at the measurement date. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs which are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

**Investments with Insurance Companies**

Prior to March 1, 1993, a portion of the Plan's assets were used to purchase and pay premiums for life insurance for certain participants. These insurance contracts are included at cash values as reported to the Plan by the insurance company. There are no reserves against cash values for credit risk of the contract issuer or otherwise. All life insurance premiums were surrendered during August 2023.

**Refund of Contributions**

Amounts payable to participants and the Plan Sponsor for over-contributions are recorded as a liability with a corresponding decrease in contributions. The Plan Sponsor has discussed these amounts with Thor Industries, Inc. 401(k) Plan and they are in the process of taking corrective action.

**NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian, Fidelity Management Trust Company, has certified that the following data included in the accompanying financial statements is complete and accurate.

- Investments and common collective trusts at fair value and notes receivable, included in the statements of net assets available for benefits as of February 28, 2024 and 2023.
- Investment income, interest income on loans, and net appreciation on fair value of investments included in the statement of changes in net assets available for benefits for the year ended February 28, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements.

**NOTE 4 - PLAN TERMINATION DUE TO MERGER**

Pursuant to the Plan Transfer Strategy Approval agreement effective February 28, 2024, employees who were eligible for the Tiffin Motor Homes, Inc. 401k Profit Sharing Retirement Plan became immediately eligible for the Thor Industries, Inc. 401(k) Plan. The Plan's official termination date was February 28, 2024. The assets of the Tiffin Motor Homes, Inc. 401k Profit Sharing Retirement Plan were transferred to the Thor Industries, Inc. 401(k) Plan on February 28, 2024.

**NOTE 5 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 - FAIR VALUES**

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used during the year ended February 28, 2023.

- *Mutual funds*: Valued at the closing price reported on the active market on which the individual securities are traded.
- *Pooled separate accounts*: Valued at the closing price reported on the active market on which the individual securities are traded.
- *Common collective trusts*: Valued at the NAV per share/unit reported at the close of every business day. The NAV is based on the fair value of the underlying investments held by the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 8 - INCOME TAX STATUS

The Plan is a Fidelity Management & Research Company non-standardized, pre-approved profit sharing plan. The Internal Revenue Service has ruled in a letter dated June 30, 2020 that the plan developed by Fidelity Management & Research Company, after which the Plan is modeled, qualifies under the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Tax positions are recognized in the financial statements when it is more likely than not that the position will be sustained upon examination by the tax authorities.

The Sponsor has concluded that as of February 28, 2024 and 2023, the Plan had no significant uncertain tax positions or material amounts of unrecognized tax benefits that qualify for either recognition or disclosure in the financial statements for open tax years based on an assessment of many factors including experience and interpretations of tax laws.
