Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Arizona Center for Hand Surgery, P.C. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 17, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period ended July 17, 2023, and the related notes to the financial statements.

Note 1 – Plan Description

The following description of the Arizona Center for Hand Surgery, P.C. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General:

The Plan was a defined contribution plan effective January 1, 2001. The Plan had been amended through the years to comply with tax legislation and was most recently amended effective January 1, 2022. The Plan excluded independent contractors, non-resident aliens and employees covered by a collective bargaining agreement. The Plan was subject to the Employee Retirement Income Security Act of 1974 (ERISA). The board of trustees was responsible for the oversight of the Plan and determined the appropriateness of the Plan's investment offerings and monitored investment performance.

During the period ended July 17, 2023, the board of trustees authorized the transfer of all Plan assets to the My 401(k) Plan, a multiple employer plan sponsored by Group Plan Systems, LLC. As such, on July 17, 2023, all of the assets of the Plan, which totaled \$6,117,358, were transferred to the My 401(k) Plan and the Plan was subsequently terminated.

Eligibility:

Employees of Arizona Center for Hand and Shoulder Surgery, P.C. (the Company) were eligible to participate in the deferral and discretionary safe harbor components of the Plan after completing one hour of service. Participants were eligible for the discretionary profit sharing and employer matching contributions if they met the eligibility requirements above, completed 1,000 hours of service and were employed on the last day of the Plan year.

Contributions:

The Plan included a salary deferral arrangement of up to 90% of compensation allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants were permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) contributions to the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

The Company may have, at its discretion, elected to make safe harbor non-elective contributions, matching contributions, or profit sharing contributions as determined and authorized by the Company. The Company made no such contributions for the period ended July 17, 2023.

Participants may have also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of contributions into various investment options offered by the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Each participant's account was credited with the participant's contributions, any Company contributions, and an allocation of Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Note 1 – Plan Description (Continued)

Vesting:

Participants were immediately vested in their voluntary contributions and the Company's safe harbor contributions plus actual earnings thereon. Vesting in the Company matching and profit sharing contribution portion of their accounts, plus actual earnings thereon, was based on years of credited service. A participant was 20% vested after two years of credited service with an additional 20% vesting per year until the participant was 100% vested after six years of credited service. Notwithstanding the above, a participant was fully vested upon reaching normal retirement age, death or permanent disability.

Payment of benefits:

Upon termination of service due to death, disability, or retirement, a participant may have elected to receive the value of the vested interest in his or her account in the form of a lump sum distribution. For termination due to death, the participant may have also elected to receive installments. The Plan allowed for in-service distributions if a participant reached age 62, subject to plan provisions. If a participant terminated employment and the participant's account balance did not exceed \$1,000, the Plan administrator would have authorized the benefit payment without the participant's consent. If the balance of the terminated participant's account was between \$1,000 and \$5,000, the Plan administrator may have authorized that the benefit payment be rolled into an individual retirement account in the participant's name.

Forfeited accounts:

Forfeited non-vested accounts may have been used to reduce Company contributions or pay plan expenses. Forfeited non-vested accounts as of July 17, 2023 and December 31, 2022 totaled \$0 and \$38,195, respectively. No forfeitures were used during the period ended July 17, 2023.

Note 2 – Summary of Significant Accounting Policies

A summary of the Plan's significant accounting policies follows:

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Payment of benefits:

Benefits are recorded when paid.

Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The board of trustees determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See *Note 4* for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Note 2 – Summary of Significant Accounting Policies (Continued)

Contributions receivable:

Contributions from participants and related matching contributions, if any, are recorded in the year when the contributions from participants are withheld from compensation.

Administrative expenses:

As provided in the Plan document, administrative expenses may be paid either by the Plan or by the Company. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investment presented in the accompanying statement of changes in net assets available for benefits.

Subsequent events:

The Plan administrator has evaluated subsequent events through September 26, 2024, which is the date the financial statements were available to be issued.

Note 3 – Information Certified and Provided By the Custodian

John Hancock Life Insurance Company, the custodian of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of July 17, 2023 and December 31, 2022 and the statement of changes in net assets available for benefits for the period ended July 17, 2023.

Note 4 – Fair Value Measurement

Fair value measurements are based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; or
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4 – Fair Value Measurement (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 17, 2023 and 2022 and December 31, 2022.

Cash: The carrying value is believed to be representative of its fair value based on its short term nature.

Pooled separate accounts: Valued at the net asset value (NAV) or equivalent based on units of the pooled separate accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. There are no unfunded commitments or redemption restrictions associated with these investments.

The Plan had investments in various pooled separate accounts which invested in equity, fixed income, and target date funds. The objective of investments in equity funds was to approximate the risk and return characterized by various indices; to seek long term capital appreciation; provide diversified exposure representative of various segments of the U.S. or foreign equity market; and/or to seek income. The objective of investments in fixed income funds was to provide investment results that approximate the overall performance of certain bond indices and/or to provide a predictable rate of return while preserving the safety of capital and minimizing market risk. The objective of investments in target date funds was to provide various levels of asset allocations which become more conservative over time so participants can stay with the same fund before and after selected retirement dates.

There was one pooled separate account within the Plan that invested in a stable value collective investment trust that invests primarily in corporate bonds, both U.S. and non-U.S., municipal securities and wrapper contracts in order to preserve capital and provide stability of principal while earning current income.

Note 5 – Party-In-Interest and Related Party Transactions

The Plan investments were managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company was the custodian and recordkeeper, as defined by the Plan, and, therefore, the investment transactions qualify as party-in-interest transactions. For the period ended July 17, 2023, the Plan also made direct payments to John Hancock Life Insurance Company of \$13,323. Additionally, indirect fees are paid to John Hancock Life Insurance Company based on investment account balances. These fees ranged from 0.07% to 0.80% of the investment account balance.

Matthew, Gold, Kennedy, & Snow were the third party administrator. For the period ended July 17, 2023, the Plan recognized \$1,500 in administrative expenses to Matthew, Gold, Kennedy, & Snow.

CuraFin Advisors provided investment advisory services to the Plan. For the period ended July 17, 2023, the Plan recognized \$15,400 in administrative expenses to CuraFin Advisors.

Note 6 – Plan Termination

On July 17, 2023, all assets of the Plan were transferred into the My 401(k) Plan and the Plan was subsequently terminated.

Note 7 – Tax Status

The Plan Sponsor had adopted a pre-approved plan provided by CCH Incorporated (CCH). CCH obtained an opinion letter dated June 30, 2020 from the IRS pursuant to a requirement to restate pre-approved plan documents every six years in order to maintain the Plan's tax-qualified status. Although the Plan had since been amended, the Plan administrator believed that the Plan was designed, and was being operated, in compliance with the applicable requirements of the IRC and, therefore, believed that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions. There are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market fluctuation and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could have materially affected participants' account balances and the amounts reported in the statement of net assets available for benefits.
