**December 31, 2023 and 2022**

#### **NOTE A--DESCRIPTION OF THE PLAN**

The following description of the OrthopedicsNY, LLP (the "Company") 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document and adoption agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a contributory savings and profit sharing plan which covers all employees of OrthopedicsNY, LLP, Executive Woods Ambulatory Surgery Center, LLC, Clifton Park ASC, LLC, and Everett Road ASC, LLC.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Employees are eligible to make participant contributions after attaining age 21. Employees are eligible to receive employer profit sharing contributions after one year of service with 1,000 hours worked with a participating employer and be a minimum age of 21 years old. Employees enter the profit sharing plan on the first day of January or July following satisfaction of the eligibility requirements.

##### Contributions

Participants may contribute a percentage of their pre-tax annual compensation, subject to certain limitations as defined by the Plan and the Internal Revenue Code (IRC). Participants may also make Roth contributions into the Plan. Participants who have attained the age of 50 before the close of the plan year are allowed an additional catch-up contribution (\$7,500 in 2023). Participants are allowed to defer 100% of any bonus into the Plan. Participants may also roll over distributions from other qualified defined benefit or contribution plans.

The Company's contributions are comprised of a safe harbor contribution and a discretionary profit sharing contribution. Participants annually receive 3% of compensation as a safe harbor contribution and a discretionary profit sharing contribution of 2% of compensation.

##### Participant Accounts

Each participant's account is credited with the participant's and employer's contribution and allocations of Plan earnings and expenses. Allocations are based on participant deferrals and account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are immediately vested in their salary deferral contributions, the Company's safe harbor contributions and rollover contributions, plus actual earnings thereon. Vesting in the Company's profit sharing contribution is based on years of service. Vesting for employees occurs ratably over five years (years two through six) for all eligible employees.

#### **NOTE A--DESCRIPTION OF THE PLAN--Continued**

##### Vesting--Continued

A participant is 100% vested upon: (1) disability; (2) death; (3) normal retirement at age 65; or (4) termination of the Plan. If a participant's employment with the Company is terminated before age 65 for any reason other than disability or death, the participant shall be entitled to an amount equal to the "vested percentage" of his or her account balance.

##### Forfeited Accounts

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures will be used to reduce employer contributions and for administrative expenses of the Plan. As of December 31, 2023 and 2022, the Plan had unallocated forfeitures of \$136 and \$21,865, respectively. During the year ended December 31, 2023, the Plan used \$22,024 of forfeited non-vested accounts to pay Plan administrative expenses.

##### Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions to be invested in any of the investment choices available under the Plan. Investment fund choices include registered investment companies. Participants may change the mix of investments from one fund to another on a daily basis.

All investments are participant-directed.

##### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Prior to termination, a participant may withdraw their pre-tax contributions in the event of undue financial hardship. The Plan also provides for in-service distributions for participants who have attained age 59 ½.

##### Notes receivable from Participants

Participants may borrow from their fund accounts up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Loan terms range from one year to five years or for a reasonable term exceeding five years where the loan is used for the purchase of a primary residence. The loans are collateralized by the balance in the participant's account and bear interest at a rate determined by the Plan sponsor. Interest rates range from 4.25% to 9.50% at December 31, 2023. Principal and interest is paid ratably through bi-weekly payroll deductions.

##### Plan Expenses

Administrative expenses include certain trustee fees, other investment-related expenses, legal fees and audit fees which are paid by the Plan.

#### **NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

The Plan's investments are reflected in the accompanying statement of net assets available for benefits at fair value. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note C for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments which includes realized gains or losses (computed using an average cost) and the unrealized appreciation (depreciation) on those investments.

##### Payment of Benefits

Benefits are recorded when paid.

##### Notes Receivable from Participants

Notes receivable from participants are stated at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

##### Subsequent Events

In accordance with U.S. GAAP, the Plan has evaluated for subsequent events between the statement of net assets available for benefits date of December 31, 2023 and December 20, 2024, the date the financial statements were available to be issued.

#### NOTE C--FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted market prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. All of the Plan's investments were valued using Level 1 inputs at December 31, 2023 and 2022.

##### *Level 1 Fair Value Measurements*

The fair value of investments held at registered investment companies is based on the quoted net asset values of the investments held by the Plan at year-end.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

#### **NOTE D--CERTIFIED INVESTMENT INFORMATION**

Certain information related to the investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2023 and 2022, and the net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2023, was obtained by management and agreed to or derived from the information certified as complete and accurate by Ascensus Trust Company.

#### **NOTE E--PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### **NOTE F--RELATED PARTY TRANSACTIONS**

The Plan invests in shares of registered investment companies managed by Ascensus. Ascensus Trust Company is the trustee and custodian of the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from prohibited transaction rules.

#### **NOTE G--TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the U.S. Department of Labor. The Plan is subject to routine audits by federal taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to tax examinations for years prior to 2020.

#### **NOTE H--RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
