INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Bloomfield College Defined Contribution Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bloomfield College Defined Contribution Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets in liquidation as of December 31, 2023, the statement of net assets available for benefits as of December 31, 2022 (ongoing), and the related statement of changes in net assets in liquidation for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution and an agent on behalf of qualified institutions as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by qualified institutions and certified to by a qualified institution and an agent on behalf of qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution and an agent of institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matters— Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 6 to the financial statements, the Board of Trustees of Bloomfield College approved a plan of liquidation on May 18, 2023 and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Also as described in Note 6, pursuant to the Plan's termination, the net assets of the Plan were fully distributed as of December 31, 2023. Our opinion is not modified with respect to these matters.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Bloomfield College Defined Contribution Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all full-time employees of Bloomfield College (the "College"). Employees are eligible to become participants and make deferral contributions to the Plan as soon as administratively possible after their hire date. Faculty employees become eligible to receive an employer contribution immediately while non-faculty employees become eligible for an employer contribution after completing three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees is responsible for oversight of the Plan. The Pension Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

The Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF) (collectively TIAA and CREF) is the Plan's recordkeeper and holds the Plan's investments and executes investment transactions.

Effective June 29, 2023 the Plan was terminated and all Plan assets have been liquidated as of December 31, 2023. See Note 6 Plan Termination footnote for more information.

Contributions: Each year, participants may contribute a portion of their annual compensation, as defined by the Plan, as pretax deferrals, up to an annual limit determined by Internal Revenue Service ("IRS") limitations (\$22,500 for 2023). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 in 2023. Participants who have been employed for at least 15 years may also make special 403(b) catch-up contributions not to exceed \$3,000 per annum or \$15,000 in a lifetime. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer matching contributions vary based upon whether the participant is a faculty member or a non-faculty member. For faculty employees, the College will contribute an amount equal to 10% of base salary. Faculty employees are not required to make an elective deferral to receive this contribution. Non-faculty employees must be full-time employees and complete at least 1,000 hours of service during the Plan year to receive the College's contribution. For non-faculty participants, the College will contribute 5% of base salary if a participant does not make an elective deferral or defers less than 5%, and an additional 5% if the participant contributes 5% or more. Contributions are subject to certain limitations. Effective November 1, 2018, for each staff employee with a base annual salary of \$43,000 or less and who is contributing at least 2% of their base salary, the College will contribute an additional 3% of their base salary, utilizing funds endowed to the College for this purpose under the Kellogg Grant. Normal Employer Contributions were suspended between July 1, 2021 and June 30, 2022. Effective June 29, 2023 the Plan was terminated and no further contributions were made to the Plan subsequent to that date.

Participant Accounts: Each participant's account is credited with the participant's contributions and the College's employer contributions, as well as allocations of Plan earnings. Participant accounts are charged with participant withdrawals and an allocation of administrative expenses that are paid by the Plan as well as Plan gains/(losses). Allocations are based on participant earnings, account balances, or specific

participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Participants are also immediately vested in the College's contributions.

Notes Receivable from Participants: The Plan does not allow for participant loans.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial payments, installment payments or payments in the form of an annuity contract. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, in-service withdrawals are also permitted for participants aged 59 ½ or older. Hardship distributions are permitted if certain criteria are met.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: Effective June 29, 2023 the Plan was terminated and all Plan assets have been liquidated as of December 31, 2023. As Plan management determined that the liquidation was imminent, the basis of accounting for the Plan was changed from accrual basis of accounting for an ongoing plan as of and for the year ended December 31, 2022 to the liquidation basis of accounting as of and for the year ended December 31, 2023. These methods of accounting are in accordance with accounting principles generally accepted in the United States of American ("U.S. GAAP"). There was no material impact to the Plan's net assets as a result of the application of the liquidation basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. The Plan's Pension Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the College and are excluded from these financial statements. Investment related expenses are included in net appreciation/ (depreciation) of fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for other recognition and disclosure through December 20, 2024, which is the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements, including investments held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) (collectively TIAA and CREF) including TIAA as agent for TIAA Trust, N.A. as of and for the year ended December 31, 2023 and by TIAA and CREF including TIAA as agent for TIAA, FSB as of December 31, 2022.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies and assumptions used by the Plan to estimate the fair values of investments held directly by the Plan. There have been no changes in the methodologies used at December 31, 2023 or 2022.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Variable Annuity Accounts: The fair values of the Plan's investments held in variable annuity accounts are determined by obtaining quoted prices on the NASDAQ Stock Market (Level 1 inputs).

Traditional Investment Contracts (not fully benefit-responsive): The TIAA Traditional Annuity Contracts are individual guaranteed fixed annuity investment contracts issued by TIAA ("Issuer"). Due to certain liquidity restriction provisions, all of the individual annuity contracts within the TIAA Traditional Annuity contracts held by the Plan are not fully benefit-responsive and, accordingly, are measured at fair value.

TIAA and Plan management have determined contract value to be the most reasonable estimate of fair value for these contracts. Contract value equals the contributions deposited into the contracts, plus interest credited to the contracts, less contract withdrawals, and it reflects the value at which participant transactions are executed under the contracts. The contract value reflects the theoretical transfer (exit) value available to the Plan and Plan participants. The fair values of the Plan's investment contracts that are not fully benefit-responsive have been estimated to approximate contract values based upon discounted cash flows values calculated using risk-adjusted market discount rates which correlate closely with TIAA Traditional Annuity's historical interest crediting rates. Significant unobservable inputs include the discount rates and interest crediting rates applied to the contract values.

However, the projected interest crediting rate assumptions are the same as the discount rate assumptions and, accordingly, the fair value estimate would not be impacted by the combined effect of changes in the discount rate and projected interest crediting rate assumptions. The contract values are guaranteed by TIAA and reflect the exit value available to the Plan and Plan participants. Based upon recent credit ratings for TIAA, management believes no adjustment to contract value is required related to credit quality. Since investment contracts are not transferable, there is no market from which to obtain observable market prices for the contracts held by the Plan or comparable contracts (Level 3 inputs).

The Plan Administrator is responsible for the review of the fair value estimates of plan assets. The Plan Administrator and management, or its designee, reviews the fair value pricing methodology employed by TIAA for the Plan's guaranteed investment contracts to ensure a reasonable measure of market valuation has been utilized. The valuation approach is reviewed on an ongoing basis to ensure market values reported represent a reasonable exit price.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan had no financial assets at December 31, 2023. Financial assets carried at fair value at December 31 2022, are classified in the table below in one of the three categories described above:

NOTE 5 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under the Department of Labor's regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the College. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the College. Any direct or indirect expenses paid for by the Plan qualify as party-in-interest transactions. The Plan held investments issued by TIAA, CREF and TIAA and CREF. TIAA and CREF are service providers to the Plan, and therefore, these transactions qualify as party-in-interest transactions.

NOTE 6 - PLAN TERMINATION

The College has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

On November 15, 2022, the College entered into an agreement and plan of merger with Montclair State University, a New Jersey public research university. On May 18, 2023, the Board of Trustees at the College determined that the College shall terminate the Plan effective as of June 29, 2023, ceasing any and all further contributions into the Plan, as authorized by and in accordance with the relevant termination provisions of the Plan document. The merger was completed on June 30, 2023. As a result of the merger, the Plan was terminated as of June 29, 2023.

As of December 31, 2023, all plan assets have been distributed to plan participants based on their preferred distribution option (lump sum, rollover or individually-owned annuity accounts). Approximately \$11.6M of plan assets were distributed to plan participants through lump sum and rollover method. The remaining \$48.4M of plan assets were deemed distributed as individual-owned annuity accounts.

NOTE 7 - TAX STATUS

The Internal Revenue Service issued an opinion letter dated August 7, 2017 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2020.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks, as well as risks associated with global events such as pandemic. Due to the level of risk associated with certain investments, and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements.
