Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the ONE SCHOOL TEAM US 401(K) PLAN ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management's Responsibility for the Financial Statements

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. NOTES TO FINANCIAL STATEMENTS

NOTE 1—PLAN DESCRIPTION

Effective January 1, 2018, Burn Brae Education, Inc. (the “Company”) established the One School Team US 401(k) Plan (the “Plan”). The following description provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan’s provisions.

1. General – The Plan is a defined contribution plan covering all employees of the Company who are 21 or older and have completed three months of service. An employee must be scheduled to work over 1,000 hours during a Plan year to be eligible.

The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA).

2. Contributions – Effective April 1, 2018, participants may contribute up to 100% of annual compensation, designated as voluntary pre-tax contributions or after tax (Roth) contributions, not to exceed \$22,500 and \$20,500 for 2023 and 2022. Participants who are at least age 50 may make additional “catch-up” contributions of \$7,500 for 2023 and \$6,500 for 2022. The Plan includes an automatic enrollment feature. Unless employees elect not to participate, or elect a different deferral rate, new participants are automatically enrolled with an initial deferral rate of 3% of their compensation.

The Company is required to contribute, as a matching contribution, 100% of elective deferrals up to 3% of compensation. The match is paid into the Plan every payroll.

The Company may, in its sole discretion, make a profit-sharing contribution to all eligible participants. The participant must be employed by the Company on the last day of the Plan year. The Company did not elect to make a profit-sharing contribution for 2023 or 2022.

3. Participant Accounts – Each participant’s account is credited or charged with the participant’s contribution and an allocation of the Company’s contribution, Plan earnings or losses, forfeitures, and Plan expenses. Allocations are based upon plan earnings or losses and account balances, as defined. The benefit to which a participant is entitled is the vested portion of the participant’s account.
4. Vesting – Participants are 100% vested in their voluntary contributions plus actual earnings or losses thereon. Participants’ vesting in the Company’s matching contributions and profit-sharing contributions is determined in accordance with a schedule based on the participant’s years of service.
5. Forfeited Accounts – If, at the time of termination of employment, a participant is not 100% vested in the Company’s matching contributions or profit-sharing contributions, the participant’s account will be deemed as forfeited upon the earlier of the payment of the vested portion or the fifth consecutive one-year break in service. Forfeitures of non-vested matching contributions can be used to pay Plan expenses or reduce employer contributions. Forfeitures available for future use were \$-0- as of December 31, 2023 and \$7,641 as of December 31, 2022.
6. Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect one of several methods to distribute the value of a participant’s vested account, as defined by the Plan.

NOTES TO FINANCIAL STATEMENTS

NOTE 1—PLAN DESCRIPTION (Continued)

7. Administrative Expenses – Administrative expenses of the Plan are paid out of plan assets and by the Company.
8. On June 27, 2023, \$3,543,802 of Plan Assets were transferred to a Pooled Employer Plan (PEP). As a result, \$79 of Plan assets remain as of December 31, 2023.

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The accompanying financial statements have been prepared using the accrual basis of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from Plan assets during the reporting period. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments at December 31, 2023 and 2022 are held by Matrix Trust Company. All investments are reported at market value as of December 31, 2023 and 2022.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Realized gains and losses on the sale of securities are computed on a specific identification basis.

Dividend and interest income are recognized when earned. Net appreciation (depreciation) on investments held represents the change in market value of the investments from the beginning of the Plan year (or date the investments were purchased, if later) to the end of the Plan year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

RECLASSIFICATIONS

Certain prior year amounts have been reclassified to conform with the current year presentation.

NOTES TO FINANCIAL STATEMENTS

NOTE 3—FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

Level 2 and Level 3 Fair Value Measurements

Level 2 and Level 3 fair value measurements are not applicable to the Plan for 2023 and 2022.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4—INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and schedule is complete and accurate.

- a. Investments, as shown in the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022.
- b. Investment income, as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2023 and 2022.
- c. The schedule of assets (held at end of year) as of December 31, 2023, as shown on Schedule H - Line 4(i).

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5—NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loan is secured by the balance in the participant’s account and the interest rate for each loan is at the discretion of the Plan Administrator. Repayments of principal and interest are made in bi-monthly installments over the specified note period through payroll deductions. Loans must be repaid within five years, or 30 years if used for the purchase of a primary residence.

NOTES TO FINANCIAL STATEMENTS

NOTE 6—TAX STATUS

The Plan is a Non-Standardized Pre-Approved 401(k) Plan (“Pre-Approved Plan”) sponsored by Matrix Trust Company which was adopted by the Company on October 1, 1995. The Pre-Approved Plan obtained an opinion letter on June 30, 2020 in which the Internal Revenue Service (“IRS”) stated that the Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”).

The Company has not applied for its own determination letter from the IRS. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement dates.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Company provides to the Plan certain accounting and administrative services for which no fees are charged. In addition, the majority of the expenses of the Plan are paid by the Company.

Plan investments are managed by the trustee of the Plan. Since November, 2020, the third party administrator is Human Interest Inc. and the record keeper is Matrix Trust company. Both Human Interest Inc. and Matrix Trust Company are considered parties-in-interest.

Investment transaction fees paid were \$5,676 in 2023 and \$14,761 in 2022.

NOTE 8—PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 9—PROHIBITED TRANSACTIONS

For the year ended December 31, 2023, the Company failed to transmit participant contributions to the Plan within the timeframe required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA totaling \$27,046. The Company remitted \$26,241 to the Plan during 2023. The Company is in the process of contributing the remaining \$805 balance and calculating lost earnings to be applied to the accounts of affected plan participants.
