## INDEPENDENT AUDITORS' REPORT

To the Board of Directors  
Oleco, Inc. 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Oleco, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 (as restated) and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Oleco, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2022 (as restated) and 2021, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Oleco, Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Correction and Reissuance**

The 2022 financial statements were previously issued with a report dated October 11, 2023. Subsequently, as further described in Note J, plan management determined the transfer of plan net assets to GlobalTec 401(k) and Profit Sharing Plan in the amount of \$5,763,816 occurred in 2022 instead of 2023. Accordingly, the plan has restated its previously issued financial statements for 2022 to reflect the correction of the period of recognition of the transfer of plan net assets to be 2022.

### **Emphasis of Matter - Plan Merger and Termination**

As further discussed in Note G, the plan was merged into the GlobalTec 401(k) and Profit Sharing Plan and terminated effective December 31, 2022. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise doubt about the Oleco, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibility for the Audit**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Oleco, Inc. 401(k) Profit Sharing Plan's internal control. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Note A - Plan Description

The following description of the Oleco, Inc. 401(k) Profit Sharing Plan (the “plan”) provides only general information. Participants should refer to the plan document and amendments for a more complete description of the plan’s provisions.

#### General

The plan is a defined contribution plan covering substantially all non-excluded employees of Oleco, Inc. (the “company”). Employees are immediately eligible to make elective deferrals. Employees age 21 and older are eligible for the company match and profit-sharing contributions after twelve months of eligible service. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). As described in Note G, effective December 31, 2022, the plan merged into the GlobalTec 401(k) and Profit Sharing Plan and the plan was terminated.

#### Contributions

Each year, participants may contribute up to 90% of pretax eligible compensation, as defined in the plan, up to the maximum amount permitted by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the plan. The company may make a discretionary match or profit-sharing contribution to the plan. The company contribution is invested as directed by the participant. The company elected to match 100% of an employee’s deferral up to \$500 for the years ended December 31, 2022 and 2021. Discretionary profit-sharing contributions declared by the company totaled \$329,892 and \$330,000 for the years ended December 31, 2022 and 2021.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution and company matching contributions, as well as allocations of the company’s profit sharing contribution, when made, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the company’s discretionary matching and profit-sharing contribution portions of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service, with graduated vesting beginning at 20% after two years. As described in Note G, participants became 100% vested upon the merger and termination of the plan effective December 31, 2022.

#### Notes Receivable from Participants

Loans are not permitted.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. The plan permits in-service and hardship withdrawals under certain conditions.

#### Forfeited Accounts

Forfeited, non-vested accounts totaled \$0 and \$14,734 at December 31, 2022 and 2021. These amounts will be used to offset plan administrative expenses or future employer contributions. Forfeitures used to offset employer contributions were \$0 and \$44,168 for the years ended December 31, 2022 and 2021.

### Note B - Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statement follows:

#### Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

#### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's investment committee determines the plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the plan are paid by the plan, unless otherwise paid by the company. Expenses that are paid by the company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### Subsequent Events

Plan management has evaluated subsequent events through November 21, 2024, the date the financial statements were available to be issued. No such events or transactions were identified.

### Note C - Certified Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2022 and 2021, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years ended December 31, 2022 and 2021, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the plan.

### Note D - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 – Inputs to the valuate methodology include
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### Note D - Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

**Stable Value Collective Trust Fund:** Valued at the NAV of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no assets at fair value as of December 31, 2022. The following tables sets forth by level, within the fair value hierarchy, the plan's assets at fair value as of December 31, 2021. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

### Note F - Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the plan, any party rendering service to the plan, the employer and certain others. Certain investment options held by the plan are units of mutual funds and common/collective trusts managed by Reliance, the trustee, as defined by the plan, and therefore, these transactions qualify as party-in-interest transactions.

### Note G - Plan Merger and Termination

Effective December 31, 2022, the Oleco, Inc. 401(k) Profit Sharing Plan merged into the GlobalTec 401(k) and Profit Sharing Plan and the plan was terminated. In December 2022, the net assets of the plan were transferred. Participants became 100% vested in their accounts at the time of merger and became participants of GlobalTec 401(k) and Profit Sharing Plan effective January 1, 2023.

### Note H - Tax Status of Plan

Effective November 1, 2020, the plan has adopted an Automatic Data Processing prototype non-standardized profit-sharing plan with CODA, which received a favorable opinion letter dated July 16, 2014 from the Internal Revenue Service (IRS) that the prototype plan as designed qualifies for federal income tax-exempt status. The plan has not applied for its own determination letter. The prototype plan has been amended since this date; however, the plan administrator believes that the plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, no provision for income taxes has been included in the plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that, as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note I - Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### Note J – Restatement of Previously Issued Financial Statements

Subsequent to the previous issuance of the 2022 financial statements, plan management determined the transfer of plan net assets to GlobalTec 401(k) and Profit Sharing Plan in the amount of \$5,763,816 occurred in 2022 instead of 2023. Accordingly, the plan has restated its previously issued financial statements for 2022 to reflect the correction of the period of recognition of the transfer of plan net assets to be 2022 and disclose this transfer and termination of the plan.
