Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Arkansas Glass Container Corporation Retirement Income Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As described in Note 3 to the financial statements, the governing body of Arkansas Glass Container Corporation Retirement Income Plan approved a plan of liquidation effective October 31, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 and 2024 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Arkansas Glass Container Corporation Retirement Income Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Note 1: Description of the Plan

The following brief description of the Arkansas Glass Container Corporation Retirement Income Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan’s provisions.

General

The Plan is a non-contributory defined benefit plan providing retirement, disability, and death benefits to all employees of Arkansas Glass Container Corporation (the “Employer”) hired before the applicable frozen dates noted below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective June 30, 2006, the Plan was frozen with respect to new participants and the accumulation of additional benefits for existing participants not covered by a collective bargaining agreement that provided for participation in the Plan. Effective September 30, 2006, the Plan was frozen with respect to new participants and the accumulation of additional benefits for existing participants who were members of Local 131. Effective April 1, 2016, the Plan was frozen with respect to new participants who were members of Local 74. Effective January 31, 2018, the Plan was frozen with respect to the accumulation of additional benefits for participants who were members of Local 74.

Administration

Principal Life Insurance Company is the custodian of the Plan. All contributions to the Plan are paid to the custodian in accordance with terms of the Plan. The Plan is administered by Principal Financial Group.

Benefits

Benefits under the Plan are based on participants’ compensation and years of service prior to their applicable frozen date. Normal retirement age for Plan benefits is 65. Participants may elect to receive benefits upon early retirement at age 55, provided that they have at least twenty years of service with the Employer. The normal form in which benefits are paid are as an annuity over the participant’s lifetime, as a qualified joint and survivor annuity benefit or in the form of a lump sum benefit payment not to exceed \$5,000. Other payment options are available, as described in the Plan Document.

As of June 30, 2006, accruals under the Plan ceased for participants not covered by a collective bargaining agreement that provided for participation in the Plan. As of September 30, 2006, accruals under the Plan ceased for participants who were members of Local 131. As of January 31, 2018, accruals under the Plan ceased for participants who were members of Local 74. A participant’s accrued benefit will not increase or decrease due to changes in the participant’s compensation or years of service after the dates the Plan was frozen.

Death and Disability Benefits

If an active employee dies, a death benefit is paid to the spouse if the employee dies before retirement benefits start, married and fully vested in the Plan. The death benefit equals the survivor's benefit under a 50% survivor form and is payable to the spouse as of the employee's normal retirement age. Active employees who become totally disabled receive annual disability benefits that are equal to the equivalent normal retirement benefit they have accumulated as of the time they become disabled. Disability benefits are paid until the earliest of the date the employee is no longer disabled, the date of death, or the date of normal retirement age, at which time disabled participants will receive the normal retirement benefit computed as though they had been employed to normal retirement age, with their annual compensation remaining the same at the time they became disabled.

Funding Policy

The Plan's funding policy is for the Employer to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. During the period ending March 11, 2024, the Employer made contributions of \$359,927. The Employer's contributions for 2024 and 2023 met the minimum funding requirements of ERISA.

The Employer has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions set forth in ERISA. For the Plan year ended June 30, 2023, no Employer contributions were made due to the Plan's termination effective October 31, 2022 (see Note 3).

Priorities Upon Termination of the Plan

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated.

- a. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
- b. Other vested benefits insured by the Pension Benefit Guaranty Corporation ("PBGC") (a U.S. government agency) up to the applicable limitations discussed below.
- c. All other vested benefits (that is, vested benefits not insured by the PBGC).
- d. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees. For plan terminations occurring during 2024, that ceiling was \$7,432 per month or \$89,182 annually. That ceiling applies to those pensioners who elect to receive their benefits in the form of a single life annuity and are 65 years old at the time of retirement or plan termination (whichever comes later). For younger or older annuitants or for those who elect to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceilings are actuarially adjusted. Benefit improvements attributable to a plan amendment may not be fully guaranteed even though total benefit entitlements fall below the aforementioned ceilings.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Plan sponsor and the level of benefits guaranteed by the PBGC.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

As discussed in Note 3, the Board of Directors voted to terminate the Plan effective October 31, 2022. As a result, the accompanying 2024 and 2023 financial statements are prepared on the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes there in. The Plan's most significant estimates are the present value of accumulated plan benefits which is based on actuarial assumptions and the valuation of investments. Actual results could differ from those estimates.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those estimated future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the services employees have rendered. Accumulated plan benefits include benefits expected to be paid to:

- a. Retired or terminated employees or their beneficiaries
- b. Beneficiaries of employees who have died, and
- c. Present employees or their beneficiaries

Benefits under the Plan are based on a percentage of eligible compensation for each applicable year of service. Benefits payable under all circumstances, including retirement, death, disability and termination of employment, are included to the extent they are deemed attributable to employee service rendered through the date the Plan was frozen.

Actuaries from Principal Financial Group determine the actuarial present value of accumulated plan benefits, which is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The more significant methods and assumptions used by the actuaries in their valuations as of October 30, 2022 are as follows:

Retirement: At normal retirement age (65)

Inflation: 2.40%

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Effective October 31, 2022, the Plan was terminated (see Note 3) and the most recent computations of the actuarial present value of accumulated plan benefits were made as of October 30, 2022. Had the valuations been performed as of July 1, 2024, there would have been material differences due to the approved termination of the Plan.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Investment Valuation and Income Recognition

Investments are reported at liquidation value which equals fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Retirement Committee determines the Plan’s valuation policies utilizing information provided by its investment advisors, custodians, and actuaries. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis when earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the plan’s gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Employer, as provided by the plan document. Expenses that are paid directly by the Employer are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefit.

Subsequent Events

The Plan has evaluated all subsequent events for potential recognition and disclosure through December 18, 2024, the date these financial statements were available to be issued.

Note 3: Plan Termination

On July 27, 2022, the Board of Directors of the Plan Sponsor approved to terminate the Plan effective October 31, 2022. As a result of the Plan termination, participants become 100% vested in their accounts and final distributions will be made to the participants or the participant's beneficiary as soon as feasibly possible after the date of termination. The employer submitted to Principal Life Insurance Company a standard termination letter which was acknowledged as received by Principal Life Insurance Company on October 31, 2022.

The Plan received a favorable determination letter on Plan termination from the Internal Revenue Service as of November 21, 2023. As described in Note 2, in accordance with generally accepted accounting principles, the Plan has changed its basis of accounting to value Plan assets from the going concern basis into the liquidation basis in 2023 and 2024.

Effective March 11, 2024, the liquidation of Plan assets was completed and final distributions were made to Plan participants.

Note 4: Income Tax Status

The Plan obtained its latest determination letter on March 30, 2018, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since requesting the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2020.

Note 5: Fair Value

Accounting standards define fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. They also establish a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. Following are the three levels of inputs that may be used to measure fair value:

Level 1: Quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Unobservable inputs for the assets or liabilities.

Following are the valuation methodologies the Plan uses to measure financial instruments at fair value:

Pooled Separate Accounts (PSAs) - Valued based on the underlying investments (i.e., common stock, mutual funds, short term securities), adjusted for expenses. While the majority of the underlying assets values are based on quoted prices, the net asset value (NAV) of the pooled separate accounts is not publicly quoted. The NAV is reported by the fund managers as of the financial statement date based on recent transaction prices. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The NAV is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During 2024 and 2023, the Plan's investments (including realized gains and losses on investments bought, sold, and held during the period and year) depreciated in value by \$117,826 and \$224,604, respectively.

Note 6: Parties in Interest

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan had total investments of \$0 and \$6,225,830 invested in Principal Life Insurance Company's Investments as of March 11, 2024 and June 30, 2023. As a result of Principal Life Insurance Company serving as custodian, third party administrator and actuary for the Plan, Principal Life Insurance Company is by definition a party-in-interest and, as a result, all transactions pertaining to these investments were with a party-in-interest. The Plan paid \$59,646 and \$27,930 to Principal Life Insurance Company for their services to the Plan for the period ended March 11, 2024 and year ended June 30, 2023, respectively. Other administrative expenses paid by the Plan include premiums of \$0 and \$31,064 paid to the PBGC and investment advisory fees of \$2,186 and \$6,044 paid to Principal Financial Advisors, Inc. for the period ended March 11, 2024 and year ended June 30, 2023, respectively.

The above transactions are exempt from being prohibited transactions under ERISA.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and the changes in net assets available for benefits as of and for the period ending March 11, 2024 (in Liquidation) and year ending June 30, 2023 (in Liquidation).

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible the changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 8: Information Prepared and Certified by the Custodian

All of the Plan's assets were held by Principal Life Insurance Company, the Custodian. The amounts set forth in the accompanying financial statements for investments and investment income and the information shown in the supplemental schedules were summarized from information furnished by the custodian. A certification has been received from the custodian which certifies that information furnished by the custodian is complete and accurate for the period ending March 11, 2024 (in Liquidation) and year ending June 30, 2023 (in Liquidation), respectively. As permitted by 2 CFR 252.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the certified information was not subjected to any procedures except for comparing the information with the related information included in the financial statements and supplemental schedules.
