On 9/10/24 the IRS announced tax relief for businesses located in Suffolk County, New York that were impacted by severe storms and flooding that began on 8/18/24. This followed a disaster declaration by the Federal Emergency Management Agency (FEMA).

The administrative tax filing relief extends the 5500 filing deadline from October 15, 2024 to February 3, 2025 for those Plan Sponsors that have a valid filing extension to October 15, 2024.

The stated relief extends to both Taxpayers and Practitioners located in the disaster area (Treas. Reg. 301-7508A-1(d) (2) as well as Taxpayers not located in the disaster area but whose records necessary to meet the 5500 filing deadline are maintained in the covered disaster area (Treas. Reg. 301.7508A-1(c)).

Pointer Pension Service, Inc. is a practitioner business that is located in Suffolk County, N.Y., a covered disaster area. This firm is a Third Party Administrator that prepares the IRS Form 5500 filing for the above captioned Plan Sponsor who is outside the immediate disaster area but whose records necessary to prepare the 5500 filings are maintained by this firm in Suffolk County.

Please note: this Plan Sponsor had a valid 5500 filing extension to 10/15/24 and was identified as part of a Bulk Practitioner Disaster Relief Request submitted to the IRS.
