### 1. Plan Description

---

The following brief description of the Kugler Company 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Kugler Oil Company (the Company).

Employees are eligible to make pre-tax and designated after-tax Roth salary deferral contributions after attaining age 18. Eligible employees may become participants on the first day of the pay period following the date on which entry requirements are fulfilled. Employees are eligible to receive discretionary matching and profit sharing contributions after attaining age 18 and completing one year of service with at least 1,000 hours. Once eligible, participants must be employed on the last day of the Plan year and complete 1,000 hours of service in order to receive discretionary matching and profit sharing contributions each Plan year.

#### ***Contributions***

Participants may contribute up to 90% of annual eligible compensation, subject to the maximum dollar limits allowable by law. All participants who meet the eligibility requirements are automatically enrolled with an initial 5% (6% effective November 1, 2024) pre-tax salary deferral contribution. The Plan includes an automatic escalation feature which provides an annual increase of 1% in salary deferral election percentages up to 10% for all participants that are automatically enrolled. Participants may elect not to contribute or make modifications to their deferral election. Participants may also contribute amounts representing distributions from other qualified plans. The Company may make discretionary matching contributions and discretionary profit sharing contributions. All participants who are eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of a) the Company's discretionary matching contributions, b) the Company's discretionary profit sharing contributions, and c) Plan earnings or losses. The Company's discretionary matching contributions are allocated among participants based upon each eligible participant's elected salary deferral. The Company's discretionary profit sharing contributions are allocated among participants based upon each participant's eligible compensation. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Fidelity Management Trust Company (Fidelity).

### *Vesting*

Participants are vested immediately in their contributions plus earnings thereon. Company discretionary matching and profit sharing contributions credited to participant's accounts are vested based on years of continuous service. Participants are 20% vested after two years of credited service and vesting increases 20% per year until a participant is 100% vested after six years of credited service.

### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest payments must be made through payroll deductions for active participants.

### *Payment of Benefits*

Upon termination, retirement, disability, or death the participant or beneficiary may elect to receive either a partial, lump sum, or installment payments equal to the value of the vested funds allocated to the participant's account. The Plan requires that distribution payments between \$1,000 and \$5,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Benefits are recorded when paid.

### *Forfeitures*

Upon a participant's termination of employment before normal retirement or death, the portion of their Company's contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to reduce the Company's contributions or plan expenses. As of September 30, 2024 and 2023, there was \$101,483 and \$74,564 of forfeited non-vested amounts remaining, respectively. During the years ended September 30, 2024 and 2023, the Company utilized no amounts to reduce Company contributions.

## 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### *Basis of Presentation*

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting-Defined Contribution Pension Plans*.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisory and custodian. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

### ***Other***

Certain fees are paid by the Plan and are included in administrative expenses. Other certain expenses specifically incurred by or attributable to individual participants are paid from the applicable participant accounts. Investment related expenses are included in net appreciation in fair value of investments. Audit fees are paid by the Company and are excluded from these financial statements.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Subsequent Events*

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through December 19, 2024. See "Contributions" section of Note 1 for a description of a subsequent event.

### 3. Information Certified by Fidelity

### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of September 30, 2024 and 2023.

*Mutual Funds and Money Market Fund:* Valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts and Stable Value Fund:* Common collective trusts and the stable value fund are valued at the NAV based on the market value of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per share (or its equivalent) to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is in the Plan's assessment that these investments meets those requirements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Tax Status

---

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operating in compliance with applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### 6. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed as soon as practicable after the termination date.

#### 7. Related-Party Transactions

---

Certain Plan investments are mutual funds and a money market fund managed by Fidelity. Fidelity is the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions.
